


Summary of Responses to Consultation about Re-modelling of Children's Centre Services which took place between 1 November 2016 and 31 January 2017.







Breakdown of where the responses came from in relation to the existing children's centres.

We received 616 responses to the consultation. 580 of these responders told us the first part of their postcode and 35 did not. Column C below details these however this does not enable us to say specifically which would be the responder's home centre as centre boundaries cross postcode areas. Column B gives some idea of which of the children's centre areas the responders live in. Column D


details the numbers of responses that gave us the first part of their postcode and said that they used children's centre services.


During the period of the consultation 5800 families accessed services, given that 483 families who responded said that they use children's centre area services this is an estimated 8% response rate.

Question 4: Have you used the Children's Centre services for any of the reasons listed below:




Comments for Q4 aligned the reasons for accessing services to the themes identified in response to Q3 and in particular breast feeding support and meeting other parents.



Reason and importance - Meeting other parents/children and develop support networks






Reason and importance - Accessing support and advice during my pregnancy including having a baby/parenting classes




Reason and importance - Supporting my knowledge and understanding of my child's development



Reason and importance - Accessing a structured parenting course




Reason and importance - Access general information and advice including leaflets and signposting to other services e.g. Debt Advice






In respect of Q6, individual comments were mainly concerned with any changed venues being too far away or not accessible via public transport. These concerns will be mitigated through outreach.



It is clear from the responses to Q7 and the additional comments that many families already access services at outreach within their local area, probably without realising.



There were 234 responses to this part of the question.

From the general comments in response to Q11 it is clear that there has been a misconception around the meaning of 0-19 services with parents of under 5s worried that adults and older children will be in the same groups as young children.

Comments indicate that families would like more of what we do.

Locally available services are very popular.

Consultation with partners indicate that we need to have further discussions about 19-25 services for young adults with disabilities to clarify what might be offered.

The main themes from above follow through, in summary these were:

- Child development
- Health
- Networking/Social/Family time/Groups in particular SEN Groups, Dads groups, Multiples Groups (twins, triplets etc.)
- Information, Advice & Guidance (local and using a variety of channels)
- Adult support: training/advice/job clubs etc.
- Out of hours and timings of services

Summary of impact

The proposed reorganisation into family centres will improve the health and well being of children and young people across the City. The main focus will be to meet the needs of the most vulnerable families and support local communities by distributing resources where they are most needed. Evidence of need and this approach will also help to maximise resource allocation and utilisation at a time of diminishing resources. Stakeholders support the need to target resources to those families most in need. Access to services will be improved through the reorganisation of children's centres into family centres so that families in poverty are able to locally access services. Improved integration of services and further development of a whole family approach and whole family plan will help to reduce inequalities in child development and improve parents' aspirations, self esteem and parenting skills thus improving life chances.

A total of 616 questionnaires were received and recorded on Citizen Space. Approximately 21% did not use a Children's Centre but within the remaining 78% all centres were represented. Responses identified accessing adult learning, training and employment support as well as support regarding home and money including impartial debt advice as being the least important.

A total of 616 questionnaires were received and recorded on Citizen Space. Approximately 21% did not use a Children's Centre but within the remaining 78% all centres were represented. There was a wide range of services that respondants said they utilise including midwifery, health visiting, toddler groups, training opportunities and advice services. Of those that supplied information, the majority (53%) were in the age bracket of 25 – 34 years.

Respondents were asked what was important to them in accessing services. The following areas were felt to be the most important:

- To support their own and their child's health and wellbeing
- To meet other parents/children and develop support networks
- · To support knowledge and understanding of child development
- To access support and advice during pregnancy including having a baby and parenting classes

When asked their views on extending services to pre-birth to 19 (25 years if child has a disability), providing support for the whole family 74% agreed or strongly agreed with this proposal Only 13% either disagreed or strongly disagreed.

The additional comments highlighted that existing services should not be diluted in order to offer services to the older age group and asked that these changes ensure that the importance of early years is still recognised as part of this wider work.

90% of respondants were female and t here was a wide range of services that respondents said they utilise including midwif e ry, health visiting, toddler groups, training opportunities and advice services.

Respondents were asked what was important to them in accessing services. The following areas were felt to be the most important:

- To support their own and their child's health and wellbeing
- To meet other parents/children and develop support networks
- To support knowledge and understanding of child development
- To access support and advice during pregnancy including having a baby and parenting classes

The comments received indicated that the distance they would need to travel would be the influencing factor and services local and close to home were important often because of the difficulty of using public transport. However easy access by public transport was considered by some and many that commented said they would be willing to consider travel and that they often already do. The additional comments highlighted that existing services should not be diluted in order to offer services to the older age group and asked that these changes ensure that the importance of early years is still recognised as part of this wider work.

Summary of Impact

Overall summary of possible impact

To redesign children's centres by developing a new delivery model based on family centres for 0 -19 year olds, (25 years old if the young person has a disability).

The family centres will be located in the 20% most deprived areas of the City within 7 locality areas and services will be available across Sheffield from link and outreach sites including community venues and in the home.

There were 616 responses to the Statutory Consultation which were recorded on Citizen Space. 78% of the respondants used Children's Centres and all centres were represented in the responses.

There was a wide range of services that respondents said they utilise including midwifery, health visiting, toddler groups, training opportunities and advice services. Respondents identified the following areas as the most important:

- To support their own and their child's health and wellbeing
- To meet other parents/children and develop support networks
- To support knowledge and understanding of child development
- To access support and advice during pregnancy including having a baby and parenting classes

74% of responses supported extending services to pre-birth to 19 (25 years if child has a disability) and comments highlighted that that the importance of early years is still recognised as part of the wider age range and work.

The new familiy centres will have a positive impact on tackling poverty; health; age (young people 0-19 or 0-25 where a young person is disabled); disability; pregnancy and maternity; different racial groups; both gender's though it is recognised that the majority of staff and service users are female; the Voluntary, Commuiniy and Faith sector and partner organsiations.
