ADVICE TO MEMBERS ON DECLARING INTERESTS AT MEETINGS

The existing Standards regime will be abolished from 1st July, 2012 by the Localism Act 2011. From this date, the way that your interests need to be registered and declared will change. Prejudicial and personal interests will no longer exist and they have been replaced by Disclosable Pecuniary Interests (DPIs).

The Act also requires that provision is made for interests which are not Disclosable Pecuniary Interests and requires the Council to introduce a new local Code of Conduct for Members. It is intended that provision will be made in the new Code for dealing with "personal" interests.

The Regulations in relation to Disclosable Pecuniary Interests have only recently been published by the Government and guidance is being developed for circulation to you prior to 1st July.

If at all possible, you should try to identify any potential interest you may have before the meeting so that you and the person you ask for advice can fully consider all the circumstances before reaching a conclusion on what action you should take. 

LICENSING ACT 2003

Review of Premises Licence - Mosborough Off Licence, 56 High Street, Sheffield, S20 5AE.

1.0 PURPOSE OF REPORT

1.1 To consider an application for the review of a premises licence made under Section 51 of the Licensing Act 2003 in relation to the premises known as Mosborough Off Licence, 56 High Street, Sheffield, S20 5AE. A copy of the current premises licence is attached at Appendix 'A'.

2.0 THE APPLICATION

- 2.1 The applicant is South Yorkshire Police.
- 2.2 The application, which was received on 24th July 2012, is attached to this report labelled Appendix 'B'.
- 2.3 The grounds for the review are based on the following aspects of the 2003 Licensing Act objectives:-

Prevention of Crime and Disorder Prevention of Public Nuisance Protection of Children from Harm

2.4 The application form details further the grounds for review.

3.0 REASONS FOR REFERRAL

- 3.1 The Licensing Authority must under the Act refer any application for review to the Licensing Committee, unless it is withdrawn, or if representations are made by an interested party that the Licensing Authority are of the opinion that they are frivolous or vexatious.
- 3.2 The Licensing Authority has, during the representation period received representations from the following:
 - a) Sheffield Safeguarding Children Board

Appendix 'C'

3.3 The applicant, the Premises Licence Holder and any other person that has made representations have been invited to attend the hearing. Copies of the front page of the notices are attached to this report labelled Appendix 'D'.

4.0 FINANCIAL IMPLICATIONS

4.1 There are no specific financial implications arising from this application. However additional costs may be incurred should the matter go to appeal. In such an eventuality it may not be possible to recover all these costs. The impact of these additional costs (if any) will be kept under review and may be subject of a further report during the year.

5.0 THE LEGAL POSITION

- 5.1 The Licensing Act 2003 at section 52(3) requires that the Licensing Authority must, having regard to the application and any relevant representations, take such steps mentioned in subsection (4) (if any) as it considers necessary for the promotion of the licensing objectives.
- 5.2 Section 52(4) states:

"The steps are -

- a) To modify the conditions of the licence;
- b) To exclude the licensable activity from the scope of the licence:
- c) To remove the designated premises supervisor;
- d) To suspend the licence for a period not exceeding three months;
- e) To revoke the licence;

and for this purpose the conditions of the licence are modified if any of them is altered or omitted, or any new condition added."

- 5.3 If members decide to take the steps referred to in (a) or (b) above, it may provide that the modification or exclusion is to have effect for only such period (not exceeding three months) as it may specify.
- 5.4 The Licensing Act 2003 at section 52(11) states that:
 - "A determination under this section does not have effect -
 - a) until the end of the period given for appealing against the decision, or
 - b) if the decision is appealed against, until the appeal is disposed of."
- 5.5 The Licensing Act 2003 at section 4(1) requires the Licensing Authority to carry out its functions with a view to promoting the Licensing Objectives which section 4(2) sets out as:
 - a) the prevention of crime and disorder,
 - b) public safety,
 - c) the prevention of public nuisance,
 - d) the protection of children from harm.
- 5.6 Section 4(3) of the Licensing Act also requires the Licensing Authority to have regard to the published statement of the Licensing Policy and any guidance issued by the Secretary of State under Section 182.

6.0 HEARINGS REGULATIONS

- 6.1 Regulations governing hearings under the Licensing Act 2003 have been made by the Secretary of State.
- The Licensing Authority has provided all parties with the information required in the Regulations to the 2003 Act as set out at Appendix 'E'.
- 6.3 Attached at Appendix 'E' is the following: -
 - a) a copy of the Notice of Hearing;
 - b) the rights of a party provided in Regulations 15 and 16;
 - c) the consequences if a party does not attend or is not represented at the hearing
 - d) the procedure to be followed at the hearing.

7.0 APPEALS

7.1 The Licensing Act 2003 section 181 and Schedule 5 makes provision for appeals to be made by the applicant; the holder of the premises licence and those making representations against decisions of the Licensing Authority to the Magistrates Court.

8.0 RECOMMENDATIONS

8.1 That members carefully consider the application for review along with any other representations made and take such steps as detailed in paragraph 5.2 above that the Committee consider necessary for the promotion of the Licensing Objectives.

9.0 OPTIONS OPEN TO THE COMMITTEE

- 9.1 a) modify the conditions of the licence;
 - b) exclude a licensable activity from the scope of the licence;
 - c) remove the designated premises supervisor;
 - d) suspend the licence for a period not exceeding three months:
 - e) revoke the licence; or
 - f) reject the application for review.

Annex 1 - Mandatory Conditions

Mandatory Condition 1 (Section 19 ss 2)

Where a licence authorises the sale of alcohol then no supply of alcohol may be made under the premises licence –

- (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
- (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

Mandatory Condition 2 (Section 19 ss 3)

Where a licence authorises the sale of alcohol then every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

Mandatory Condition 3 (Section 20)

- 1. Where a premises licence authorises the exhibition of films, the licence includes the following conditions relating to the admission of children to the exhibition:
 - (a) The admission of children (under 18) to the exhibition of any film must be restricted in accordance with the classification set by the film classification body (currently the BBFC).
 - (b) In a case where there is no classification given by the classification body (the BBFC) the admission of children to the exhibition of any film must be restricted in accordance with any recommendation given by the Licensing Authority.
- 2. In this section -

"children" means persons aged under 18; and

"film classification body" means the person or persons designated as the authority under section 4 of the Video Recordings Act 1984 (c.39) (authority to determine suitability of video works for classification).

Mandatory Condition 4 (Section 21)

Where a premises licence includes a condition that at specified times one or more individuals must be at the premises to carry out a security activity each such individual must be licensed by the Security Industry Authority.

Prevention of Crime & Disorder Prevention of Public Nuisance Protection of Children from harm

Mosborough Off Licence, 56 High Street, Sheffield, was issued with a Premises Licence No SY 0946 PR on the 15th November 2005. The Premises Licence Holders are shown as Mr Peter THOMPSON and Mr Richard MARTIN and the Designated Premises Supervisor is Mr Peter THOMPSON.

The premises have been the subject of recent test purchase operations. Since 25th May 2011 it has failed the test three times. Full details of these test purchase operations are within this report.

These test purchase operations are conducted to provide a positive response and action following complaints from the public and observations by police staff that many instances of anti-social behaviour involve young people under the age of 18 years, who have acquired alcohol and/or are under the influence of alcohol.

Many instances of concern by local residents relate to shopping precincts, park areas and other similar hotspots, which suffer from grafitti, criminal damage and threatening behaviour by these young people towards other law abiding members of the public.



The issue of child safety is also raised, in that alcohol acquired by young people illegally is often passed to even younger children and over indulged by all, thereby causing serious concern for health and safety.

Test Purchase Operations and Intervention carried out over the last 14 months: -

1. Wednesday 25th May 2011

One x 500ml can of Budweiser Lager was sold to a police volunteer, 15 years old by a member of staff namely, Natalie MISSERE.

A Fixed Penalty Notice No. A0071848 3 was issued attracting a penalty of £80.00

- 2. Friday 24th June 2011 premises passed test purchase.
- 3 Friday 22nd July 2011 premises passed test purchase.
- 4. Thursday 4th August 2011 premises passed test purchase.
- 5. Tuesday 25th October 2011 premises passed test purchase.
- 6. Wednesday 16th November 2011

One x bottle 75cl bottle of Chardonnay wine value £4.99 was sold to a female police volunteer, 15 years old by a member of staff namely, Christine WHEAT.

- A Fixed Penalty Notice No. A00757624 was issued attracting a penalty of £80.
- 7. On the 22nd of November 2011 the premsies were visited by Police Licensing Officers who spoke with a member of staff, Anna MARTIN. The failed test purchase on the 16th of November was discussed and an information pack relating to Safeguarding Children, Trading Standards and various information about posible police action was passed over. A letter to the DPS, Mr THOMPSON was forwarded by the police Licensing Team informing him of the pack and for it to be circulated to other members of staff working at the premises.
- 8. Friday 23rd March 2012 premises passed test purchase.
- 9 Wednesday 30th May 2012

One x bottle of Bulmers Berry Cider was sold to a male volunteers, 16 years old by a member of staff namely, Amy MASON.

A Fixed Penalty Notice No. A0078197 5 was issued attracting a penalty of £80.00

10. On Wednesday 20th June a member of staff from South Yorkshire Police Licensing Team (Elizabeth Payne) and a member of staff from Sheffield Children's Safeguarding Board (Julie Hague) attended at the premises to meet with Mr MARTIN and Mr THOMPSON to discuss the previous test purchase failures and offer further support, training advice and guidance. However upon Ms Payne and Ms Hague arriving at the premises there was no answer to their knocking. Subsequent telephone conversations followed whereby Mr MARTIN and Mr THOMPSON advised that they had waited inside the premises from 8.30am to 8.45am and then left. However Ms Hague had left an answerphone message requesting the meeting time be changed to 9am. The meeting was re-scheduled for 9am on Monday 25th June 2012.



11. Saturday 23rd June 2012

One bottle of Bulmers Cider was sold to two volunteers, aged 16 & 17 years old by Premise Licence Holder Richard MARTIN.

A Fixed Penalty Notice No. A0078200 9 was issued attracting a penalty of £80.00. Mr MARTIN has since been offered the opportunity to attend the Fixed Penalty Notice Waiver Training Course.

12. Monday 25th June 2012

Ms Hague of Sheffield Children's Safeguarding Board and Ms Payne of South Yorkshire Police's Licensing team attended at the premise to meet with Mr MARTIN and Mr THOMPSON regarding previous Test Purchase failures. At the meeting the fact that a further failure had taken place over the weekend was discussed. Ms Payne advised that an application for a premise review would be submitted by South Yorkshire Police, and that they would also look to serve a Voluntary Closure Notice. General advice was given regarding training records(the store did not have any), checking of ID, refusals logs, and the use of signage. Ms Hague offered two places on the multi-agency training course which is due to be held on 11th July 2012. A duplicate training pack (same as the one given in November 2011) was left at the premise for later perusal.

13. Wednesday 27th June 2012-07-03

A Voluntary Closure Notice for a period of 96 hours (08:00hrs 13th July 2012 to 22:30hrs 15th July 2012) was served on the premises. Written acceptance of the Closure was received by email on 1st July 2012. We can confirm that the closure was adhered to.

Although three failures within a 12 month period are required to enable the initiation of a premise licence review, we have detailed a further failure above which falls outside of the twelve month period, but which we believe is relevent to this application.

Clearly it can be seen that no regular system of age related checks or challenge are made as standard practice, thereby leading to a presumption that alcohol is regularly traded to persons underage with little or no regard to the law or the licensing objectives.

Although intervention has been made with these premises by the Police, Childrens Safeguarding Board and Trading Standards they still sell alcohol to persons under the age of 18 years old.

The request for a review of a premises licence is not taken lightly by South Yorkshire Police, as it is well understood what effect this will have on trade and the prospects of the business. However there appears to be an obvious lack of responsibility by the Premises Licence Holders and the DPS.

Once identified we work with local partner agencies to offer support, advice and training to try and reduce the possibility of these premises committing the offence of underage sales again.

As the other evidence within this bundle shows, Mosborough Off Licence have failed four test purchase operations in the space of 13 months, the final two failures being made within a period of fourteen days. The premises have also passed some operations, however I have grave concerns with regards to the management of the premise. As stated above the effects of alcohol on young people can lead to an increase in Anti-Social and criminal behaviour which negatively impacts on the local community. Therefore I am eager to ensure that premises such as the Mosborough Off Licence are made aware of the impact of their failure to prevent sales to underage people, and that in future they take all reasonable steps available to ensure that this does not happen again.



The above documentation has been provided to the Sheffield Safeguarding Children Board (SSCB Licensing Project) as a Responsible Authority under the Licensing Act 2003. I am writing on behalf of the Safeguarding Children Board to make a Representation under the Core Objective for the Protection of Children from Harm, on the grounds that there have been repeated sales of alcohol to children and young people at the premises over the last 13 months.

The Safeguarding Children Board takes a serious view of premises that are unable to protect children from the risks associated with underage sales of alcohol. The evidence presented by South Yorkshire Police shows a number of failed test purchase operations at this premises and in line with the Licensing Authority approved Joint Agency Test Purchase Strategy, which is an agreed process to assist premise managers to improve their operation, the Safeguarding Children Board has attempted to work in partnership with the premises management, providing a number of interventions including free multi agency training to the premises management and staff. (The details of these interventions are provided in the chronology and related documents at Appendix 1 of this letter for the consideration of the Licensing Sub-Committee).

Despite attempts to support the premises management over the period from June 2011 to date, a consistent operational improvement has not been achieved and evidence of underage sales has continued.

In light of the above I am writing to ask the Licensing Authority to take positive action to protect children from the risks presenting at this premises.



Right of attendance, assistance and representation

15. Subject to regulations 14(2) and 25, a party may attend the hearing and may be assisted or represented by any person whether or not that person is legally qualified.

Representations and supporting information

16. At the hearing a party shall be entitled to -

(a) in response to a point upon which the authority has given notice to a party that it will want clarification under regulation 7(1)(d), give further information in support of their application, representations or notice (as applicable),

(b) if given permission by the authority, question any other party; and

(c) address the authority

Failure of parties to attend the hearing

20. – (1) If a party has informed the authority that he does not intend to attend or be represented at a hearing, the hearing may proceed in his absence.

(2) If a party who has not so indicated fails to attend or be represented at a

hearing the authority may:-

(a) where it considers it to be necessary in the public interest, adjourn the hearing to a specified date, or

(b) hold the hearing in the party's absence.

- (3) Where the authority holds the hearing in the absence of a party, the authority shall consider at the hearing the application, representations or notice made by that party.
- (4) Where the authority adjourns the hearing to a specified date it must forthwith notify the parties of the date, time and place to which the hearing has been adjourned.

Procedure at hearing

21. Subject to the provisions of the Regulations, the authority shall determine the procedure to be followed at the hearing.

22. At the beginning of the hearing, the authority shall explain to the parties the procedure which it proposes to follow at the hearing and shall consider any request made by a party under regulation 8(2) for permission for another person to appear at the hearing, such permission shall not be unreasonably withheld.

23. A hearing shall take the form of a discussion led by the authority and cross-examination shall not be permitted unless the authority considers that cross-examination is required for it to consider the representations, application or notice as the case may require.

24. The authority must allow the parties an equal maximum period of time in which to exercise their rights provided for at regulation 16.

25. The authority may require any person attending the hearing who in their opinion is behaving in a disruptive manner to leave the hearing and may –

(a) refuse to permit that person to return, or

(b) permit him to return only on such conditions as the authority may specify, but such a person may, before the end of the hearing, submit to the authority in writing any information which they would have been entitled to give orally had they not been required to leave.



Licensing Act 2003 - Hearing Procedure (REVIEW) - Regulation 7 (1)

This procedure has been drawn up in accordance with the Licensing Act 2003 to assist those parties attending Licensing Committee hearings.

- 1. The hearing before the Council is Quasi Judicial.
- 2. The Chair of the Licensing Committee will introduce the Committee and ask officers to introduce themselves.
- 3. The Chair will ask the applicants and other parties to formally introduce themselves.
- 4. The Solicitor to the Committee will outline the procedure to be followed at the hearing.
- Hearing Procedure:-
 - (a) The Licensing Officer will introduce the report.
 - (b) Questions concerning the report can be asked by Members the applicant and other parties.
 - (c) The Licensing Officer will introduce the applicant for review (or his/her nominated representative) who will be asked to detail the application.
 - (d) Members may ask questions.
 - (e) The Licensing Officer will in turn introduce representatives for the other Responsible Authorities and Interested parties who will be asked to detail their relevant representations
 - (f) Members may ask questions
 - (g) With the leave of the Chair the licensee or his representative may cross examine the representatives of the applicant for review and the other Responsible Authorities and Interested Parties.
 - (h) The licensee (or his/her nominated representative) will then be asked to respond to the application and to any other representations made.
 - (i) The licensee (or his/her nominated representative) may then be asked questions by members and with the leave of the Chair from the other parties present.
 - (j) The applicant will then be given the opportunity to sum up the application.
 - (k) The representatives of the Responsible Authorities will be given the opportunity to sum up
 - (I) The licensee will be given the opportunity to sum up
 - (m) The Licensing Officer will then detail the options.
 - (n) There will then be a private session for members to take legal advice and consider the application.
- 6. The decision of the Licensing Committee will be given in accordance with the requirements of the Licensing Act 2003 and regulations made there under.
- NB: 1) At any time in the Licensing Process Members of the Committee may request legal advice from the Solicitor to the Committee. This advice may be given in open session or in private.
 - 2) The Board Hearing will be held in public unless and in accordance with the Regulations the Committee determine that the public should be excluded.

Regulation 8

- A party shall give to the authority within the period of time provided for in the following provisions of this regulation a notice stating –
 - (a) whether he intends to attend or be represented at the hearing;
 - (b) whether he considers a hearing to be unnecessary
- (2) In a case where a party wishes any other person (other than the person he intends to represent him at the hearing) to appear at the hearing, the notice referred to in paragraph (1) shall contain a request for permission for such other person to appear at the hearing accompanied by details of the name of that person and a brief description of the point or points on which that person may be able to assist the authority in relation to the application, representations or notice of the party making the request.
- (3) In the case of a hearing under
 - (a) section 48(3)(a) (cancellation of interim authority notice following police objection), or
 - (b) section 105(2)(a) (counter notice following police objection to temporary event notice),

the party shall give the notice no later than one working day before the day or the first day on which the hearing is to be held.

- (4) In the case of a hearing under -
 - (a) section 167(5)(a) (review of premises licence following closure order),
 - (b) paragraph 4(3)(a) of Schedule 8 (determination of application for conversion of existing licence),
 - (c) paragraph 16(3)(a) of Schedule 8 (determination of application for conversion of existing club certificate)
 - (d) paragraph 26(3)(a) of Schedule 8 (determination of application by holder of justices' licence for grant of personal licence),

the party shall give the notice no later than two working days before the day or the first day on which the hearing is to be held.

(5) In any other case, the party shall give the notice no later than five working days before the day or the first day on which the hearing is to be held.
