ADVICE TO MEMBERS ON DECLARING INTERESTS AT MEETINGS

If you are present at a meeting of the Council, of its executive or any committee of the executive, or of any committee, sub-committee, joint committee, or joint sub-committee of the authority, and you have a **Disclosable Pecuniary Interest** (DPI) relating to any business that will be considered at the meeting, you must not:

- participate in any discussion of the business at the meeting, or if you become aware of your Disclosable Pecuniary Interest during the meeting, participate further in any discussion of the business, or
- participate in any vote or further vote taken on the matter at the meeting.

These prohibitions apply to any form of participation, including speaking as a member of the public.

You must:

- leave the room (in accordance with the Members' Code of Conduct)
- make a verbal declaration of the existence and nature of any DPI at any
 meeting at which you are present at which an item of business which affects or
 relates to the subject matter of that interest is under consideration, at or before
 the consideration of the item of business or as soon as the interest becomes
 apparent.
- declare it to the meeting and notify the Council's Monitoring Officer within 28 days, if the DPI is not already registered.

If you have any of the following pecuniary interests, they are your **disclosable pecuniary interests** under the new national rules. You have a pecuniary interest if you, or your spouse or civil partner, have a pecuniary interest.

- Any employment, office, trade, profession or vocation carried on for profit or gain, which you, or your spouse or civil partner undertakes.
- Any payment or provision of any other financial benefit (other than from your council or authority) made or provided within the relevant period* in respect of any expenses incurred by you in carrying out duties as a member, or towards your election expenses. This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992.

*The relevant period is the 12 months ending on the day when you tell the Monitoring Officer about your disclosable pecuniary interests.

- Any contract which is made between you, or your spouse or your civil partner (or a body in which you, or your spouse or your civil partner, has a beneficial interest) and your council or authority –
 - under which goods or services are to be provided or works are to be executed; and
 - which has not been fully discharged.

- Any beneficial interest in land which you, or your spouse or your civil partner, have and which is within the area of your council or authority.
- Any licence (alone or jointly with others) which you, or your spouse or your civil
 partner, holds to occupy land in the area of your council or authority for a month
 or longer.
- Any tenancy where (to your knowledge)
 - the landlord is your council or authority; and
 - the tenant is a body in which you, or your spouse or your civil partner, has a beneficial interest.
- Any beneficial interest which you, or your spouse or your civil partner has in securities of a body where -
 - (a) that body (to your knowledge) has a place of business or land in the area of your council or authority; and
 - (b) either -
 - the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or
 - if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you, or your spouse or your civil partner, has a beneficial interest exceeds one hundredth of the total issued share capital of that class.

If you attend a meeting at which any item of business is to be considered and you are aware that you have a **personal interest** in the matter which does not amount to a DPI, you must make verbal declaration of the existence and nature of that interest at or before the consideration of the item of business or as soon as the interest becomes apparent. You should leave the room if your continued presence is incompatible with the 7 Principles of Public Life (selflessness; integrity; objectivity; accountability; openness; honesty; and leadership).

You have a personal interest where -

- a decision in relation to that business might reasonably be regarded as affecting
 the well-being or financial standing (including interests in land and easements
 over land) of you or a member of your family or a person or an organisation with
 whom you have a close association to a greater extent than it would affect the
 majority of the Council Tax payers, ratepayers or inhabitants of the ward or
 electoral area for which you have been elected or otherwise of the Authority's
 administrative area, or
- it relates to or is likely to affect any of the interests that are defined as DPIs but are in respect of a member of your family (other than a partner) or a person with whom you have a close association.

Guidance on declarations of interest, incorporating regulations published by the Government in relation to Disclosable Pecuniary Interests, has been circulated to you previously.

You should identify any potential interest you may have relating to business to be considered at the meeting. This will help you and anyone that you ask for advice to fully consider all the circumstances before deciding what action you should take.

In certain circumstances the Council may grant a **dispensation** to permit a Member to take part in the business of the Authority even if the member has a Disclosable Pecuniary Interest relating to that business.

To obtain a dispensation, you must write to the Monitoring Officer at least 48 hours before the meeting in question, explaining why a dispensation is sought and desirable, and specifying the period of time for which it is sought. The Monitoring Officer may consult with the Independent Person or the Council's Standards Committee in relation to a request for dispensation.

<u>STREET TRADING – MOBILE STREET TRADING CONSENT WITHIN THE</u> CITY CENTRE

1.0 PURPOSE OF REPORT

1.1 To consider an application for the grant of a Mobile Street Trading consent within the City Centre Boundary.

2.0 INTRODUCTION

- 2.1 The Council as a Licensing Authority have power under the provision of the 1982 Act to regulate Street Trading in the City.
- 2.2 A Street Trading Consent is required to trade on any Street (which includes roads, footways, forecourts, or other areas to which the public have access) within the Sheffield City Boundary.
- 2.3 The Licensing Committee at it's meeting of 29th January 2002 passed the following resolution:
 - 1. That under the provisions of schedule 4 of the Local Government (Miscellaneous Provisions) Act 1982:
 - all streets (which includes roads, footways, forecourts or other areas to which the public have access) within the Sheffield City boundary, shall be designated consent streets and;
 - (b) such street trading designation shall take effect as from the 1st April 2002; and
 - (c) all previous designations in relation to street trading will be rescinded as a result of the designation set out above.
 - 2. The effect of this resolution is that from 1st April 2002, it will be an offence to engage in street trading in any street or any other place identified in the above resolution without being authorised to do so by consent from the City Council.
- 2.4 A Local Authority may attach conditions to a Street Trading Consent. The conditions may include conditions to prevent obstruction of the street and danger to persons using the street or nuisance or annoyance.
- 2.5 A Street Trading Consent may only be granted for a maximum period of twelve months.

2.6 There is no appeal procedure against the refusal or revocation of a consent. An applicant may, however apply for judicial review of the Council's decision.

3.0 THE APPLICATION

- 3.1 The applicant is Mr Michael Desmond and a copy of the application and supporting documents are attached at Appendix 'A'.
- 3.2 The application was submitted on 14th May 2015.
- 3.3 The application is to sell flowers from a non-motorised tricycle within the City Centre.
- 3.4 The application submitted shows a proposed mobile route through specific locations within the City Centre Boundary:
 - Barkers Pool
 - Fargate
 - Peace Gardens (Pinstone Street) (12:30-13:30)
 - 13:30-15:30 hours break
 - Vulcan House, Riverside (15:30-17:00)
 - 17:00-19:00 hours break
 - Sheffield Railway Station for the Master Cutler arrival at 18:30-19:00 hours
- 3.5 The application was circulated for consultation, in the usual manner, to the City Centre Management Team, South Yorkshire Police, South Yorkshire Fire and Rescue, Highways and Planning on 18th May 2015.
- 3.6 No objections have been received by any of the Responsible Authorities. However, comments have been made by the Highways Department, attached at Appendix 'B'
- 3.7 Members are to note that the specific location at each site will be agreed in conjunction with the City Centre Management Team and Highways Department so as not to cause obstruction on the highway to other road users as well as to consider safety of the operator / applicant.
- 3.8 The applicant has been invited to attend the Licensing Committee hearing. Copies of the invites are attached at Appendix 'C'.
- 3.9 A copy of the hearing procedure is attached at Appendix 'D'.

4.0 REASONS FOR REFERRAL

- 4.1 The application has been referred to the Licensing Sub-Committee for their consideration as the trading proposals set out in Mr Desmond's application falls outside the scope of the current street trading policy as detailed below.
- 4.2 Firstly, Mr Desmond's application requests to act as a mobile trader to sell flowers. This falls outside the current policy for mobile traders to sell only fruit and vegetables (see section 3.3 of the policy).



- 4.3 Mr Desmond's proposed trading times would also fall outside the scope of the standard mobile conditions which are attached at Appendix 'E'. In particular conditions 1, 2 and 7.
- 4.4 Secondly, Mr Desmond's request is to trade in the city centre boundary as a mobile trader, this fall outside the scope of our city centre policy as detailed below.
- 4.5 Currently our city centre policy (section 3) for street trading refers to only specific sites which have been agreed and allocated as suitable. This has been agreed in consultation with the City Centre Management Team and the Planning Department. Currently those site are:
 - Top of Fargate Currently allocated to a trader selling Hot Food
 - Bottom of Fargate Currently allocated to a trader selling Ice Cream
 - Outside of Peace Gardens Currently allocated to trader selling Ice Cream
 - Howard Street Currently allocated to trader selling Coffee
 - Tudor Square Currently allocated to trader selling Hot Food
 - Barkers Pool Currently allocated to trader in the evening selling Hot Food
- 4.6 Mr Desmond's application refers to a route which as listed above falls outside the agreed allocated sites/areas.
- 4.7 Members are also noted that any applications which fall within the city centre boundary, should also consider the City Centre Qualitative Criteria for Small Trading Stalls at page 38 of our Policy.
- 4.8 Members should consider all the information provided by the applicant both in their written application and in person at the hearing.
- 4.9 Members are to also note section 2.8 of Street Trading Policy when determining this application, in particular sections 2.8.2
 - Public Safety / Highway sections (b) & (d)
 - Appearance of the unit sections (a) & (b)

5.0 FINANCIAL IMPLICATIONS

- 5.1 The Street Trading Policy states that fees will be set and reviewed annually on a full cost recovery basis. The level of fee takes into account the location, duration of consent, the trading hours and articles to be sold as well as the enforcement of terms and conditions.
- 5.2 The current fee for City Centre Street Trading is £1994.00 per annum, if granted payments can be made quarterly if agreed with the Authority.
- 5.3 The applicant has paid the current mobile fee of £315, to ensure the Service recovers its costs for a City Centre Consent, the fee should reflect the current city centre fee as in section 6.2 of this report.



6.0 RECOMMENDATIONS

6.1 That Members consider all the relevant information available and any representations that may be made.

7.0 OPTIONS OPEN TO THE COMMITTEE

- 7.1 To grant the application for a Mobile Street Trading Consent within the City Centre boundary and impose a revised fee.
- 7.2 To grant the application with amendments with a revised fee.
- 7.3 To defer the matter for further consideration.
- 7.4 To refuse the grant of the Mobile Street Trading Consent within the City Centre.

Proposal for mobile flower sales (Zero carbon emissions)

My proposal is as follows:

The Business Idea and its operations
The business idea is to sell competitively priced, high quality flowers in Sheffield City Centre, Vulcan
House (Iron & Steel), Sheffield Railway station, travelling by bespoke tricycle (see pic 1) which will be
highly attractive and eye-catchingly painted in primary colours and will conform to all size
requirements

Please see attached picture of Tricycle

I propose to:

Cycle a route around the city centre, selling flowers at the following locations: The route and times will be as follows:

Barkers Pool Fargate Peace Gardens (Pinstone Street) 12.30 - 1.30pm 1.30 - 3.30pm - break Vulcan House (Iron & Steel), Riverside 3.30 - 5.00pm 5.00 - 7.00pm - break Sheffield Railway Station for the Master Cutler arrival 6-30 7pm

I attach a map of my route.

I will avoid The Moor, as I am fully aware there are already four flower sellers pitched there. I will also avoid Division Street, as I understand there are two flower sellers there. I will stop when requested by the general public, there will be no hindrance to traffic on the route I am proposing and will walk with my non motorised unit whilst on Fargate and near pedestrians. I have acquainted myself with relevant health and safety requirements and the tricycle will be serviced and well - maintained at all times.

I have chosen this business idea because I have identified a gap in the market around the city centre, Riverside / Kelham Island and Sheffield Railway station.

Products

I shall collect flowers on a daily basis from the wholesale market and stock the tricycle, leaving further supplies at home for collection later in the day, as the need arises.

I shall add 30% to the wholesale price of buying the completed floral arrangements and I am confident that I will be able to make a profit because of my low running costs.

I aim to sell 100 units per week.

Marketing



I have spoken to a range of people (around 50) from legal companies and Government agencies, around Riverside and Kelham Island and over half have stated that they would buy flowers after work, if they were made available.

I have examined the local area in detail and there is little or no provision.

I shall carry advertising material for distrubution at the Riverside offices. I would aim to raise awareness of my business through my daily round.

Your costs and break even point.

My start up costs are very low, the only expense being the tricycle and the customising of it, which will be £500.


My market research has convinced me that I will no adversely affect any flower vendors in or around the city centre area.

Hi Georgina,

The basis of the comment below is that there would be no problem with the applicant simply travelling along roads at peak traffic periods to get to pedestrianised trading sites, much as any other commuter would travel.

Concerns relate to the potential for to him travel at such times along a busy road and then being hailed by a pedestrian wishing to purchase flowers.

This would result in the trader stopping on the road, causing a potential danger to himself and others.

On pedestrianised areas this would not be a problem, particularly since vehicular traffic would not be affected and he would be pushing his cycle-barrow.

However, this should <u>not necessarily extend to trading</u> on wide pedestrianised areas.

- 2. Mobile consent holders are not permitted to trade within a 500 metre radius of any static traders, other mobile traders, or shops, trading in similar goods / articles.
- 3. Any consent issued for a mobile street trader does not permit the holder to trade within an 800 metre radius of the Sheffield Arena, Don Valley Stadium, Sheffield Wednesday and Sheffield United Stadiums on any event / match day (see attached plan) for four hours previous, during and one hour after any event.
- Mobile traders must not in any circumstance unload items for sale off the unit for display on the footpath, highway or any other area.
- 5. Mobile traders can only trade between the hours of 9am to 7pm seven days a week.
- 6. Mobile traders are only permitted to trade in the areas listed on their consents.
- Mobile traders must ensure that any stopping position does not infringe any parking or traffic requirements or cause obstruction of the highway, and does not present any dangers to other road users or pedestrians.
- 8. Mobile traders must not stop within 800 metres of any school from an hour before the start of the school day until an hour after the end of the school day.

PLEASE NOTE, for the purposes of these conditions the "Council" shall be defined as the Licensing Service.

1.0 PURPOSE OF REPORT

1.1 To consider an application for the grant of a Static Street Trading consent to trade at The Abbey public house car park, 944 Chesterfield Road, Sheffield, S8 0SH.

2.0 INTRODUCTION

- 2.1 The Council as a Licensing Authority have power under the provision of the 1982 Act to regulate Street Trading in the City.
- 2.2 A Street Trading Consent is required to trade on any Street (which includes roads, footways, forecourts, or other areas to which the public have access) within the Sheffield City Boundary.
- 2.3 The Licensing Committee at it's meeting of 29th January 2002 passed the following resolution:
 - 1. That under the provisions of schedule 4 of the Local Government (Miscellaneous Provisions) Act 1982:
 - (a) all streets (which includes roads, footways, forecourts or other areas to which the public have access) within the Sheffield City boundary, shall be designated consent streets and;
 - (b) such street trading designation shall take effect as from the 1st April 2002; and
 - (c) all previous designations in relation to street trading will be rescinded as a result of the designation set out above.
 - 2. The effect of this resolution is that from 1st April 2002, it will be an offence to engage in street trading in any street or any other place identified in the above resolution without being authorised to do so by consent from the City Council.
- 2.4 A Local Authority may attach conditions to a Street Trading Consent. The conditions may include conditions to prevent obstruction of the street and danger to persons using the street or nuisance or annoyance.
- 2.5 A Street Trading Consent may only be granted for a maximum period of twelve months.

2.6 There is no appeal procedure against the refusal or revocation of a consent. An applicant may, however apply for judicial review of the Council's decision.

3.0 THE APPLICATION

- 3.1 The applicant is Mikey & Jonny's Pizza Company Ltd and a copy of the application is attached at Appendix 'A'.
- 3.2 The application was submitted on 15th May 2015.
- 3.3 The application is to sell Pizza from an Italian pizza oven mounted aluminium trailer on a Tuesday and Friday every week from 11:00 to 21:00 hours.
- 3.4 The applicant has consulted with the Planning and Highways departments and received comments back from each service as well as authorisation from the brewery, Punch Taverns Pub Company to trade within the car park area at the premises.
- 3.5 The application was circulated, in the usual manner, to South Yorkshire Police, South Yorkshire Fire and Rescue, Highways and Planning. Notices were erected by Licensing Officers at the site advertising the application and notice was also given to shops and anyone that might be affected by the applications within the immediate vicinity.
- 3.6 No objections have been received by any of the above relevant authorities. However, comments that have been made by the Planning Department and Highway Department are attached at Appendix 'B'.
- 3.7 Objections have been received by interested parties listed below in 4.1 of this report.

4.0 REASONS FOR REFERRAL

- 4.1 The application has been referred to the Sub-Licensing Committee for their consideration as the Licensing Authority has received objections to the application from the following parties:-
 - Greenhill Road NHW Group Residents of Greenhill Road
 - · Local resident of Greenhill Road

- 4.2 The objections refer to issues contained in section 2.8 of our street trading policy when determining the application, and Members are referred to in particular section 2.8.2:
 - Public Safety sections (a), (b) & (c)
 - Avoidance of Public Nuisance section (b)
 - Appearance of the unit section (b)
 - Environmental Credentials section (a)
- 4.3 Members should consider all the information provided by the applicant both in their written application and in person at the hearing.





I have been approached by a number of our residents on Greenhill Road, because there is concern regarding the above application.

1. Position

First of all is the objection to the positioning of the aluminium trailer, which will appear an unsightly obtrusion as it blocks the full view of the Abbey Pub building, particularly to traffic coming down Meadowhead. This is a pleasant looking area and we don't want it marring either temporary or permanently.

2. Traffic problems

Secondly and more importantly is the traffic access and parking problem. This is a very busy corner for traffic. Also parking is in great demand. Access to the pub car park will be severely limited for any cars coming off Chesterfield Road and Meadowhead and wanting to enter the car park to use the Pizza van. The entrance is just beside the lights where cars wait. This could cause a holdup on Meadowhead if there are stationary vehicles at the lights on Abbey Lane blocking the car park entrance. During busy periods it can slow the traffic flow down, particularly for vehicles travelling from Abbey Lane onto Chesterfield Road because only 3–4 cars are let through the lights at one time.

It has always been a tricky situation driving in and out of the car park. (This may be the reason the pub car park isn't used much). We don't want this problem adding to when so much effort and cost has been made recently to enable traffic flow at this junction.

3. More Fast Food.

This is a potential temptation to schoolchildren. We have more than enough fast food outlets in Woodseats already, but this would be too obvious and accessible to the many school children who pass this point, not only from the Abbey Lane school but others in the close proximity. Let us act responsibly in regard to the 'diet' of our children.

There is also a potential for more litter. We already have a litter problem from the older ones using Greenhill Road as a thoroughfare and dropping letter after consuming snacks from Morrisons.

We would ask you to reject this application for the reasons given above.

SUB-COMMITTEE HEARING PROCEDURE

This procedure has been drawn up to assist those parties attending Street Trading Consent Committee hearings.

- 1. The Chair of the Licensing Committee will introduce the Committee and ask officers to introduce themselves.
- 2. The Chair will ask the applicants and interested parties to formally introduce themselves.
- 3. The Solicitor to the Committee will outline the procedure to be followed at the hearing.
- 4. Hearing Procedure:-
 - (a) The Licensing Officer will introduce the report.
 - (b) Questions concerning the report can be asked both by Members and the applicant.
 - (c) The applicant/consent holder (or his/her nominated representative) will then be asked to:-
 - (i) detail the application;
 - (ii) provide clarification on the application and respond to the representations made.
 - (d) The Chair of the Licensing Committee will invite Members of the Sub-Committee and all other parties present to put any relevant questions to the applicant and/or his/her representative.
 - (e) Consultees / interested parties will be invited to present their representations or elect a spokesperson (which may be a Councillor) to speak on their behalf. New representations must not be raised.
 - (f) The Chair of the Licensing Committee will invite Members of the Sub-Committee and all other parties present to put any relevant questions to the consultees / interested parties.
 - (g) The consultees / interested parties will be invited to sum up. A maximum of 5 minutes will be allowed.
 - (h) The applicant will be invited to sum up. A maximum of 5 minutes will be allowed.
 - (i) The Licensing Officer will then detail the options.
 - (j) There will then be a private session for Members to take legal advice and consider the application.
 - (k) Once a decision has been reached, all parties will be invited to return. The Sub-Committee's decision and reasons will be announced by the Chair.
 - (I) The Sub-Committee's decision will be confirmed in writing to the applicant and those parties who made representations.
- NB: 1) At any time in the Licensing Process Members of the Committee may request legal advice from the Solicitor to the Committee. This advice may be given in open session or in private.
 - 2) The Committee Hearing will be held in public unless and in accordance with the Regulations the Committee determine that the public should be excluded.

There is no right of appeal against the Council's decision to refuse to grant or revoke a Street Trading Consent.
