#### ADVICE TO MEMBERS ON DECLARING INTERESTS AT MEETINGS

If you are present at a meeting of the Council, of its executive or any committee of the executive, or of any committee, sub-committee, joint committee, or joint sub-committee of the authority, and you have a **Disclosable Pecuniary Interest** (DPI) relating to any business that will be considered at the meeting, you must <u>not</u>:

- participate in any discussion of the business at the meeting, or if you become aware of your Disclosable Pecuniary Interest during the meeting, participate further in any discussion of the business, or
- participate in any vote or further vote taken on the matter at the meeting.

These prohibitions apply to any form of participation, including speaking as a member of the public.

#### You must:

- leave the room (in accordance with the Members' Code of Conduct)
- make a verbal declaration of the existence and nature of any DPI at any meeting at which you are present at which an item of business which affects or relates to the subject matter of that interest is under consideration, at or before the consideration of the item of business or as soon as the interest becomes apparent.
- declare it to the meeting and notify the Council's Monitoring Officer within 28 days, if the DPI is not already registered.

If you have any of the following pecuniary interests, they are your **disclosable pecuniary interests** under the new national rules. You have a pecuniary interest if you, or your spouse or civil partner, have a pecuniary interest.

- Any employment, office, trade, profession or vocation carried on for profit or gain, which you, or your spouse or civil partner undertakes.
- Any payment or provision of any other financial benefit (other than from your council or authority) made or provided within the relevant period\* in respect of any expenses incurred by you in carrying out duties as a member, or towards your election expenses. This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992.

\*The relevant period is the 12 months ending on the day when you tell the Monitoring Officer about your disclosable pecuniary interests.

- Any contract which is made between you, or your spouse or your civil partner (or a body in which you, or your spouse or your civil partner, has a beneficial interest) and your council or authority –
  - under which goods or services are to be provided or works are to be executed; and
  - which has not been fully discharged.

- Any beneficial interest in land which you, or your spouse or your civil partner, have and which is within the area of your council or authority.
- Any licence (alone or jointly with others) which you, or your spouse or your civil partner, holds to occupy land in the area of your council or authority for a month or longer.
- Any tenancy where (to your knowledge)
  - the landlord is your council or authority; and
  - the tenant is a body in which you, or your spouse or your civil partner, has a beneficial interest.
- Any beneficial interest which you, or your spouse or your civil partner has in securities of a body where -
  - (a) that body (to your knowledge) has a place of business or land in the area of your council or authority; and
  - (b) either -
    - the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or
    - if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you, or your spouse or your civil partner, has a beneficial interest exceeds one hundredth of the total issued share capital of that class.

If you attend a meeting at which any item of business is to be considered and you are aware that you have a **personal interest** in the matter which does not amount to a DPI, you must make verbal declaration of the existence and nature of that interest at or before the consideration of the item of business or as soon as the interest becomes apparent. You should leave the room if your continued presence is incompatible with the 7 Principles of Public Life (selflessness; integrity; objectivity; accountability; openness; honesty; and leadership).

You have a personal interest where -

- a decision in relation to that business might reasonably be regarded as affecting the well-being or financial standing (including interests in land and easements over land) of you or a member of your family or a person or an organisation with whom you have a close association to a greater extent than it would affect the majority of the Council Tax payers, ratepayers or inhabitants of the ward or electoral area for which you have been elected or otherwise of the Authority's administrative area, or
- it relates to or is likely to affect any of the interests that are defined as DPIs but are in respect of a member of your family (other than a partner) or a person with whom you have a close association.

Guidance on declarations of interest, incorporating regulations published by the Government in relation to Disclosable Pecuniary Interests, has been circulated to you previously.

You should identify any potential interest you may have relating to business to be considered at the meeting. This will help you and anyone that you ask for advice to fully consider all the circumstances before deciding what action you should take.

In certain circumstances the Council may grant a **dispensation** to permit a Member to take part in the business of the Authority even if the member has a Disclosable Pecuniary Interest relating to that business.

To obtain a dispensation, you must write to the Monitoring Officer at least 48 hours before the meeting in question, explaining why a dispensation is sought and desirable, and specifying the period of time for which it is sought. The Monitoring Officer may consult with the Independent Person or the Council's Audit and Standards Committee in relation to a request for dispensation.

#### LICENSING ACT 2003

#### **Review of Premises Licence**

#### A & E News 128 Mansfield Road Sheffield S12 2AQ

#### 1.0 PURPOSE OF REPORT

1.1 To consider an application for the review of a premises licence made under Section 51 of the Licensing Act 2003 in relation to A & E News 128 Mansfield Road Sheffield S12 2AQ.

#### 2.0 THE APPLICATION

- 2.1 The application was made by the South Yorkshire Police on 1<sup>st</sup> November 2016.
- 2.2 The grounds for the review are based on the following aspects of the 2003 Licensing Act objectives:-
  - The prevention of crime and disorder
  - Public Safety
  - The prevention of public nuisance.
  - The protection of children from harm.
- 2.3 The application form is attached at Appendix 'A' and details further the grounds for the review application.

#### 3.0 REASONS FOR REFERRAL

- 3.1 The Licensing Authority must under the Act refer any application for review to the Licensing Committee, unless it is withdrawn, or if representations are made by an interested party that the Licensing Authority are of the opinion that they are frivolous or vexatious.
- 3.2 The Licensing Authority has, during the representation period received representations from the following:-

a)	South Yorkshire Police	Appendix 'B'
b)	Sheffield Safeguarding Children Board	Appendix 'B'

- 3.3 The applicant, the Premises Licence Holder and any other person that has made representations have been invited to attend the hearing. Copies of the front page of the notices are attached to this report labelled Appendix 'C'.
- 3.4 A copy of the current premises licence is attached at Appendix D.

#### 4.0 FINANCIAL IMPLICATIONS

4.1 There are no specific financial implications arising from this application. However additional costs may be incurred should the matter go to appeal. In such an eventuality it may not be possible to recover all these costs. The impact of these additional costs (if any) will be kept under review and may be subject of a further report during the year.

#### 5.0 THE LEGAL POSITION

- 5.1 The Licensing Act 2003 at section 52(3) requires that the Licensing Authority must, having regard to the application and any relevant representations, take such steps mentioned in subsection (4) (if any) as it considers necessary for the promotion of the licensing objectives.
- 5.2 Section 52(4) states:

"The steps are --

- a) To modify the conditions of the licence;
- b) To exclude the licensable activity from the scope of the licence;
- c) To remove the designated premises supervisor;
- d) To suspend the licence for a period not exceeding three months;
- e) To revoke the licence;

and for this purpose the conditions of the licence are modified if any of them is altered or omitted, or any new condition added."

- 5.3 If members decide to take the steps referred to in (a) or (b) above, it may provide that the modification or exclusion is to have effect for only such period (not exceeding three months) as it may specify.
- 5.4 The Licensing Act 2003 at section 52(11) states that:

"A determination under this section does not have effect -

- a) until the end of the period given for appealing against the decision, or
- b) if the decision is appealed against, until the appeal is disposed of."
- 5.5 The Licensing Act 2003 at section 4(1) requires the Licensing Authority to carry out its functions with a view to promoting the Licensing Objectives which section 4(2) sets out as:
  - a) the prevention of crime and disorder,
  - b) public safety,
  - c) the prevention of public nuisance,
  - d) the protection of children from harm.
- 5.6 Section 4(3) of the Licensing Act also requires the Licensing Authority to have regard to the published Statement of Licensing Policy and any guidance issued by the Secretary of State under Section 182.

#### 6.0 HEARINGS REGULATIONS

- 6.1 Regulations governing hearings under the Licensing Act 2003 have been made by the Secretary of State.
- 6.2 The Licensing Authority has provided all parties with the information required in the Regulations to the 2003 Act as set out at Appendix 'C'.
- 6.3 Attached at Appendix 'C' is the following:
  - a) a copy of the Notice of Hearing;
  - b) the rights of a party provided in Regulations 15 and 16;
  - c) the consequences if a party does not attend or is not represented at the hearing
  - d) the procedure to be followed at the hearing.

#### 7.0 APPEALS

7.1 The Licensing Act 2003 section 181 and Schedule 5 makes provision for appeals to be made by the applicant; the holder of the premises licence and those making representations against decisions of the Licensing Authority to the Magistrates Court.

#### 8.0 **RECOMMENDATIONS**

8.1 That members carefully consider the application for review along with any other representations made and take such steps as detailed in paragraph 5.2 above that the Committee consider necessary for the promotion of the Licensing Objectives.

#### 9.0 OPTIONS OPEN TO THE COMMITTEE

- 9.1 a) modify the conditions of the licence;
  - b) exclude a licensable activity from the scope of the licence;
  - c) remove the designated premises supervisor;
  - d) suspend the licence for a period not exceeding three months;
  - e) revoke the licence; or
  - f) reject the application for review.

The grounds for this review are based on the following aspects of the 2003 Licensing Act objectives:-

The Prevention of Crime and Disorder Public Safety The Prevention of Public Nuisance Protection of Children from Harm

A&E News, 128 Mansfield Road, Sheffield, S12 2AQ was granted a Premises License No SY 2370 PR on 1<sup>st</sup> October 2015. The Premises License Holder is shown as Nadeem QAMAR and Designated Premise Supervisor is shown as Talat Nosheen ZAMEER.

The premises have been subject of Test Purchase Operations. Since 4<sup>th</sup> November 2015 it has failed the test three times and passed the test five times. Details of these test purchase operations are contained within this report and more detail provided within my police witness statement.

These test purchase operations are conducted to provide a positive response and action following complaints from the public and observations by police staff that many instances of anti-social behaviour involve young people under the age of 18 years, who have acquired alcohol and/or under the influence of alcohol. Anti-Social Behaviour is reported on a regular basis by staff at the shop.

Many instances of concern by local residents relate to shopping precincts, park areas and other similar hotspots, which suffer from graffiti, criminal damage and threatening behaviour by these young people towards other law abiding members of the public.

The issue of child safety is also raised, in that alcohol acquired by young people illegally is often passed to even younger children and over indulged by all, thereby causing serious concern for health and safety.

There has also been intelligence to suggest staff are selling cigarettes to minors and paying paper boys in cigarettes. There are also concerns regarding the competence of staff working at the shop and issues with the CCTV system when officers have attended to download footage.

- 3. On Monday 14<sup>th</sup> December 2015 the premises passed a Test Purchase Operation.
- 4. On Wednesday 13th January 2016 the premises passed a Test Purchase Operation.
- On Wednesday 24<sup>th</sup> February 2016, Talat Nosheen ZAMEER (DPS) attended the Safeguarding in Licensed Premises Training provided by Sheffield Safeguarding Children Board, South Yorkshire Police and Trading Standards.
- Saturday 2<sup>nd</sup> July 2016
   Failed Test Purchase Operation
- 7. On Friday 8<sup>th</sup> July 2016 myself and Julie Hague visited the shop to discuss the latest Failed Test Purchase and check their policies/procedures.
- 8. On 22<sup>nd</sup> July 2016 the premises passed a Test Purchase Operation.
- 9. On 11<sup>th</sup> August 2016 the premises passed a Test Purchase Operation.
- 10. On 31<sup>st</sup> August 2016 the premises passed a Test Purchase Operation.
- 11. Friday 30<sup>th</sup> September 2016 Failed Test Purchase Operation
- 12. On 11<sup>th</sup> October 2016 SCC it was brought to my attention that the company who are named as Premises License Holders had been dissolved on 27<sup>th</sup> September 2016 and that they have until 27<sup>th</sup> October 2016 to submit a Transfer application to change the Premises License Holder. This transfer application was submitted later the same day and have now named the License Holder as NADEEM QAMAR. These are the same people who held it previously just in a name now rather than a Business.
- 13. On 20<sup>th</sup> October 2016, intelligence has been brought to my attention in relation to underage sales of cigarettes and that the paperboy at the shop has been paid with cigarettes. This information has been forwarded to the relevant authorities.
- 14. On 20th October the premises passed a Test Purchase Operation
- 15. There is also a history of recent incidents of Anti-Social Behaviour at the premises over the last 12 months, which I explain further in the chronology of ASB. This has also escalated into a rather costly Theft from the premises. This incident also highlighted an issue with access to CCTV at the premises.

#### Mandatory Condition 1 (Section 19 ss 2)

(c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;

(d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;

(e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).

- 2. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- 3.—(1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.

#### WITNESS STATEMENT OF

#### **Cheryl Topham**

I am the Licensing Enforcement Officer, employed by South Yorkshire Police currently based at Force Headquarters, Carbrook, Sheffield. I have been in my current role as Licensing Enforcement Officer for South Yorkshire Police for approximately 14 months. Due to A&E News failing three Test Purchase Operations within a twelve month period it has been necessary for South Yorkshire Police to submit an application to Review the Premises License. The premises has only had the premises license since 1<sup>st</sup> October 2015 and within this statement are records of all their Test Purchasing, Intervention and Intelligence. Although the three failed Test Purchases has prompted this review there are other issues at the premises including problems downloading CCTV and other intelligence relating to underage sales.

1 On Wednesday 4<sup>th</sup> November 2015 the premises failed a Test Purchase Operation. This was only one month after opening. The 15 year old volunteer was sold 3 cans of Fosters Lager by the owner of the shop, Nadeem QAMAR. A Fixed Penalty Notice of £90 was issued, Ref 0010850.

- 2 On Thursday 12th November 2015 myself and Julie Hague, Sheffield Safeguarding Children Board, attended the premises to speak to Mr Qamar or the DPS about the recent Test Purchase Failure. Mr Qamar was present but his wife, Talat Nosheen Zameer who is the DPS, was not. I gave him an Information pack which South Yorkshire Police put together and has lots of useful information to assist in training himself and his staff with regards avoiding underage sales. He was also given a template for a refusals log and also Challenge 25 posters which he didn't have at that time. He stated he did have a refusals book but it was in the back and he couldn't find it. He stated that his wife, The DPS, was responsible for ordering stock and hiring the staff. I explained that as she is the DPS he must make her aware we have attended, give her the information pack I had provided and they need to make every effort to ensure there aren't further failures. I explained the consequences of further failures such as prosecutions, voluntary closures and Reviewing the Premises License. Julie Hague also offered to send him the details of the Safeguarding in Licensed Premises Course which is run by Julie with the support of South Yorkshire Police and Trading Standards.
- 3 On Monday 14<sup>th</sup> December 2015 the premise passed a Test Purchase Operation.
- 4 On Wednesday 13<sup>th</sup> January 2016 the premises passed a Test Purchase Operation.
- 5 On Wednesday 24<sup>th</sup> February 2016, Talat Nosheen Zameer, DPS, attended the Safeguarding In Licensed Premises Training which Julie had offered to them.
- 6 On Saturday 2<sup>nd</sup> July 2016 the premises failed a Test Purchase Operation. The 15 year old volunteer was sold a 500ml bottle of Carling Peach Cider by shop assistant Kelly Ann Marshall and she was issued with a £90 Fixed Penalty Notice

along with a letter offering her the option to waiver the cost of the ticket and attend a training course instead. Marshall stated she had only been working at the shop for around one week and was still being trained. She said the owner, Mr Qamar, had left her alone in the shop while he went home to attend to another matter. The Police Officer also stated there were no Challenge 25 posters on display in the shop.

- On Friday 8th July 2016, myself and Julie Hague attended the shop in relation to 7 the Test Purchase Failure. We were greeted by Nadeem Qamar who explained Ms Marshall had only worked for him a week and this was the first time she had been left alone. He said he had trained her on all matters including age verification. I explained that if he had been there then possibly he would have questioned Ms Marshalls judgement before she made that sale. He said she had booked on the training course which was offered rather than paying full price for the ticket. He produced the Refusals log which did have some entries and it was Ms Marshall who had completed the last entry. Whilst there was still a lack of Challenge 25 posters, there was one on the door. However, I would have expected to see one at the counter and also around the alcohol section in the shop. Julie also offered the next Safeguarding course so he and Ms Marshall could attend. He questioned why he was being tested so frequently. I checked his record and could see this was the 4th time they had been tested in a 9 month period. He was adamant he had more Pass letters than this but could not show them to me. I yet again advised him of the consequences of further failures such as Voluntary Closure or Review of the License.
- 8 On Wednesday 22<sup>nd</sup> July 2016 the premises passed a Test Purchase Operation.
- 9 On Tuesday 11<sup>th</sup> August 2016 the premises passed a Test Purchase Operation.

- 10 On Monday 31<sup>st</sup> August 2016 the premises passed a Test Purchase Operation.
- 11 On Friday 30<sup>th</sup> September 2016 the premises failed a Test Purchase Operation. The volunteer who was under 18 was sold a 700ml bottle of Carte Reale Shiraz wine by shop assistant Kelly Ann Marshall and she was issued with a £90 Fixed Penalty Notice. This is the second time Marshall has sold on a Test Purchase Operation to a young person.
- 12 On 11<sup>th</sup> October 2016 it was brought to my attention that the company who were named as Premise License Holder, Nan Enterprises Ltd, had been dissolved on 27<sup>th</sup> September 2016. Emma Rhodes, Sheffield City Council Licensing Officer explained they would have until 27<sup>th</sup> October to submit a transfer application to appoint a new Premise License Holder. The transfer application was submitted later the same day and have now named the License Holder as Nadeem QAMAR. These are the same people who held it previously just in a name now rather than the business.
- 13 On 20<sup>th</sup> October, intelligence was brought to my attention in relation to the underage sales of cigarettes at the shop and that the paperboy at the shop was being paid with cigarettes. This is anonymous intelligence however has been forwarded to the relevant authorities.
- 14 Our police records also show there have been nine calls relating to Anti-Social Behaviour and crimes which are linked to ASB in a nine month period. I have devised a chronology of these incidents which is within these documents. Some of the calls are made by Mr Qamar and some are by customers. I also checked Police records as to whether other shops in the area all experience the same amount of ASB. There are two other shops/off licenses in the immediate area, one of them has 3 recorded incidents and the other has 2. These shops also get test purchased regularly and one last failed in 2012 and the other last failed in



2014. recently. There appears to be a link between the amount of Anti-Social behaviour A&E News are experiencing and the sales of alcohol to underage people.

#### Continuation of Statement of: Jason Booth

I can confirm that the effect of alcohol on young people is very detrimental not only to the young people themselves, but also the local community which is why, as an area, we place great emphasis on the importance of carrying out regular Test Purchase Operations. These are done with the aim of identifying premises who do not have stringent procedures and policies in place, which in turn ensure they are only selling alcohol to over 18s responsibly. Once identified we work with local partner agencies to offer support, advice and training to try and reduce the possibility of these premises committing the offence of underage sales again.

My enquiries have shown that A and E News, Mansfield Road have failed three test purchase operations since the initial failure on 4th November 2015. The premises have also passed five operations during this time. However I have genuine concerns with regards to the management of the premise and I am aware that licensing staff have met with them previously to highlight this along with arranging additional training.

I have also reviewed the anti social behaviour in and around this premises where I can see nine calls recordered on our system linked to this location. Five of these calls refer to problems with groups of youths/young people causing problems inside and outside the premises. I have checked another premise across the road also involved in the sale of alcohol and I can see that they have only note one such incident in the last twelve months.

As stated above the effects of alcohol on young people can lead to an increase in Anti-Social and criminal behaviour which negatively impacts on the local community. Therefore, I am keen to ensure that premises such as A and E News are made aware of the impact of their failure to prevent sales to underage people, and that in future they take all reasonable steps available to ensure that this does not happen again.



#### APPLICATION TO REVIEW THE PREMISES LICENCE: A&E NEWS, 128 MANSFIELD ROAD, SHEFFIELD S12 2AQ

I am writing to make a representation on behalf of the Safeguarding Children Board (SSCB) as the Responsible Authority for the protection of children from harm under the Licensing Act 2003. The reason for the representation is that the above premise has been evidenced to operate irresponsibly and as such undermines the core objective for the protection of children from harm, under the Licensing Act 2003.

The evidence submitted by South Yorkshire Police demonstrates that within the past 12 months, alcohol has been repeatedly sold to children. During test purchase operations, a 15 year old child was sold lager on 4<sup>th</sup> November 2015; a 15 year old child was sold cider on 2<sup>nd</sup> July 2016; and a bottle of wine was sold to a young person under the age of 18 on 30<sup>th</sup> September 2016.

The Safeguarding Children Board takes a serious view of premises that are evidenced to sell alcohol to children and young people. The risks of underage drinking are well established and include physical harm, vulnerability to criminals and perpetrators, disinhibited and anti-social behaviour.

In response to the failed test purchase operation on 4<sup>th</sup> November 2015, I visited the premises with Ms Topham of SY Police on 12<sup>th</sup> November 2015 and provided verbal advice to Mr Nadeem Qamar (the duty manager and husband of the DPS Mrs Talat Nosheen Zameer, who was not present). As there was a lack of signage and no evidence of a refusals or staff training log, I advised Mr Qamar that the age verification scheme must improve in order to protect children and young people and that all staff should be trained to implement the Challenge 25 scheme; Mr Qamar was handed a multi agency information pack by Ms Topham and we carefully explained how to implement the Challenge 25 scheme, maintain refusals records and

where to display signage. I also advised that the DPS and other such responsible supervisors should attend the next safeguarding training workshop which was in February 2016. A letter was subsequently sent to confirm this verbal advice and the offer of free training (Annex 1 refers).



On 24<sup>th</sup> February 2016, the DPS Mrs Nosheen Zameer, attended the multi agency safeguarding training.

In response to the second test purchase failure, on 2<sup>nd</sup> July 2016, I visited the premises on 8<sup>th</sup> July 2016 with my colleague Ms Topham of SY Police. Again, the DPS Mrs Zameer was not present at the shop and Mr Qamar was in charge. A discussion took place about the failed test purchase and Mr Qamar stated that this was due to a new member of staff who had, for the first time that night, been left alone in the shop. During this visit I noted that Mr Qamar was able to produce a refusals log and I observed there was one Challenge 25 sign on the door. I reiterated the importance of training all staff to enforce the age verification scheme, displaying public signage and the need to maintain staff training records, as none were available. I urged Mr Qamar to refresh staff training immediately and to ensure his staff attended the next available safeguarding training workshop. I verbally provided him with the date which was 12<sup>th</sup> October. This was followed up by a written advice and training offer letter (annex 2 refers). At this meeting Ms Topham advised Mr Qamar that in line with local multi agency protocols, another test purchase failure could result in a voluntary closure or review of the premises licence.

Despite advice and a second failed test purchase failure, no one from the premises attended the safeguarding training on 12<sup>th</sup> October.

I am aware that the premises has passed 5 test purchase operations, in the same 12 month timespan as the 3 failures. This suggests that although the age verification scheme does on occasion prevent sales, there is an inconsistency in the management and implementation of safeguarding procedures at the premises which, if it is not addressed, will continue to undermine the core objective for the protection of children from harm.

In light of the above, the Safeguarding Children Board would ask the Licensing Sub Committee to take positive action to address the safeguarding concerns presenting at this premise.

#### Right of attendance, assistance and representation

15. Subject to regulations 14(2) and 25, a party may attend the hearing and may be assisted or represented by any person whether or not that person is legally qualified.

## This procedure has been drawn up in accordance with the Licensing Act 2003 to assist those parties attending Licensing Committee hearings.

- 1. The hearing before the Council is Quasi Judicial.
- 2. The Chair of the Licensing Committee will introduce the Committee and ask officers to introduce themselves.
- 3. The Chair will ask the applicants and other parties to formally introduce themselves.
- 4. The Solicitor to the Committee will outline the procedure to be followed at the hearing.
- 5. Hearing Procedure:-
  - (a) The Licensing Officer will introduce the report.
  - (b) Questions concerning the report can be asked by Members the applicant and other parties.
  - (c) The Licensing Officer will introduce the applicant for review (or his/her nominated representative) who will be asked to detail the application.
  - (d) Members may ask questions.
  - (e) The Licensing Officer will in turn introduce representatives for the other Responsible Authorities and Interested parties who will be asked to detail their relevant representations
  - (f) Members may ask questions
  - (g) With the leave of the Chair the licensee or his representative may cross examine the representatives of the applicant for review and the other Responsible Authorities and Interested Parties.
  - (h) The licensee (or his/her nominated representative) will then be asked to respond to the application and to any other representations made.
  - (i) The licensee (or his/her nominated representative) may then be asked questions by members and with the leave of the Chair from the other parties present.
  - (j) The applicant will then be given the opportunity to sum up the application.
  - (k) The representatives of the Responsible Authorities will be given the opportunity to sum up
  - (I) The licensee will be given the opportunity to sum up
  - (m) The Licensing Officer will then detail the options.
  - (n) There will then be a private session for members to take legal advice and consider the application.
- 6. The decision of the Licensing Committee will be given in accordance with the requirements of the Licensing Act 2003 and regulations made there under.
- NB: 1) At any time in the Licensing Process Members of the Committee may request legal advice from the Solicitor to the Committee. This advice may be given in open session or in private.

#### ANNEX 1 - MANDATORY CONDITIONS

#### Mandatory Condition 1 (Section 19 ss 2)

Where a licence authorises the sale of alcohol then no supply of alcohol may be made under the premises licence -

- (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
- (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

#### Mandatory Condition 2 (Section 19 ss 3)

Where a licence authorises the sale of alcohol then every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

#### Mandatory Condition 3 (Section 20)

- 1. Where a premises licence authorises the exhibition of films, the licence includes the following conditions relating to the admission of children to the exhibition:
  - (a) The admission of children (under 18) to the exhibition of any film must be restricted in accordance with the classification set by the film classification body (currently the BBFC).
  - (b) In a case where there is no classification given by the classification body (the BBFC) the admission of children to the exhibition of any film must be restricted in accordance with any recommendation given by the Licensing Authority.
- 2. In this section -
  - "children" means persons aged under 18; and

"film classification body" means the person or persons designated as the authority under

section 4 of the Video Recordings Act 1984 (c.39) (authority to determine suitability of video works for classification).

#### Mandatory Condition 4 (Section 21)

Where a premises licence includes a condition that at specified times one or more individuals must be at the premises to carry out a security activity each such individual must be licensed by the Security Industry Authority.

#### Annex 1B - Mandatory Condition effective from 28th May 2014:

1. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

#### Annex 1C - Mandatory Conditions effective from 1st October 2014:

**1.-(1)** The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.

(2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises-

(a) games or other activities which require or encourage, or are designed to require or encourage, individuals to-

(i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised

to sell or supply alcohol), or

(ii) drink as much alcohol as possible (whether within a time limit or otherwise);

(b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;

(c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;

(d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;

(e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).

2. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.

3.-(1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.

(2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.

(3) The policy must require individuals who appear to the responsible person to be under

18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either-

(a) a holographic mark, or

(b) an ultraviolet feature.

4. The responsible person must ensure that-

(a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures-

(i) beer or cider: 1/2 pint;

(ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and

(iii) still wine in a glass: 125 ml;

(b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and

(c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

#### ANNEX 2 - CONDITIONS CONSISTENT WITH THE OPERATING SCHEDULE

- There shall be no adult entertainment or services, activities, other entertainment or matters 1. ancillary to the use of the premises that may give rise to concern in respect of children.
