ADVICE TO MEMBERS ON DECLARING INTERESTS AT MEETINGS

If you are present at a meeting of the Council, of its executive or any committee of the executive, or of any committee, sub-committee, joint committee, or joint sub-committee of the authority, and you have a **Disclosable Pecuniary Interest** (DPI) relating to any business that will be considered at the meeting, you must not:

- participate in any discussion of the business at the meeting, or if you become aware of your Disclosable Pecuniary Interest during the meeting, participate further in any discussion of the business, or
- participate in any vote or further vote taken on the matter at the meeting.

These prohibitions apply to any form of participation, including speaking as a member of the public.

You must:

- leave the room (in accordance with the Members' Code of Conduct)
- make a verbal declaration of the existence and nature of any DPI at any
 meeting at which you are present at which an item of business which affects or
 relates to the subject matter of that interest is under consideration, at or before
 the consideration of the item of business or as soon as the interest becomes
 apparent.
- declare it to the meeting and notify the Council's Monitoring Officer within 28 days, if the DPI is not already registered.

If you have any of the following pecuniary interests, they are your **disclosable pecuniary interests** under the new national rules. You have a pecuniary interest if you, or your spouse or civil partner, have a pecuniary interest.

- Any employment, office, trade, profession or vocation carried on for profit or gain, which you, or your spouse or civil partner undertakes.
- Any payment or provision of any other financial benefit (other than from your council or authority) made or provided within the relevant period* in respect of any expenses incurred by you in carrying out duties as a member, or towards your election expenses. This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992.

*The relevant period is the 12 months ending on the day when you tell the Monitoring Officer about your disclosable pecuniary interests.

- Any contract which is made between you, or your spouse or your civil partner (or a body in which you, or your spouse or your civil partner, has a beneficial interest) and your council or authority –
 - under which goods or services are to be provided or works are to be executed; and
 - which has not been fully discharged.

- Any beneficial interest in land which you, or your spouse or your civil partner, have and which is within the area of your council or authority.
- Any licence (alone or jointly with others) which you, or your spouse or your civil
 partner, holds to occupy land in the area of your council or authority for a month
 or longer.
- Any tenancy where (to your knowledge)
 - the landlord is your council or authority; and
 - the tenant is a body in which you, or your spouse or your civil partner, has a beneficial interest.
- Any beneficial interest which you, or your spouse or your civil partner has in securities of a body where -
 - (a) that body (to your knowledge) has a place of business or land in the area of your council or authority; and
 - (b) either -
 - the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or
 - if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you, or your spouse or your civil partner, has a beneficial interest exceeds one hundredth of the total issued share capital of that class.

If you attend a meeting at which any item of business is to be considered and you are aware that you have a **personal interest** in the matter which does not amount to a DPI, you must make verbal declaration of the existence and nature of that interest at or before the consideration of the item of business or as soon as the interest becomes apparent. You should leave the room if your continued presence is incompatible with the 7 Principles of Public Life (selflessness; integrity; objectivity; accountability; openness; honesty; and leadership).

You have a personal interest where -

- a decision in relation to that business might reasonably be regarded as affecting
 the well-being or financial standing (including interests in land and easements
 over land) of you or a member of your family or a person or an organisation with
 whom you have a close association to a greater extent than it would affect the
 majority of the Council Tax payers, ratepayers or inhabitants of the ward or
 electoral area for which you have been elected or otherwise of the Authority's
 administrative area, or
- it relates to or is likely to affect any of the interests that are defined as DPIs but are in respect of a member of your family (other than a partner) or a person with whom you have a close association.

Guidance on declarations of interest, incorporating regulations published by the Government in relation to Disclosable Pecuniary Interests, has been circulated to you previously.

You should identify any potential interest you may have relating to business to be considered at the meeting. This will help you and anyone that you ask for advice to fully consider all the circumstances before deciding what action you should take.

In certain circumstances the Council may grant a **dispensation** to permit a Member to take part in the business of the Authority even if the member has a Disclosable Pecuniary Interest relating to that business.

To obtain a dispensation, you must write to the Monitoring Officer at least 48 hours before the meeting in question, explaining why a dispensation is sought and desirable, and specifying the period of time for which it is sought. The Monitoring Officer may consult with the Independent Person or the Council's Audit and Standards Committee in relation to a request for dispensation.

1. APOLOGIES FOR ABSENCE

1.1 Apologies for absence were received from Councillors John Booker, George Lindars-Hammond, Helen Mirfin-Boukouris, Steve Wilson and Josie Paszek, with Peter Rippon attending as her substitute.

2. EXCLUSION OF PUBLIC AND PRESS

2.1 No items were identified where a resolution may be moved to exclude the public and press.

3. DECLARATIONS OF INTEREST

3.1 There were no declarations of interest.

4. MINUTES OF PREVIOUS MEETINGS

- 4.1 *10th November*, 2016
- 4.1.1 The minutes of the meeting of the Committee held on 10th November, 2016, were approved as a correct record.
- 4.2 1st December, 2016
- 4.2.1 The minutes of the meeting of the Committee held on 1st December, 2016 were approved as a correct record and, arising therefrom, Councillor Pat Midgley stated that, further to concerns expressed by some Committee Members at the meeting of the Healthier Communities and Adult Social Care Scrutiny and Policy Development Committee on 9th November, 2016, regarding the late circulation of the presentation on Shaping Sheffield The Plan, arrangements had been made for the Plan to be considered at a special meeting of the Committee, which had been held on 8th February. 2017.

5. PUBLIC QUESTIONS AND PETITIONS

- 5.1 There were no questions raised, or petitions submitted by members of the public.
- 6. REVENUE BUDGET AND CAPITAL PROGRAMME 2017/18

- 6.1 The Committee considered reports of the Acting Executive Director, Resources, on the Capital Programme 2017/18 and the Revenue Budget 2017/18, which were to be considered by the Cabinet on the afternoon of 15th February, 2017.
- 6.2 In attendance for this item were Councillor Ben Curran (Cabinet Member for Finance and Resources), Eugene Walker (Acting Executive Director, Resources), Dave Phillips (Head of Strategic Finance), Mike Thomas (Acting Assistant Director, Strategic Finance), Laura Pattman (Director of Business Strategy, Communities) and Paul Schofield (Finance and Commercial Services Business Partner).
- Dave Phillips introduced the Revenue Budget 2017/18 report, indicating that, as in previous years, following cuts in Government funding, producing a balanced budget had been a very demanding process. As part of the process, the Council had been forced to identify £40m savings, and deal with other issues, such as rising demand pressures, specifically relating to Adult Social Care. Mr. Phillips concluded by referring to the Council's unearmarked reserves, indicating that they were presently at a minimum level. In addition, the Council had earmarked reserves, which were all set aside for specific purposes.
- 6.4 Members of the Committee raised questions and the following responses were provided:-
 - Although the figure for gross business rate estimated income had reduced by approximately £5 million since 2016/17, this did not mean that the City's economy was shrinking, but was partly as a result of a number of successful appeals against the level of business rates, thereby resulting in a reduction in estimated income for the City. In addition, the national business rates revaluation had reduced the gross figure, although this was compensated for by additional grant income. The reduction in income in terms of business rates should not be confused with the economic performance of the City.
 - A key aim of the Better Care Fund was, through funding provided by the Council and the Clinical Commissioning Group (CCG), to provide improved community-based services, in order to reduce the numbers of people being unable to be discharged from hospital due to a lack of such services. It was hoped that savings would be identified which, in turn, would eliminate the need for this contribution after 2015/16. This had become a major issue nationally, and one which the Health Service had been attempting to remedy for some years, but, due to the increase in demand, savings had yet to be made. It was hoped that the Shaping Sheffield Plan would provide an opportunity in terms of identifying such savings.
 - Although a general Equality Impact Assessment (EIA) in terms of the Revenue Budget 2017/18 had been included in the report, attached at Appendix 9, the EIAs completed by Council Services for each budget-saving proposal had not been appended to the report, but a list of the EIAs was included in Appendix 9. They could be made available on request, and were also available on the Council website.
- 6.5 It was stated that some Members had faced difficulties in accessing the appropriate

links on the Council website in connection with the individual EIAs.

- 6.6 Dave Phillips also made reference to the report on the Capital Programme 2017/18.
- 6.7 RESOLVED: That the Committee:-
 - (a) notes the contents of the reports of the Acting Executive Director, Resources, on the Capital Programme 2017/18 and the Revenue Budget 2017/18, together with the comments made and the responses provided to the questions raised;
 - (b) expresses its thanks and appreciation to all officers, and Councillor Ben Curran (Cabinet Member for Finance and Resources), involved in producing a balanced budget for 2017/18;
 - (c) recommends that the reports of the Acting Executive Director, Resource, on the Capital Programme 2017/18 and the Revenue Budget 2017/18, respectively, be submitted to Cabinet without amendment; and
 - (d) in the light of the concerns raised with regard to the difficulties in accessing the links, on the Council website, to the individual Equality Impact Statements, requests the Head of Policy, Performance and Communications to attend a future meeting to provide an update on the new Sheffield City Council website, and report on this specific issue, as part of the update.

7. WORK PROGRAMME 2016/17

7.1 RESOLVED: That the draft Work Programme for 2016/17, set out in the report of the Policy and Improvement Officer now submitted, be approved.



Performance Overview


Key Performance Measures by Corporate Plan Priority

- The above chart shows the RAG rating of each of the measures within the priority areas.
- There was not much change in the overall ratings within the priorities between the end of 2015/16 and the end of 2016/17.
- The most notable changes were the increase in the number of green measures within 'In-Touch Organisation' (+4) and the increase in the number of No RAG measures in Better Health and Wellbeing (+3) and Tackling Inequalities (+3).





Exclusions - Primary




• The data for half-terms 1-4 shows that primary fixed term exclusions are similar to last year.




- The rate of permanent exclusion in primary schools slowed in the second term of the year, leading to a decrease on last year's rate of 0.046%.
- The rate of permanent exclusion among BME pupils has more than halved (0.031%) since HT 1-4 in 2015/16 (0.078%). The rate for White British pupils has increased from 0.029% to 0.046% over the same period.

 The rate of fixed-term secondary exclusion is still lower than last year, however the gap between the 2015/16 and 2016/17 rates decreased in the spring term.





- The rate of permanent exclusion in secondary schools has continued to rise.
- The positive trend for reducing BME exclusion has continued, falling from 0.515% (HT 1-4 2015/16) to 0.445% for the first two terms of the 2016/17 academic year. The proportion of permanent exclusions among white British pupils increased from 0.231% to 0.349% over the same period.


Educational Attainment Early Years Foundation Stage







- Sheffield's rank amongst other LAs for the EYFS attainment gap measure has improved markedly in 2016, from 114th to 78th.
- The attainment gap relates to the gap between the lowest 20% in Sheffield and the national median, which has improved by 9.7% points since 2013.
- The attainment gap within Sheffield is the same (31.6%), as the average score for all children is the same as the national median in 2016. This gap has fallen 6.2% points over the same period.

Educational Attainment Key Stage 1





- The attainment measures at KS1 changed in 2016, so the new rank is based on the percentage of pupils achieving the 'expected level' as opposed to level 2B+.
- The 2016 rank for writing is higher than in 2015, but Sheffield's relative position is similar to 2015 for reading and maths.
- There is a lot of variation in ranks at KS1 as the results tend to be tightly grouped. Over the past few years, however, reading has consistently been an area of weaker performance.






Educational Attainment Key Stage 2





- As with KS1, the measure used for the ranking has changed to the percentage of pupils achieving the 'expected level'.
- Based on this new measure,
 Sheffield's ranking has improved and the result is in the third quartile.
- The breakdown by subject indicates that reading is the area in which Sheffield pupils perform least well.
- Sheffield's results are in the third quartile for maths and between the third and fourth quartiles for writing.

Educational Attainment Key Stage 4







- Sheffield's ranking among other local authorities with regards the percentage of pupils achieving 5 or more A*-C grade GCSEs including English and maths has fallen by 7 places in 2016, resulting in a drop back into the fourth quartile.
- This performance is reflected in Sheffield's rank for the Attainment 8 score, which is a new measure calculated using the grades achieved across 8 qualifications.
- Sheffield performs more strongly in the Progress 8 score, which weights the Attainment 8 results on the basis of attainment at KS2, i.e. on average Sheffield pupils perform slightly better at KS4 than those who achieved similar results at KS2.

3. Take-up of Apprenticeships

Take-up of apprenticeships





- The percentage of 16-17 year olds taking up apprenticeships increased in the 2014/15 academic year and the higher rate was maintained last year.
- Figures up to March 2017 suggest that the results for this year will be similar.
- Sheffield had a higher proportion of 16-17 year olds taking up apprenticeships than the national average and the Core Cities as at June 2016, with the exception of Nottingham.
- Sheffield had the third highest rate of 16-17 year olds recorded as participating in some form of education or training (90.8% -June 2016) among the Core Cities, behind Leeds (92.9%) and Newcastle (91.2%).



- The rate of permanent admissions of older people to residential and nursing care homes in 2016/17 was 825 per 100,000, which falls just short of the Better Care Fund target of 823.9 per 100,000.
- This represents a fall of 10% on 2015/16









- The above measures are largely dependent on internal systems and processes and not the quality of the outcome.

Care and Support Delayed transfers of care




- 'Delayed transfers of care' continues to be a significant challenge.
- The rate at the end of 2016/17 is almost double that seen in 2015/16.





- The overspend for the year was £5.1m, which is the highest for three years.




Housing completions






- The number of housing completions had been recovering since the low in 2011/12.
- Student cluster flats account for 30 completions in 2015/16 compared to 116 in 2014/15.
- There were 997 studio or one bedroom flats proposed within schemes completed last year.
- If this is verified these, combined with the student clusters, account for 72% of the completions in 2015/16.
- Sheffield Housing Company completions were 87 (6%), meaning that 22% were houses and larger flats.
- The number of Sheffield Housing Company completions this year (87) is just above the target of 86.

Housing - planning




- The past three years has seen a significant improvement in the number of deliverable homes as a percentage of the 5-year housing supply.
- This figure includes different types of housing including student housing in and around the City Centre.
- The 128% figure in the chart equates to 9,820 units (not all of these have planning permission)
- There are 2,399 student cluster units with permission.
- There are 3,542 1-bed/studio flats with permission.
- The 5 year supply doesn't include non-student City Centre housing that the council doesn't have a firm start date for.
- There will be an impact on business rates in the City Centre if premises are converted into student accommodation.

Affordable Housing



- With the exception of 2014/15, the number of affordable homes built or acquired in Sheffield has been low and the total in 2016/17 (294) fell short of the target (362).
- Despite continued growth in the number of private housing completions in 2015/16, the number of affordable completions dropped back to 2013/14 levels.



6. Transport

Highways - user satisfaction





- The National Highways and Transport Network survey suggests satisfaction with the condition of highways in Sheffield increased between 2015 and 2016.
- Sheffield's result is below the average of the Councils that take part in the survey (approx. 38% satisfaction) and ranks 71st out of 106 authorities.
- Data for the other Core Cities is patchy, but Sheffield has a lower satisfaction percentage than those for which data is available: Leeds (40%), Bristol (47%) and Newcastle (46%).
- The action relating to the Streets Ahead programme is reporting as 'amber', with tree issues cited as the reason for falling behind. The extent of the delay is not clear, as data is unavailable.
- Sheffield performs better in terms of satisfaction with traffic levels and congestion, ranking 38th out of 106 participating authorities.
- Sheffield's result was above the average satisfaction for 2016 (45%), and better than Bristol (34%) and Leeds (46%), but lower than Newcastle (51%).

Modal split – walking and cycling




- The modal split survey, which measures the number of person trips by mode of transport, recorded a smaller proportion of people walking in 2016 compared to 2015
- This is the lowest proportion recorded since 2008.




- The longer-term trend of increasing cycling rates continued in 2016, but the rate is still very low.
- This element of modal split remains a significant challenge if we are to achieve the goal stated in the Corporate Plan of cycling accounting for 10% of all journeys by 2025.

Modal split – Motorised vehicles




 Based on the survey results, the percentage of people making journeys by public transport fell slightly in 2016, although this measure has been stable since 2011.




- The proportion of person trips made by car, taxi or motorcycle was higher in the 2016 survey compared to 2015.
- The overall trend is fairly stable, although the total number of journeys has been decreasing.

Bus Patronage



- The measure used by the service is based on the number of bus passengers in Sheffield over the course of a calendar year.
- The data indicates that bus patronage declined in 2016 and was well below the target of 59.09 million.
- The fall in bus patronage is typical of the trend in metropolitan areas, although Sheffield's drop of 2.3% in 2016 compared to 2015 is higher than the average of 1.4%.


Air quality



- The two measures for air quality currently monitored by the service are shown in the charts.
- They indicate that performance is on target.
- Given that air quality is considered a major challenge for the city, it is not felt that these measures adequately reflect the situation.
- Work is ongoing to review these measures, which are likely to be replaced with longer-term annual average readings.




Air quality – trends in NO₂



• The levels recorded by DEFRA's automated detector in Tinsley indicates a reduction in NO₂ in that part of the city in the region of 50% since the early nineties.



Visits to sporting venues and activities




- The number of visits per 1,000 population to sporting venues and activities has increased compared to last year and is the highest rate since 2013/14.
- The majority of the improvement seen is due to the addition of Graves and Thorncliffe Leisure Centres.

Visits to cultural venues




- The number of visits per 1,000 head of population to SCC cultural funded venues decreased in 2016/17 to the lowest rates for at least four years.
- There were reductions across many of the venues. The largest contributing factor to the decrease was a drop of around 18% in numbers to The Arena between 2014/15 and 2016/17.
- The Library Theatre is no longer included in the figures, however that would only account for around 10% of the decrease seen.
- With the exception of Q3, The Showroom had lower figures than expected amounting to a 13% decrease on 2014/15 numbers.
- 44% of all cultural visits are recorded as "Sheffield Galleries and Museums". Approximately three-quarters of this is made up of footfall counts to the Millennium Gallery.


Moor Markets



- Footfall to the Moor Markets has remained fairly stable since 2014.
- There was an increase in footfall in 2016 compared to 2015 of around 7% after a strong second six months of the year.
- Letting levels, after an initial drop in the first few months, have stabilised at around 80%.

Attracting income





- Whilst the estimated volume of delegates coming to conferences and events in Sheffield was at its highest level since 2008, the amount of spend associated with these was lower than the previous two years.
- This is likely to be due to a decrease in the average length of time spent here by each delegate, with fewer overnight stays.
- The Ambassador Programme has brought in a total of £21.6m to Sheffield in the past four years, through bookings for hotels, venues and travel.

Ability to Change / Impact

Priority should be given to issues that the Committee can realistically have an impact on, and that will influence decision makers;

Performance

Priority should be given to the areas in which the Council, and other organisations (public or private) are not performing well;

• **E**xtent

Priority should be given to issues that are relevant to all or large parts of the city (geographical or communities of interest);

• Replication / other approaches

Work programmes must take account of what else is happening (or has happened) in the areas being considered to avoid duplication or wasted effort. Alternatively, could another body, agency, or approach (e.g. briefing paper) more appropriately deal with the topic

Other influencing factors

- Cross-party There is the potential to reach cross-party agreement on a report and recommendations.
- Resources. Members with the Policy & Improvement Officer can complete the work needed in a reasonable time to achieve the required outcome
