ADVICE TO MEMBERS ON DECLARING INTERESTS AT MEETINGS

If you are present at a meeting of the Council, of its executive or any committee of the executive, or of any committee, sub-committee, joint committee, or joint sub-committee of the authority, and you have a **Disclosable Pecuniary Interest (DPI)** relating to any business that will be considered at the meeting, you must not:

- participate in any discussion of the business at the meeting, or if you become aware of your Disclosable Pecuniary Interest during the meeting, participate further in any discussion of the business, or
- participate in any vote or further vote taken on the matter at the meeting.

These prohibitions apply to any form of participation, including speaking as a member of the public.

You **must**:

- leave the room (in accordance with the Members' Code of Conduct)
- make a verbal declaration of the existence and nature of any DPI at any meeting at which you are present at which an item of business which affects or relates to the subject matter of that interest is under consideration, at or before the consideration of the item of business or as soon as the interest becomes apparent.
- declare it to the meeting and notify the Council's Monitoring Officer within 28 days, if the DPI is not already registered.

If you have any of the following pecuniary interests, they are your **disclosable pecuniary interests** under the new national rules. You have a pecuniary interest if you, or your spouse or civil partner, have a pecuniary interest.

- Any employment, office, trade, profession or vocation carried on for profit or gain, which you, or your spouse or civil partner undertakes.
- Any payment or provision of any other financial benefit (other than from your council or authority) made or provided within the relevant period* in respect of any expenses incurred by you in carrying out duties as a member, or towards your election expenses. This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992.

*The relevant period is the 12 months ending on the day when you tell the Monitoring Officer about your disclosable pecuniary interests.

- Any contract which is made between you, or your spouse or your civil partner (or a body in which you, or your spouse or your civil partner, has a beneficial interest) and your council or authority –
 - under which goods or services are to be provided or works are to be executed; and
 - which has not been fully discharged.

- Any beneficial interest in land which you, or your spouse or your civil partner, have and which is within the area of your council or authority.
- Any licence (alone or jointly with others) which you, or your spouse or your civil partner, holds to occupy land in the area of your council or authority for a month or longer.
- Any tenancy where (to your knowledge) –
 - the landlord is your council or authority; and
 - the tenant is a body in which you, or your spouse or your civil partner, has a beneficial interest.
- Any beneficial interest which you, or your spouse or your civil partner has in securities of a body where -
 - (a) that body (to your knowledge) has a place of business or land in the area of your council or authority; and
 - (b) either -
 - the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or
 - if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you, or your spouse or your civil partner, has a beneficial interest exceeds one hundredth of the total issued share capital of that class.

If you attend a meeting at which any item of business is to be considered and you are aware that you have a **personal interest** in the matter which does not amount to a DPI, you must make verbal declaration of the existence and nature of that interest at or before the consideration of the item of business or as soon as the interest becomes apparent. You should leave the room if your continued presence is incompatible with the 7 Principles of Public Life (selflessness; integrity; objectivity; accountability; openness; honesty; and leadership).

You have a personal interest where –

- a decision in relation to that business might reasonably be regarded as affecting the well-being or financial standing (including interests in land and easements over land) of you or a member of your family or a person or an organisation with whom you have a close association to a greater extent than it would affect the majority of the Council Tax payers, ratepayers or inhabitants of the ward or electoral area for which you have been elected or otherwise of the Authority's administrative area, or
- it relates to or is likely to affect any of the interests that are defined as DPIs but are in respect of a member of your family (other than a partner) or a person with whom you have a close association.

Guidance on declarations of interest, incorporating regulations published by the Government in relation to Disclosable Pecuniary Interests, has been circulated to you previously.

You should identify any potential interest you may have relating to business to be considered at the meeting. This will help you and anyone that you ask for advice to fully consider all the circumstances before deciding what action you should take.

In certain circumstances the Council may grant a **dispensation** to permit a Member to take part in the business of the Authority even if the member has a Disclosable Pecuniary Interest relating to that business.

To obtain a dispensation, you must write to the Monitoring Officer at least 48 hours before the meeting in question, explaining why a dispensation is sought and desirable, and specifying the period of time for which it is sought. The Monitoring Officer may consult with the Independent Person or the Council's Audit and Standards Committee in relation to a request for dispensation.

1. APOLOGIES FOR ABSENCE

1.1 Apologies for absence had been received from Councillors Vic Bowden, Mike Levery and Sioned-Mair Richards.

2. EXCLUSION OF PUBLIC AND PRESS

2.1 RESOLVED: That the public and press be excluded from the meeting before discussion takes place on item 7 on the agenda (Item 6 of these minutes), on the grounds that, if the public and press were present during the transaction of such business, there would be a disclosure to them of exempt information described in paragraphs 1, 2 and 3 of Schedule 12A to the Local Government Act 1972, as amended.

3. DECLARATIONS OF INTEREST

3.1 There were no declaration of interest.

4. MINUTES OF PREVIOUS MEETING

4.1 The minutes of the meeting of the Committee held on 21st January, 2020 were approved as a correct record.

5. ACTION TAKEN UNDER DELEGATED POWERS

5.1 The Committee noted that, since its last meeting, and following receipt of further evidence that had been requested from the appellants in respect of two cases, the Executive Director, People Services, in consultation with the Chair of the Committee, under powers delegated to him with regard to Home to School Transport Appeals, had agreed to grant home to school travel passes in both cases (Case Nos. AL/SA02 and AL/SA03).

6. SCHOOL ADMISSION REQUESTS - PRIMARY SCHOOL PLACES

6.1 The Executive Director, People Services, submitted reports and commented upon 37 cases where parents had expressed a wish for their children to be admitted to primary schools of their choice. The Executive Director stated that places in primary schools had been identified by the City Council, in accordance with the published admission criteria, and it had been agreed that the Executive Director would provisionally allocate places at those schools where there were places

available, up to the standard number/admission limit. The Committee was requested to consider prioritising the pupils on waiting lists, within their respective categories, for admission if and when places become available.

6.2 The committee were informed that one case had been withdrawn, as the place had been allocated (Case No.F21).

6.3 The Committee gave consideration to all the supporting evidence and information provided by the pupils' parents including, in some cases, evidence and advice provided by voluntary or professional bodies and organisations and, arising therefrom, it was:-

6.3 RESOLVED: That (a) 14 pupils be not prioritised on the waiting lists, within their respective categories, on the grounds that the Committee considers that there are no exceptional educational, financial, medical or family circumstances demonstrated (Case Nos. F2, F3, F5, F6, F8, F10, F12, F15, F16, F23, F25, F26, F31 and F36);

(b) seven pupils be prioritised at the top of the waiting list in the 'catchment' category on the grounds that there are exceptional family and/or medical circumstances (Case Nos. F9, F11A, F13, F14, F17, F18 and F33);

(c) five pupils be prioritised at the top of the waiting list in the 'sibling' category on the grounds that there are exceptional medical and/or family circumstances (Case Nos. F1, F22, F27, F34 and F35); and

(d) 10 pupils be prioritised at the top of the waiting list in the 'non-catchment' category on the grounds that there are exceptional family, medical and/or social circumstances (Case Nos. F4, F7, F11, F19, F20, F21A, F24, F28, F29 and F30).

(NOTE: In accordance with Council Procedure Rule 26 of the Council's Constitution and the provisions of Section 100B(4)(b) of the Local Government (Access to Information) Act 1985, the Chair decided that Case Nos. FT1 and FT2 be considered as matters of urgency in order for the requests to be considered at the earliest possible opportunity although it had not been possible to give five clear days' notice that the requests were to be considered.)

7. COUNCILLOR MICHELLE COOK

7.1 The Chair expressed his thanks on behalf of the Committee for all the hard work and support Councillor Michelle Cook, who had recently resigned from the City Council, had given to the Committee and wished her well for the future.

1. APOLOGIES FOR ABSENCE

1.1 An apology for absence was received from Councillor Peter Garbutt.

2. EXCLUSION OF PUBLIC AND PRESS

2.1 RESOLVED: That the public and press be excluded from the meeting before discussion takes place on item 5 on the agenda, on the grounds that, if the public and press were present during the transaction of such business, there would be a disclosure to them of exempt information described in paragraphs 1, 2 and 3 of Schedule 12A to the Local Government Act 1972, as amended.

3. DECLARATIONS OF INTEREST

3.1 There were no declarations of interest.

4. ACTION TAKEN UNDER DELEGATED POWERS

4.1 The Committee noted that, since its last meeting, and following receipt of further evidence that had been requested from the appellants in respect of 12 cases with regard to Primary School Admissions, and one case relating to a Home to School Transport Appeal, the Executive Director, People Services, in consultation with the Chair of the Committee, under powers delegated to him had determined that:-

- (a) two pupils be prioritised within their admissions category of “non-catchment” prior to the allocation of places, on the grounds that there are exceptional family circumstances (Case Nos. M20 and M3);
- (b) eight pupils be not prioritised prior to the allocation of places as no exceptional circumstances were demonstrated (Case Nos. M1, M23, M8, M16, M17, M22, MB1 and HB1);
- (c) one pupil be prioritised on the top of the respective waiting list

in the “sibling” category on the grounds that there are exceptional family circumstances (Case NE1);

- (d) one pupil be not prioritised on the non-catchment waiting list as there were no exceptional circumstances demonstrated (BE1);
- (e) information submitted by the parents of two pupils be considered by the Admissions Committee at a subsequent meeting, where the Committee will decide whether to authorise a fresh application and waiting list prioritisation; and
- (f) the home to school travel pass be granted (Case No. S/D03).

5. SCHOOL ADMISSION REQUESTS - PRIMARY SCHOOL PLACES

- 5.1 The Executive Director, People Services, submitted reports and commented upon two cases (B1 and B2) where parents had expressed a wish for their child to be admitted to a primary school of their choice. The Executive Director stated that places at the primary school had been allocated on the 16th April national allocation date by the City Council, in accordance with the published admission criteria.
- 5.2 The Committee gave consideration to all the supporting evidence and information provided by the pupils’ parents, including medical evidence. The Committee was asked to consider whether there were any significant and material changes in the circumstances of the families, since the original applications were made, to authorise that a fresh application be made, which would allow a fresh right of appeal for the school and also, based on the information provided, to prioritise on the waiting list for the School, and, arising therefrom, it was:-
- 5.3 **RESOLVED:** That upon consideration of the cases, and with due regard to the additional information now submitted, the Committee considers that there has not been material changes in the families’ circumstances in the cases (Case Nos. B1 and B2) and therefore (a) refuses to grant fresh applications and (b) determines that the pupils be not prioritised on the waiting lists, within the non-catchment category, on the grounds that the Committee did not consider that there was compelling evidence to place the pupils above other children in their admission category.
