# MONTH 03 2017/18 CAPITAL APPROVALS

### 1. SUMMARY

- 1.1 A number of schemes have been submitted for approval in line with the Council's capital approval process during the Month 3 reporting cycle. This report requests the relevant approvals and delegations to allow these schemes to progress.
- 1.2 Below is a summary of the number and total value of schemes in each approval category:
  - 8 additions of specific projects to the capital programme (including 1 feasibility funding request over £100k and therefore requiring cabinet approval) with a value of £2.4m.
  - 10 variations to the capital programme creating a net increase of £1.7m
- 1.3 Further details of the schemes listed above can be found in Appendix 1 and Appendix 1a.
- 1.4 Appendix 1a is a closed appendix due to commercial sensitivity of this item.

### 2. WHAT DOES THIS MEAN FOR SHEFFIELD PEOPLE

2.1 The proposed changes to the Capital programme will improve the recreational leisure facilities, schools, roads and homes used by the people of Sheffield, and improve the infrastructure of the city council to deliver those services.

### 3. BACKGROUND

This report is part of the monthly reporting procedure to Members on proposed changes to the Council's capital programme.

### 4. OUTCOME AND SUSTAINABILITY

4.1 By delivering these schemes the Council seeks to improve the quality of life for the people of Sheffield.

- Approve acceptance of the grant agreements listed in Appendix 2.
