Purpose of Report:		
To award Zest (Netherthorpe and Upperthorpe Community Alliance, trading as Zest) a grant of £10,000 per year from the BME Older People's Fund 2017-20 in compliance with the September 2016 Grant Aid Cabinet Report.		

Recommendations:

To award Zest (Netherthorpe and Upperthorpe Community Alliance, trading as Zest) a grant to deliver activities that support BME older people to be independent, safe and well connected into communities. The partnership will be awarded £10,000 per year from 2017/18 to 2019/20. The total award therefore being £30,000.

1. PROPOSAL

- 1.1 To award Zest a grant of £10,000 per year for three years to deliver a project to deliver empowering information and advice amongst BME Older People to reduce loneliness and isolation and improve health outcomes.
- 1.2 This application initially could not be funded by the grant panel that considered applications to the BME Older People's Fund because the fund was over-subscribed. However, due to an underspend in the Tackling Inequalities fund the panel has chosen to fund this comparatively small, high quality application by moving an additional £10,000 per year into the fund. The cabinet report allows for movement of money between the grant aid funds.
- 1.3 The grant will deliver a project called, Community Conversations activities supporting older women from Black and Minority Ethnic communities to make connections and improve their health literacy.
- 1.4 The project will work with isolated older women from BME communities living in Netherthorpe, Upperthorpe, Langsett and Burngreave. In Netherthorpe / Upperthorpe / Langsett the older women are predominantly from the Yemeni community and in Burngreave they are predominantly from the Pakistani community.

2. HOW DOES THIS DECISION CONTRIBUTE?

2.1 The BME Older People's Fund is for community based activity that helps to deliver the Council's People Keeping Well outcomes for BME Older People. Past experience indicates that Lunch Clubs have not always worked for all BME communities and this fund is to give BME VCF organisations that chance to try different activities that will still reduce loneliness and isolation and help people to make new friends and connections. The application process asked groups to demonstrate how their proposed activities would deliver the outcomes of Local Inform & Advise and Asset Based Community Development.

3.1 Proposals in the September 2016 cabinet report for the BME Older People's Fund grants were consulted on in summer 2016.

4.1 Equality of Opportunity Implications

4.1.1 An EIA was completed for these proposals in September 2016. BME Older People's Fund grant recipients are required to complete diversity monitoring so that the impact of the grant award can be understood over time.

4.2 Financial and Commercial Implications

4.2.1 The amount awarded of £10,000 per year 2017/18 to 2019/20 (total £30,000) is within the available grant aid budget and in compliance with the September 2016 Cabinet Report. The initial budget for the BME Older People's Fund was £30,000 per annum but an additional £10,000 per annum has been added to the fund to cover the cost of this project. The overall total for grant aid still falls within the agreed amount in the cabinet report.

4.3 <u>Legal Implications</u>

- 4.3.1 The legal power for the Council to establish, administer and make awards from the various grant funds as described in this report is provided by the general power of competence contained in Section 1 of the Localism Act 2011. The Council must mindful of the requirements imposed by the public sector equality duty enacted in Section 149 of the Equality Act 2010.
- 4.3.2 The BME Older People's Fund has been set up in compliance with the cabinet report recommendations at section 1.8.3 of the September 2016 Grant Aid cabinet report. All the grant recipients will be issued with agreements that contain the relevant Sheffield City Council Terms & Conditions for such awards.
