PROPOSAL

- 1.1 The report seeks agreement for the site of the former Hazelbarrow Primary School, shown in the accompanying site plans, to be declared surplus as it is not required for the education function for which it is held and is not required by the portfolio for the delivery of any other services
- 1.2 The School closed in 2003 as part of the South Sheffield Primary reorganisation programme and the buildings were demolished. The site has not been used for the purposes of a school or academy since then and is longer required for education provision.
- The Executive Director is asked to declare the site surplus to requirements so that it may be disposed of in accordance with the Council's Disposals Framework Policy.

2. HOW DOES THIS DECISION CONTRIBUTE?

2.1 The decision will enable the disposal of the site to meet corporate priorities. This will support the efficient use of resources in line with the corporate approach to managing SCC assets.


6. REASONS FOR RECOMMENDATIONS
