Sheffield City Council Drivers' Survey – Vehicle Registration No.

Your vehicle was recently seen passing through the Wicker Bus Gate in Sheffield, on Wednesday 3rd June at approximately hours and then turning left onto the new section of Ring Road (Derek Dooley Way, A61).

Whilst these manoeuvres are illegal, we will take no further action in this particular instance.

Rather, we would like to understand why you entered the bus gate in the first instance (for which you could be issued with a fine for $\pounds 60$) and then turned left onto the Ring Road, an illegal manoeuvre (for which you could receive 3 penalty points on your licence and a Police fine for a further $\pounds 60$). The left turn here onto the Ring Road greatly concerns us, as drivers turning left risk driving into pedestrians legitimately crossing the Ring Road on a 'green man'.

The Council does not wish to see drivers fined, or have penalty points put on their licences. Nor do we wish to see pedestrians put at risk and injured. The signing and road markings at this bus gate are similar to other locations, yet we appear to have more drivers passing through this bus gate than elsewhere and we should therefore like you to help us understand better why these restrictions were not adhered to by the person driving your vehicle.

We have no way of knowing who has completed and returned a questionnaire (please return by 12 July 2009) so please be totally honest.

If you, or whoever was driving, made a genuine mistake and didn't see signs then say so. If you knew that it was illegal to enter the bus gate and turn left, then please say so – perhaps explaining why you felt it safe to undertake this manoeuvre.

We need as many questionnaires as possible to be returned. It will only take a few minutes of your time and a prepaid envelope is enclosed – no stamp is necessary.

Thank you for your valued assistance in this matter and once again please be assured that, <u>in this instance only</u>, no further action will be taken. However you should be aware that enforcement of both restrictions is frequently carried out.

A leaflet showing details of the new routes available in the Wicker is enclosed. It may help you to refer to the "Getting to the Wicker area by car" part of the leaflet, which shows the Wicker crossing the Inner Ring Road (Derek Dooley Way) and the bus gate. The leaflet may also assist you to find your way around the City Centre in the future.

Occasionally, number plates can be mis-read. If you believe this to be the case in this instance, please take no further action.


