1. APOLOGIES FOR ABSENCE

Apologies for absence were received from Councillors Sylvia Anginotti, John Knight, Qurban Hussain, Diane Leek, Peter Moore and John Robson.

On behalf of the Council, the Lord Mayor (Councillor Sylvia Dunkley) passed on the Council's best wishes to those Members of the Council who were absent due to illness.

2. COUNCILLOR RAY SATUR MBE

The Lord Mayor (Councillor Sylvia Dunkley) reported that Councillor Ray Satur had been awarded an MBE for services to Local Government and, on behalf of the Council, passed on congratulations to Councillor Satur.

3. DECLARATIONS OF INTEREST

Councillor Ray Satur declared a personal interest in respect of the public question submitted, relating to the 120 bus service as he is an employee of First Bus, Sheffield.

4. MINUTES OF PREVIOUS MEETINGS

RESOLVED: On the Motion of Councillor Pat Midgley, seconded by Councillor Mick Rooney, that the minutes of the annual meeting of the City Council held on 18th May 2011, and the ordinary meeting held on 1st June 2011, be approved as a correct record.

5. PUBLIC QUESTIONS AND PETITIONS

5.1 Petitions

(a) Petition opposing a Planning Application made by Mylnhurst School

The Council received a petition, containing 147 signatures, objecting to a planning application by Mylnhurst School (Application No. 11/01623/FUL).

Representations on behalf of the petitioners were made by Andy Mills who stated that residents on Woodholm Road had expressed concern as the growth of non-school related activities at Mylnhurst School. Particular reference was made to the development of a swimming pool and multi use sports hall and associated increase in traffic and noise, particularly outside of normal school hours. The most recent planning application was for the demolition of an existing nursery and its replacement with a larger building together with additional access to the school site. Mr Mills stated that the consultation undertaken by the school had been limited. Whilst residents of Woodholm Road had no objection in principle to the renewal of the existing nursery building on the site, there was widespread opposition to the construction of a two lane access road through protected woodland and the associated increase in traffic which might worsen congestion and parking difficulties in the area. There was also concern that the facilities would

develop into a round the clock commercial sports facility and nursery.

The Council referred the petition to the Cabinet Member for Business, Jobs and Growth (Councillor Helen Mirfin-Boukouris) who expressed thanks to the petitioners for raising their concerns. She stated that she understood the concerns relating to the loss of trees and those related to noise, highways and safety and the usage of the school site. The planning application would be considered by the Council's City Centre, South and East Planning and Highways Committee. Councillor Mirfin-Boukouris stated that she would speak to relevant Council officers to look at whether a planning site visit could be arranged.

(b) Petition relating to Callow Towers CCTV and Security

The Council received a petition, containing 642 signatures, requesting closed circuit television (CCTV) and other security measures at Callow Towers.

Representations on behalf of the petitioners were made by Sally Kilic who referred to the need to install CCTV in Callow Towers, improve the lighting and enhance community safety. She stated that the Gleadless Valley area was a picturesque and welcoming estate and that crime levels had fallen and there were many good people living in the area. She referred to the tragic murder of a resident at Callow Mount, Zabihullah Rafiq and stated that residents would feel safer when leaving their homes if additional security was provided. She appealed to the Council to help people in the Gleadless area walk safer in their own shoes.

The Council referred the petition to the Cabinet Member for Homes and Regeneration (Councillor Harry Harpham). Councillor Harpham stated that he agreed that Gleadless Valley was a wonderful place and there were many wonderful people living there. He referred to his recent visit to Gleadless Valley and the opportunity to meet local people and witness some of the commendable work being undertaken by both Sheffield Homes and tenants. However, he acknowledged that there was a lot more to do. He expressed condolences to Mr Rafiq's family.

Councillor Harpham stated that he was aware how important it was for people to feel safe in their communities and commented that community safety was an important matter for the City Council. He referred to a previous application for funding to help address problems of anti-social behaviour in the Gleadless Valley which had been turned down by the Government. However, he stated that he would work closely with Council officers to try to identify resources to address the problems outlined by the petitioners relating to community safety, although he acknowledged that it was not easy to find money at this time and he could make no promises.

(c) Petition objecting to the Closure of National Westminster Bank Branches

The Council received a petition, containing 471 signatures, objecting to the proposed closure of the NatWest Bank branch offices at Highfield, Bradway

and Earl Street in the City Centre.

Representations on behalf of the petitioners were made by David Astle who stated that the petitioners were objecting strongly to the closure proposed by the NatWest Bank of its Bradway branch and asking the bank to reconsider its decision and allow the branch to remain open. He stated that the nearest bank was two miles away and closure of the Bradway branch would also affect other local retailers. It was not felt that the bank has considered the needs of elderly and disabled people in the Bradway area. The nearest alternative NatWest branch was three miles away, on a gradient and those such as himself using a disabled persons' scooter did not have the option of driving or access to local transport to use banking services or to obtain cash. It was considered that there had been a lack of consultation and that the decision to close the branch was contrary to the Bank's national advertising campaign which portrayed a caring and helpful service.

The Council referred the petition to the Cabinet Member for Business, Jobs and Growth (Councillor Helen Mirfin-Boukouris) who thanked the petitioners for bringing this to the Council's attention. She stated that it was unfortunate that the NatWest Bank was taking a decision to close local branches. She understood that NatWest had based their argument for closure as part of their cost savings and restructuring, but a balance of this with local needs was important. This also linked to the need for thriving local centres. She stated that she would write to the NatWest Bank stating the importance of local branches to the community and asking them to reconsider their decision with regard to the proposed closure of local branch offices.

(d) Petition requesting Traffic Calming Measures on Tadcaster Road

The Council received a petition, containing 50 signatures, requesting traffic calming measures on Tadcaster Road.

Representations on behalf of the petitioners were made by Cerys Frobisher who stated that the main objective of the petition was to slow traffic on Tadcaster Road for the safety of residents. She made reference to a head on collision and many near misses. A series of traffic calming measures was required to make it safer for residents, including older and younger people, to cross the road. Reference was made to a blind corner at the top of the road where vehicles often met and to parking on the sides of the highway which made it difficult to pass in places. Speeding vehicles came off Chesterfield Road and needed to be slowed down and there had been an increase in the number of vehicles using the route to avoid Chesterfield Road. There were also examples of vehicles contravening a no entry sign and people were concerned that, if no action was taken, there would be a serious accident or fatality.

The Council referred the petition to the Cabinet Member for Environment and Transport (Councillor Leigh Bramall) who referred to a previous request regarding this matter, which was being considered by the South Community Assembly. He stated that the Council would make contact with the petitioners following the Community Assembly's consideration of the matter.

(e) Petition objecting to the Loss of the Bus Service No. 120 to the Westminster Estate, Lodge Moor

The Council received a petition, containing 567 signatures, objecting to the loss of a bus service to the Westminster Estate, Lodge Moor.

Representations on behalf of the petitioners were made by Nancy Grayson who stated that many people living on Hallam Grange Road, Westminster Estate, Redmires Road, Crimicar Lane and surrounding areas did not have private transport and many within the area were over 70 years of age. The bus service was a vital asset and lifeline to those people and provided transport to the Royal Hallamshire and Northern General Hospitals. The service also enabled people to access Fulwood village shops and allow them to maintain their independence. People had been advised to use the 51 bus although that did not go to the hospital and was only accessible by crossing busy roads. This was particularly difficult for people using walking sticks or wheelchairs or those who were visually impaired. The alternative 40 bus service was also a considerable walk from to Lodge Moor.

The 120 bus service was considered a valuable service to people living in the area and it was noted that when First Bus withdrew their buses, Stagecoach had managed run some buses to the area. The 120 bus also enabled people to travel without having to change in the City Centre.

The Council referred the petition to the Cabinet Member for Environment and Transport (Councillor Leigh Bramall) who stated that he had sympathy for the petitioners and had spoken to the local Ward Councillor (Councillor John Knight) regarding this issue. He stated that this matter related in part to the Bus Partnership Agreement of which the 120 service was part of a trial. Councillor Bramall stated that, whilst he was generally in favour of the Bus Partnership Agreement, he was not supportive of any resultant disruption to passengers. He stated that he would bring this matter to the attention of the South Yorkshire Integrated Transport Authority.

(f) Petition requesting a Balanced Community in the Ecclesall Road District Centre

The Council received a petition, containing 355 signatures, requesting a balanced community in and around the Ecclesall Road district centre.

Representations on behalf of the petitioners were made by Janet Andrews who stated that the petition was being submitted on behalf of residents' groups around the Ecclesall Road district centre. The petition asked the Council to help maintain the balance of the community and, in particular, to introduce a planning policy which would require bars, restaurants and takeaways to close by 11.30 pm. She referred to the wide variety of residents, including elderly people in sheltered flats, families with young children, working people and students, and stated that many students also signed the petition. At present, there was a reasonable balance between the interests of businesses and the residents, although some problems did arise

such as noise, litter, broken glass and vomit on the pavement. Visitors to bars and restaurants also parked on residential streets and, when they returned to their vehicles, created noise. Residents were concerned that bars, restaurants and takeaways repeatedly challenged the opening times granted to them by Planning and if extensions to opening times were allowed it would adversely affect residents' quality of life and their ability to sleep. Each time there was an individual planning application, residents were required to ask the Planning Committee to maintain a balance of the community. It was considered that a clear planning policy would help stop applications to extend opening hours and would save considerable time and effort. Janet Andrews also referred to the close proximity between residents and businesses and that, although one side of Ecclesall Road was designated a residential area, the other side consisted of businesses. In the City Centre the Council had a night-time uses policy to protect residents' amenity and it was thought appropriate for Ecclesall Road to be granted similar protection.

The Council referred the petition to the Cabinet Member for Communities (Councillor Mick Rooney) who stated that part of his portfolio as a Cabinet Member was responsibility for Thriving District and Local Communities Strategy, and that he was aware of the tensions referred to by the petitioners and the demands of permanent and non-permanent members of the community. He stated that a way needed to be found of keeping the balance between residents and businesses and he stated that the Thriving District and Local Communities Strategy would require cross Cabinet working.

The Leader of the Council (Councillor Julie Dore) stated that the Council would look at the matters raised by the petitioners, particularly in relation to planning and licensing, and respond accordingly.

5.2 Public Questions

(a) Public question concerning Homelessness

Peter Chapman expressed concern at increasing levels of homelessness. He stated that, in the past four months, 240 families had received Court Orders seeking possession and there had been 605 repossessions in the City. Family circumstances affected people's position in relation to accommodation and he noted that many housing providers were not tolerant in their attitude towards single people. He asked the Council to look at its housing strategy and priorities in relation to homelessness.

In response, the Cabinet Member for Homes and Regeneration (Councillor Harry Harpham) indicated that homelessness was the subject of a Notice of Motion at this meeting of Council and this was a demonstration that the Council took the issue very seriously. He stated that it was concerning that there had been an increase in homelessness estimated at 30% since 2010, and those figures only included households accepted as being in priority need. It did not count rough sleepers, people with short term arrangements and those in bed and breakfast accommodation, and therefore it potentially underestimated the scale of the problem. He stated that he feared the difficulties would worsen due to changes in welfare provision, especially those

relating to housing benefit. He stated that the Council was working to try and prevent homelessness and noted that 10th October would be designated World Homeless Day. The Council's Safer and Stronger Communities Scrutiny Committee would be requested to examine the lettings policy, the availability of housing and the housing register. The Council wished to see a fair lettings policy and, as part of the examination of the lettings policy, tenants' associations would be requested to make their views known. He stated that fundamentally, there was not enough housing in the City. Councillor Harpham stated that he would keep the questioner informed of progress in relation to this matter.

(b) Public question concerning Parking on Skelwith Drive

Albert Meeds referred to problems with regard to parking on Skelwith Drive. He stated that pedestrians, including children, had to walk in the road because cars were partially parked on the pavement. Waste collection vehicles were sometimes unable to access the top of the road and the Fire Service had not been able to access a fire hydrant to check it. This was a safety concern and he requested that a visit be made to the area in question.

Mr Meeds also stated that Skelwith Drive was built at the bottom of Sandstone Hill and the rainwater runs down the sides of the road. When the rain stops, it caused damage to the underside of the pavement asphalt which dries out and additional dust is blown into houses by the wind.

In response, the Cabinet Member for Environment and Transport (Councillor Leigh Bramall) stated that where there were parking restrictions on the highway, for example on yellow lines, the City Council could take action. However, where there were no such restrictions this could become a Police matter. Councillor Bramall stated that he would request that a visit be made to Skelwith Drive to look at the particular circumstances at that location as regards parking. In relation to dust and erosion, he stated that the Highways Private Finance Initiative (PFI) would improve the City's highways to a minimum standard, which it was hoped would address the problems outlined.

(c) Public questions concerning Sheffield Homes and Openness and Transparency

Martin Brighton referred to a City-wide consultation meeting of customers of Sheffield Homes and, in reference to the minutes of that meeting, stated that the phrase 'co-ops' had been used, which he believed was a version of stock transfer. He asked if the Council could reassure clients of Sheffield Homes that no stock transfer means exactly that?

Secondly, he referred to the five day pre-meeting limit for asking questions of Sheffield Homes and asked if the Council could comment on what it expects of its wholly owned subsidiary in terms of adhering to Council policies.

Thirdly, he asked what the Council expected in terms of openness and transparency towards its citizens. Finally, he referred to people in groups within communities 'doing the Council's bidding' and claiming to speak for the

community and Sheffield Homes and the Council wrongly claiming to have engaged in meaningful consultation. He asked if the Council would put a stop to this practice and reassure people that it would not happen.

In response, the Leader of the Council (Councillor Julie Dore) stated that with regards to housing stock transfer and the views expressed by herself as Leader and the Cabinet Member for Homes and Regeneration (Councillor Harry Harpham) at the City-wide consultation meeting, it did mean that there would be no stock transfer. The reference to co-operatives was with regard to management cooperatives, which were a model of governance.

Secondly, in relation to Sheffield Homes' policy, Councillor Dore stated that she shared some concerns in relation to the governance of Sheffield Homes and how the Council's interests were represented on Sheffield Homes' Board through the Board of Directors. There were two Members of the City Council now appointed to that Board, who would ensure that the Council's interests were represented and the appropriate policies applied.

Thirdly, Councillor Dore stated that the Council aimed to answer all questions, although there may be occasions when it may not be possible to give an immediate answer and these would be followed up in writing as appropriate. There might be some restrictions on the answers to questions owing to confidentiality, data protection or contractual information for example. Fourthly, with regard to the treatment of community representatives and volunteers, Councillor Dore stated that, whilst she was not aware of the particular circumstances which Mr Brighton was referring to, all representatives of the community or volunteers should be treated with courtesy and respect.

Councillor Harry Harpham (Cabinet Member for Homes and Regeneration) stated that stock transfer would not be considered as an option. Decisions would be made together with tenants and stock transfer was not the present Administration's preferred option and he did not consider that it was the preferred option of tenants either. With regard to the five days notice for questions to Sheffield Homes, he did not consider that this was acceptable and he had informed the Chief Executive of Sheffield Homes accordingly. Such a time limit was not applied to City Council meetings, including Planning Committees, Scrutiny Committees and Community Assemblies and this practice should also apply to Sheffield Homes.

6. ORDER OF BUSINESS

RESOLVED: On the Motion of Councillor Colin Ross, seconded by Councillor Pat Midgley, that in accordance with Council Procedure Rule 11(A)(vii), the Council do now proceed to the consideration of the item of business numbered 14 on the Council Summons.

7. PROPOSED CLOSURE OF BRANCHES OF NATWEST BANK

RESOLVED: On the Motion of Councillor Colin Ross, seconded by Councillor Keith Hill, that this Council:-

- (a) opposes the proposal by NatWest Bank to close local branches at Highfield, Bradway and Earl Street in the City Centre;
- (b) believes that the withdrawal of local banking services goes against this Council's policy of Thriving District and Local Centres;
- (c) is disappointed that NatWest are yet to provide a full and transparent rationale for the grounds for closure in each case;
- (d) notes that the withdrawal of these banking services will leave many residents with an unacceptable distance to an alternative local branch, which will prove particularly difficult and expensive for elderly residents on a low income;
- (e) urges that NatWest, which is a majority state owned bank, urgently reconsider their proposal and keep these three local branches open;
- (f) in the meantime, urges NatWest to extend its proposed closure date so that its customers can be properly notified and consulted; and
- (g) directs that a copy of this motion is sent to the relevant authorities within NatWest and the Secretary of State for Business, Innovation and Skills.

10. ANNUAL REPORT OF THE LORD MAYOR 2010/11

- 10.1 The Council received the annual report of the Lord Mayor (Councillor Alan Law) on his year of office 2010-2011. Council noted the report and thanked Councillor Alan Law for his report.

11. PETITION – BIRCH AVENUE AND WOODLAND VIEW CARE HOMES

- 11.1 The Council received a verbal report by the Chair of the Healthier Communities and Adult Social Care Scrutiny Committee (Councillor Clive Skelton) upon the outcome of the Scrutiny Committee's consideration of the proposed closure of Birch Avenue and Woodland View Care Homes, which had been the subject of a petition and debate at the meeting of the Council held on 6th April, 2011. Councillor Skelton reported that a special meeting of the Scrutiny Committee had taken place on Monday, 4th July, 2011 and, at that meeting, Members of the Committee recognised that the current arrangements for funding relating to both Homes were unsustainable and changes were required to the admissions criteria. The consultation exercise undertaken by NHS Sheffield had highlighted the areas of specialist care which additional funding had been paying for, in the form of top up funding of £2.8m and the value for money represented by this additional investment. Without the care homes, there would be no dedicated facility to provide for dementia care and enhanced care in particular.
- 11.2 The Scrutiny Committee recommended to the NHS Sheffield Board that a commitment be made to all current residents to offer an option to remain in the homes and that enhanced criteria for admissions be developed in line with proposals in option 2 of the paper being considered by NHS Sheffield Board. The Scrutiny Committee also recommended that the option of developing the two care homes into centres of excellence be pursued, to ensure a co-

ordinated approach to the quality of universal dementia care in the City. Councillor Skelton also noted that the two care homes had the lowest admission to acute or hospital care of similar homes in the City. He also stated that NHS Sheffield had made a brave decision in agreeing to make changes to the contract arrangements for the two care homes. He thanked the consultation group, residents and carers for all of their efforts and said that this was an example of the local authority and NHS working together to achieve an improved outcome.

- 11.3 Councillor Ibrar Hussain (Deputy Chair) of the Healthy Communities and Adult Social Care Scrutiny Committee) added his thanks to the campaign group and NHS Sheffield for agreeing to reconsider its decision. Councillor Mary Lea (Cabinet Member for Health, Care and Independent Living) thanked all of those involved and especially the campaign group. She paid special thanks to the Scrutiny Committee and to the NHS Sheffield Board for listening and looking at these homes and their capacity in the City.
- 11.4 The Council noted the report and congratulated the Scrutiny Committee for an excellent piece of work, together with all those involved in the campaign to prevent the closure of Birch Avenue and Woodland View Care Homes.

12. PROPORTIONAL ALLOCATION OF SEATS ON COUNCIL COMMITTEES

RESOLVED: On the Motion of Councillor Pat Midgley, seconded by Councillor Clive Skelton, that this Council:-

- (a) notes the application of the political proportionality framework as set out in the report;
- (b) agrees that, in order to ensure that each group has the required number of seats overall in comparison to the total number of seats available on all Committees to reflect their composition on the Council as a whole, the two seats allocated to the former Independent Member be now recognised as belonging to the Labour Group; and
- (c) determines that political proportionality be reviewed in December each year to reflect any changes to the political composition of the Council occurring since the Annual Meeting of the Council each May.

13. COUNCIL CONSTITUTION

RESOLVED: On the Motion of Councillor Pat Midgley, seconded by Councillor Gill Furniss, that this Council notes the minor changes to the Constitution approved under delegated authority by the Director of Legal Services, in consultation with the Lord Mayor, in January, April and May, 2011, as detailed in the report now submitted.

- (c) also welcomes that community safety and services for children, families and young people are areas where funding will be restored whilst the voluntary, community and faith (VCF) sector will see their grant aid boosted to support their work across the City;

That the Motion now submitted be amended by:-

1. the substitution of the word "notes" for the words "is pleased to welcome" in paragraph (a);
 2. the substitution of the words "failed to fulfil" for the word "fulfilled" in paragraph (a); and
 3. the deletion of paragraphs (b) to (h) and the addition of new paragraphs (b) to (e) as follows:-
- (b) recalls the Amendment moved by Cllr Bryan Lodge seconded by Councillor Julie Dore at the Full Council meeting on 4th March, 2011, which includes the extract:

- (17) *confirms that if the main opposition group is given a political mandate to form an administration in May, they would propose the following amendments to the Council's budget for the Municipal Year 2011/12, redirecting £2,407k spend to key priorities:*

Additional Spend of £2,407k

- (i) *prioritise safety in Sheffield's neighbourhoods by restoring cuts to 10 FTE Police Community Safety Officer posts, at a cost of £300k;*
- (ii) *ensure that a two-tier system is not created in adult care by restoring cuts to self-directed support, which involve changing the formula for calculating personal budgets, at a cost of £400k;*
- (iii) *protect vital activities at the heart of Sheffield's communities provided by Sheffield's much valued Voluntary, Community Faith (VCF) sector, by restoring 7.5% of the cut to the grant aid budget, at a cost of £260k;*
- (iv) *prioritise education for Sheffield's young people by restoring cuts to study support services for children, at a cost of £131k;*
- (v) *ensure that young people across the City can continue to be involved in sporting activities by restoring cuts to Activity Sheffield which will ensure that Verdon Street Recreation Centre, Highfield Adventure Playground and Pitsmoor Adventure Playground stay open, and three Development Officer posts are saved, at a cost of £180k;*
- (vi) *ensure that vital projects and activities for children and families in Sheffield can continue, by restoring part of the cut to the childcare component of Children's Centres, Sure Start and Community Nurseries subsidies, at a cost of £247k, meaning that the overall reduction will be 10% instead of 22%;*
- (vii) *ensure that as many young people in Sheffield as possible are given the opportunity to enter the world of paid employment and do not become part of a culture of worklessness, by investing £500k to create a Youth Employment Fund to offer apprenticeships for 16-19 year olds;*
- (viii) *support employment in Sheffield, by restoring the Council's contribution to the Alliance for Regional Aid, at*

a cost of £4k;

- (ix) ensure that the lowest paid do not bear the brunt of the Government's cuts, by restoring cuts to the trainee and apprenticeship posts that have been cut in the Administration's budget, at a cost of £67k;
- (x) ensure that the important library service for the patients of Weston Park Hospital continues, by restoring cuts at a cost of £6k;
- (xi) recognise the importance of Sheffield's museums and galleries and the role they play in bringing business and leisure tourism to the City, by restoring cuts to Sheffield Galleries and Museums Trust to ensure that Graves Art Gallery stays open, at a cost of £180k;
- (xii) ensure that standards of public health are protected, by restoring the subsidy of bulky waste services, at a cost of £22k and reintroducing a free rat treatment service for all households, at a cost of £110k;

Savings of £2,407k:

- (i) fund £425k of projects and activities for children and young people, from the Dedicated Support Grant, subject to confirmation with the schools forum;
 - (ii) reduce spend on Small Grants by £170k in order to redirect this money to support the shortfall in funding for the grant aid budget;
 - (iii) absorb £133k costs for Activity Sheffield within the Positive Activities for Young People budget;
 - (iv) reduce spend on Household Waste Recycling Centres by £204k;
 - (v) use £115k one-off funding identified within transport services;
 - (vi) use £1360k Local Authority Business Growth Incentive (LABGI) funding;
- (c) therefore concludes that the present Administration have broken their promise to implement the above changes to the Council's budget, instead watering down commitments and in some cases dropping plans altogether, noting that these examples include:
- (1) making £2m of changes rather than the £2,4m promised;

- (2) only allocating the Voluntary, Community and Faith Sector £135K, rather than the £260K promised;
 - (3) only replacing £80K instead of the £180K promised to Museums Sheffield, with only 4 hours restored at Graves Art Gallery compared to the 30 promised;
 - (4) failing to restore £400K to self-directed support budgets, as the funding has been simply moved from within purchasing budgets for care packages;
 - (5) failing to restore 15% of the cuts to the childcare services at Children's Centres, Sure Start and Community Nurseries; and
 - (6) backtracking on plans to save money by cutting the Dedicated Schools Grant, LABGI fund and some elements of the small grants fund;
- (d) is concerned that much of the changes have been financed by dipping into the £13.4m budget surplus left by the previous Administration and unclear cuts simply described as 'within existing budgets'; and
- (e) is furthermore concerned that although the present Administration claim that these decisions have been made, there is no record of how the decisions have been made and by whom, no process for scrutiny and no completed equality impact assessment.

On being put to the vote, the amendment was negated.

(NOTE: Councillors Jillian Creasy and Robert Murphy voted for paragraphs 1, 2 and 3 sub-clauses (b), (d) and (e) and abstained from voting on paragraph 3 sub-clause (c) of the above amendment and asked for this to be recorded).

It was then moved by Councillor Jillian Creasy, seconded by Councillor Robert Murphy, as an amendment that Motion now submitted be amended by the addition of three new paragraphs as follows:-

- () notes that members of the current Administration publicly criticised cuts to Sure Start and supported the Defend Sure Start Campaign, helping to collect signatures for the 5000 strong petition and voting to "applaud and support the campaign";
- () acknowledges that the recent budget adjustments have only reduced the cut to childcare, not to Sure Start Childrens' Centres' core purpose provision in the City and that Sure Start has lost out in comparison to other Early Years Services; and
- () will therefore now do everything possible, for instance via the Review of

Early Years Services and any future budget adjustments, to support the work of Sure Start Childrens' Centres to enable them to continue to provide universal, open access, non-threatening, non-stigmatising services for parents most in need.

On being put to the vote, paragraphs 1 and 3 of the amendment were carried and paragraph 2 was negatived.

 - (ii) exclude rough sleepers, people living in B&B accommodation, people residing in refuges and night shelters, people who are

living in severe overcrowding, those at immediate risk of eviction, those in short term arrangements with friends/family, squatters, and people due discharge from institutions without accommodation to go to;

- (d) fears that the Government's cuts to the Supporting People programme and other housing support programmes have contributed to this increase;
- (e) fears a future increase in homelessness figures as changes to housing benefit are implemented;
- (f) thanks the organisations in Sheffield that work to prevent, tackle and reduce homelessness in our City;
- (g) will continue to work with partners and other organisations to help prevent and tackle homelessness in Sheffield;

1. the deletion of paragraphs (d) and (e) and the addition of new paragraphs (d) to (h) as follows:-
 - (d) recognises that despite 13 years in power, Labour politicians failed to tackle the root causes of homelessness, with 1.75 million people on social housing waiting lists and an estimated additional 380,000 'hidden homeless' people in the UK;
 - (e) notes with concern, that under the previous Government, the building of social housing declined to the lowest figure since the Second World War, with seven times more prison cells being built than council homes;
 - (f) welcomes moves by the Coalition Government to increase the building of social housing, and action taken by the last Council administration to build the first new council homes in Sheffield for two decades;
 - (g) acknowledges specific moves by the Coalition Government to tackle homelessness, such as a cross-departmental Homelessness Working Group and proposals in the Localism
