Due to your Government's ideological attack on public services, SOVA have been forced to reduce the opening times of recycling centres.

Around 80% of visits take place on Friday, Saturday, Sunday or Monday – when all five sites are open, including Blackstock Road.

The Council has supported residents to make alternative arrangements by informing customers at Blackstock Road of other sites and through the distribution of a recycling options booklet to every home – something you opposed.

Residents are also able to use other sites – particularly the Beighton site, which is open six days a week and located in the south of the City.

The Council has also rolled out the flexible choice option for kerbside recycling, giving people more choice and reducing demand.

You will note that this year, the cumulative amount of green waste collected through HWRCs is at its highest ever for this time of year.

The overall reduction in green waste recycling can largely be attributed to an increase of composting across Sheffield and the wettest summer in 100 years.

Sheffield Children's Centre on Shoreham Street, which was recently assessed as "outstanding" by Ofsted, has been issued with a Statutory Notice to cease grant funding. With regard to this notice:
