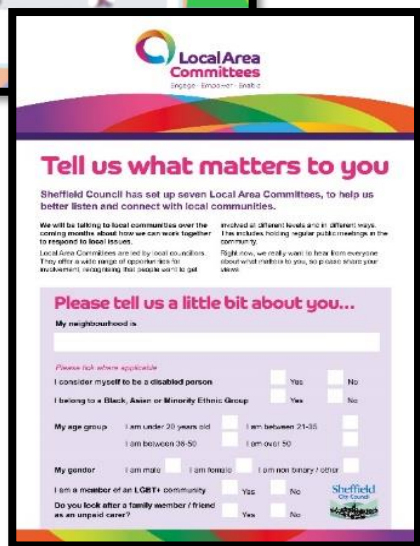
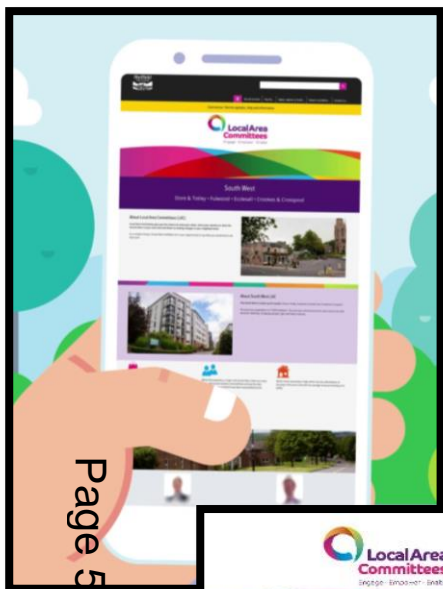
The LAC is supported by a small team of officers that consists of a Community Services Manager, Community Services Officers, Project Support Officer, a Secretary and various other supporting staff.

Survey

The Local Area Committee Community Survey was open digitally from 31st August to 31st October 2021. We also distributed hundreds of paper copies of the survey from September to December 2021.

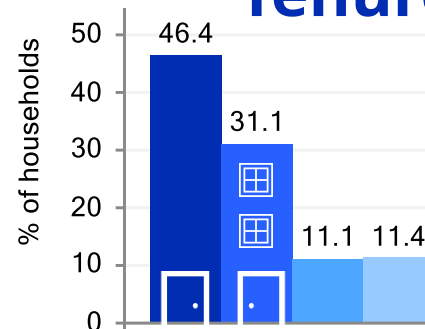

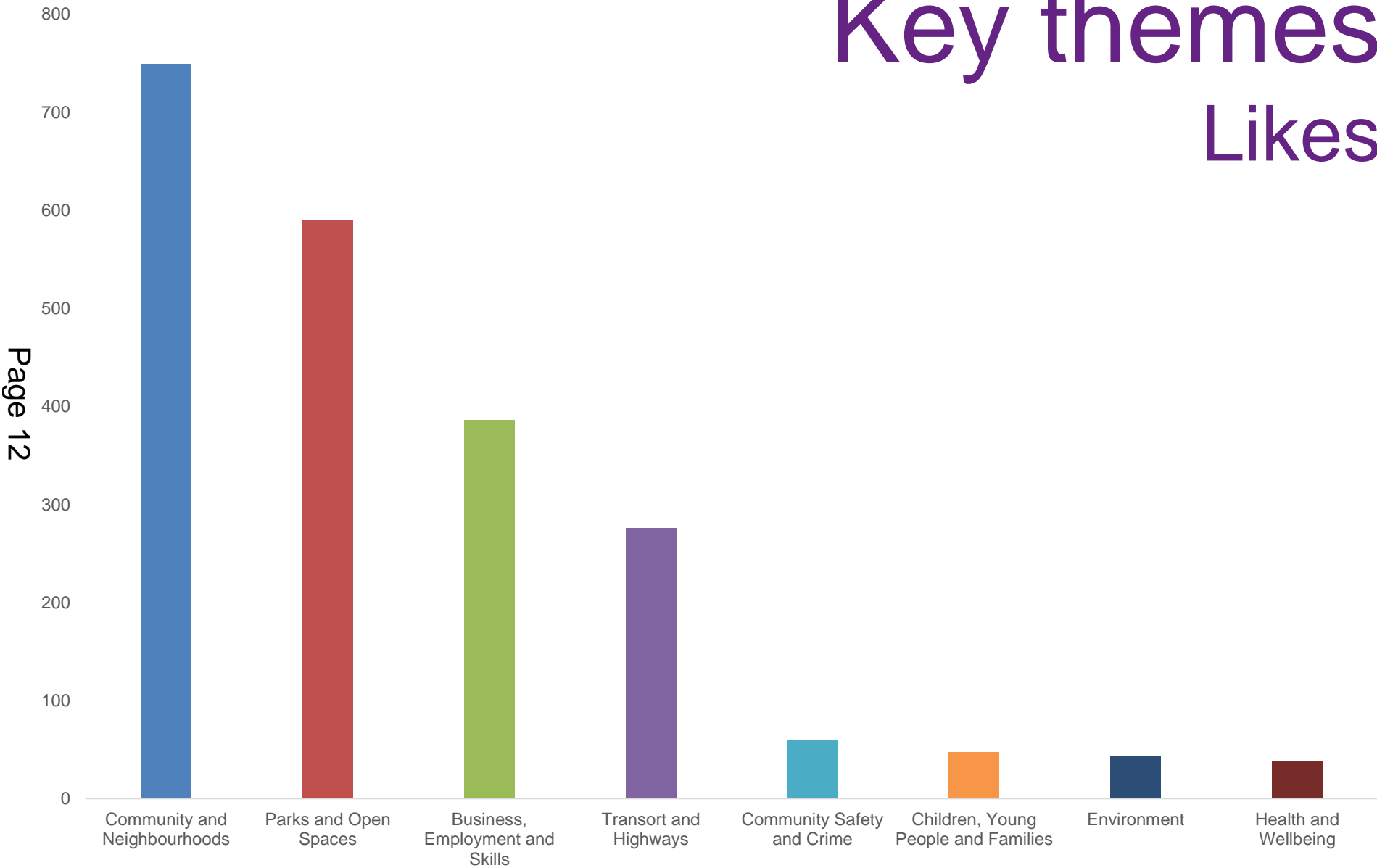

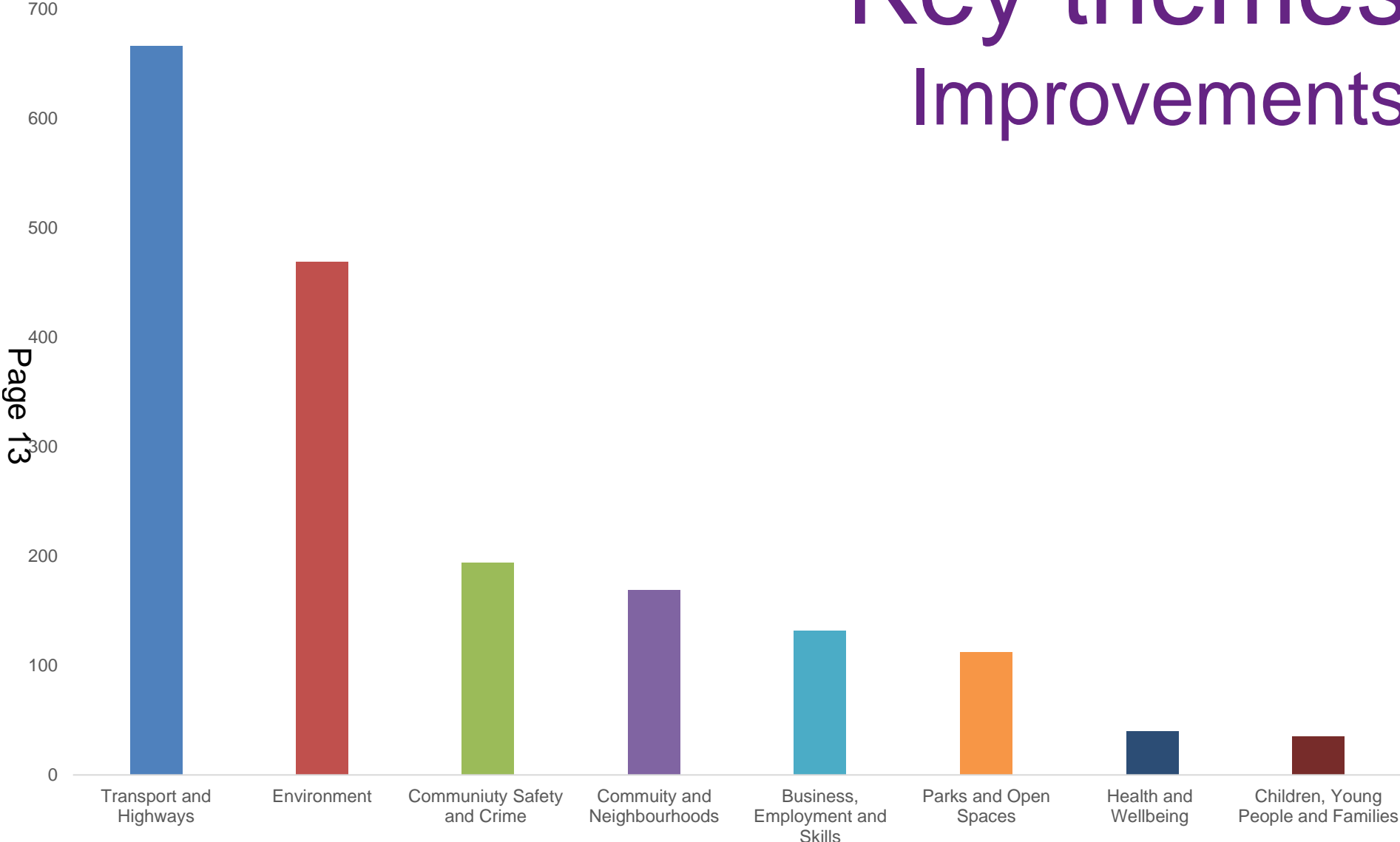
