TO THE MEMBERS OF THE CITY COUNCIL

Dear Councillor,

<u>Annual Council Meeting and First Meetings of Local Area Committees and of Policy Committees – Wednesday, 17th May 2023</u>

It is a function of the Council, at its annual meeting, to approve a schedule of Council and Committee meetings for the municipal year ahead, and (with the exception of the Local Area Committees) to appoint the Chairs and Deputy Chairs of the Council's Committees. To facilitate this, appropriate items of business have been included on the agenda for the annual meeting of the Council on 17th May 2023.

The Council has decided that each Local Area Committee shall appoint a Chair and Deputy Chair for the year from its membership. Accordingly, in line with previous practice, the first meetings of the seven Local Area Committees will be held, consecutively, immediately following the close of the annual meeting, for the purposes of appointing the Chairs and Deputy Chairs, as appropriate, and to approve the frequency of their meetings in line with the schedule of meetings to be agreed at the annual meeting of the Council.

Only committees have the power to appoint their sub-committees. Therefore, it will be for (a) each Policy Committee to establish their Urgency Sub-Committee and appoint Members to serve on it; (b) the Strategy and Resources Policy Committee to establish the standing Charity Trustee Sub-Committee, appoint Members to serve on it and appoint the Chair and Deputy Chair; and (c) the Adult Health and Social Care Policy Committee to establish the standing Health Scrutiny Sub-Committee, appoint Members to serve on it and appoint the Chair and Deputy Chair. Accordingly, the first meetings of the nine Policy Committees will be held, consecutively, immediately following the conclusion of the first meetings of the Local Area Committees, for the purposes of conducting this business.

I enclose with this letter, a list showing the proposed order for the first meetings, together with the draft agendas, which will be held immediately following one another and without a break. The Lord Mayor will occupy the Chair and the

Members of the Council will be required to remain in their seats throughout the whole of the proceedings.

To facilitate the transaction of the business, the Lord Mayor will announce at the start of each meeting, the name of the mover and seconder of the composite motion to determine the business as detailed in the agenda. The names of the mover and seconder of the composite motion will be drawn from the Members of the particular Local Area Committee, or Policy Committee, concerned. The Lord Mayor will put the motion upon which the Members of the Committee concerned will vote. In the event of any questions arising upon any item on the agenda for a particular Committee, only the members of that Committee are permitted to participate in the discussion.
