ADVICE TO MEMBERS ON DECLARING INTERESTS AT MEETINGS

The existing Standards regime will be abolished from 1st July, 2012 by the Localism Act 2011. From this date, the way that your interests need to be registered and declared will change. Prejudicial and personal interests will no longer exist and they have been replaced by Disclosable Pecuniary Interests (DPIs).

The Act also requires that provision is made for interests which are not Disclosable Pecuniary Interests and requires the Council to introduce a new local Code of Conduct for Members. It is intended that provision will be made in the new Code for dealing with "personal" interests.

The Regulations in relation to Disclosable Pecuniary Interests have only recently been published by the Government and guidance is being developed for circulation to you prior to 1st July.

If at all possible, you should try to identify any potential interest you may have before the meeting so that you and the person you ask for advice can fully consider all the circumstances before reaching a conclusion on what action you should take.

CONSENT SITE - Bramall Lane Football Ground - John Street - 57/FS.

1.0 PURPOSE OF REPORT

1.1 To consider an application for the renewal of a consent to street trade.

2.0 INTRODUCTION

- 2.1 The Council as a Licensing Authority have power under the provision of the 1982 Act to regulate Street Trading in the City.
- 2.2 A Street Trading Consent is required to trade on any Street (which includes roads, footways, forecourts, or other areas to which the public have access) within the Sheffield City Boundary.
- 2.3 The Licensing Committee at it's meeting of 29th January 2002 passed the following resolution:
 - 1. That under the provisions of schedule 4 of the Local Government (Miscellaneous Provisions) Act 1982:
 - (a) all streets (which includes roads, footways, forecourts or other areas to which the public have access) within the Sheffield City boundary, shall be designated consent streets and;
 - (b) such street trading designation shall take effect as from the 1st April 2002; and
 - (c) all previous designations in relation to street trading will be rescinded as a result of the designation set out above.
 - 2. The effect of this resolution is that from 1st April 2002, it will be an offence to engage in street trading in any street or any other place identified in the above resolution without being authorised to do so by consent from the City Council.
- 2.4 A Local Authority may attach conditions to a Street Trading Consent. The conditions may include conditions to prevent obstruction of the street and danger to persons using the street or nuisance or annoyance.
- 2.5 A Street Trading Consent may only be granted for a maximum period of twelve months.

2.6 There is no appeal procedure against the refusal or revocation of a consent. An applicant may, however apply for judicial review of the councils decision.

3.0 THE APPLICATION

- 3.1 The applicant is Mrs Linda and Mr Roger Stone and a copy of the application is attached at Appendix 'A'.
- 3.2 The application is to sell hot and cold food and hot and cold drinks during Sheffield United 1st team home fixtures, friendly's and internationals.
- 3.3 The applicant trades from a site on John Street. A copy of the location of the site is attached at Appendix 'B'.

4.0 REASONS FOR REFERRAL

4.1 An objection to the application has been received from Mr Ian Boyne, who is the letting agent for the premises located at 108 Charlotte Road, Sheffield, S1 4TL.

5.0 BACKGROUND

- 5.1 The objector, Mr Ian Boyne, wrote to the Licensing Service on 14th October 2011 and 19th January 2012, to register his concern in relation to the street trading consent. A copy of the letters are attached to the report at Appendix 'C'.
- 5.2 The Licensing Service wrote to Mr Ian Boyne on 27th January 2012 in response to his letters of 14th October 2011 and 19th January 2012. A copy of the letter sent by the Licensing Service is attached to the report at Appendix 'D'.
- 5.3 Mr Ian Boyne again wrote to the Licensing Service on 7th February 2012, requesting that his concerns be put before the Licensing Committee of the Council prior to the renewal of the consent. A copy of the letter is attached to the report at Appendix 'E'.
- 5.4 The Licensing Service wrote to Mr Ian Boyne on 9th February 2012, to inform him that the renewal of the street trading consent would be placed before the Licensing Committee of the Council for determination. A copy of the letter is attached to the report at Appendix 'F'.
- 5.5 The applicant and objectors have been invited to attend the Licensing Committee hearing. Copies of the invites are attached at Appendix 'G'.
- 5.6 A copy of the hearing procedure is attached at Appendix 'H'.

6.0 FINANCIAL IMPLICATIONS

6.1 There are no financial implications for the Council arising from this report.

7.0 RECOMMENDATIONS





> <u>Re:- 108 Charlotte Road – Shop & Flat above</u> <u>Sheffield S1 4TL</u>

I am the letting agent for this property and write to express my concern about the complaints made by the tenants of the shop and flat, relating to the siting of a mobile hot food take away unit parked within a few yards of this property.

The complaints can be summarised as follows:-

- A) The unit is parked at the Shoreham Street end of John Street on double yellow lines every match day. The road is closed for part of this time, however prior to the road closure the unit is towed into position well before the road is closed and causes serious obstructions to the junction.
- B) The mobile unit is powered by a free standing generator, positioned at the rear of the unit, even closer to the property. The generator is very noisy and the strong fumes are easily detectable in both the shop and the flat.
- C) Over a period of several hours, whilst the unit is being used, the combined fumes and cooking smells make living in the flat impossible.

I am sure you will be able to check if this unit can park in this position and conforms with your stringent standards.

However it seems rather unreasonable that this unit can just park with no regards to either the road safety aspect or the impact on the adjacent residents. It seems even more unreasonable that the unit can then be towed away and the local residents are just left with the mess.

Whilst I appreciate this take away unit does provide a service and an income to the local authority, a site away from a busy road junction and occupied property would surely be more appropriate.

I refer to the above and your letters dated 14th October 2011 and 19th January 2012 and apologise in the late reply.

Since receiving your letter I have been in regular correspondence with the shop owner Mr Bingham regarding his trading and the street trader you refer to outside the premises.

I can confirm that the trader outside the premises holds a valid street trading consent issued by Sheffield City Council. The trader was relocated to this position following consultation with the following authorities: Highways Department; South Yorkshire Police; Planning Department, and South Yorkshire Fire and Rescue Service.

The application was placed before our Licensing Committee for determination which included comments from the Highways Department which allocated this site as the most appropriate. Please note, the double yellow parking restrictions which were to be introduced as part of the ongoing scheme for this junction was also taken into consideration at the Licensing Committee hearing. The application and site location was subsequently granted to trade 'four hours prior, during and up to one hour after each fixture' at all Sheffield United 1st team home fixtures, friendly's and internationals. The consent was issued as from the 26th August 2010 and since that date no complaints or issues had been made.

Your complaint also refers to the standing generator positioned at the rear of the unit which is causing noise and fumes, our Licensing Officers regularly undertake enforcement exercises on match days and will visit the unit to see if it is causing a nuisance and whether it can be repositioned.

Officers will also ensure that the conditions attached to their consents regarding litter are being complied with, should any of the conditions be breached, the consent holders will be formally notified and appropriate action will be taken.

Whilst i appreciate approval has been given to the mobile hot food take away unit to operate in this location, the underlying problem remains. The nuisance is caused by allowing the mobile unit to park too close to a residential property and the smells from the cooking and the generator can easily be detected in the flat.

It would appear very little can be done at this moment in time and i find this very disappointing. However i would strongly request my comments are placed before the licensing committee before 31st May 2012 to avoid further consent being granted to this street trader in this location.

STREET TRADING CONSENT APPLICATION



SUB-COMMITTEE HEARING PROCEDURE

This procedure has been drawn up to assist those parties attending Street Trading Consent Committee hearings.

1. The Chair of the Licensing Committee will introduce the Committee and ask officers to introduce themselves.

- 2. The Chair will ask the applicants and interested parties to formally introduce themselves.
- 3. The Solicitor to the Committee will outline the procedure to be followed at the hearing.
- 4. Hearing Procedure:-
 - (a) The Licensing Officer will introduce the report.
 - (b) Questions concerning the report can be asked both by Members and the applicant.
 - (c) The applicant/consent holder (or his/her nominated representative) will then be asked to:-
 - (i) detail the application;
 - (ii) provide clarification on the application and respond to the representations made.
 - (d) The Chair of the Licensing Committee will invite Members of the Sub-Committee and all other parties present to put any relevant questions to the applicant and/or his/her representative.
 - (e) Consultees / interested parties will be invited to present their representations or elect a spokesperson (which may be a Councillor) to speak on their behalf. New representations must not be raised.
 - (f) The Chair of the Licensing Committee will invite Members of the Sub-Committee and all other parties present to put any relevant questions to the consultees / interested parties.
 - (g) The consultees / interested parties will be invited to sum up. A maximum of 5 minutes will be allowed.
 - (h) The applicant will be invited to sum up. A maximum of 5 minutes will be allowed.
 - (i) The Licensing Officer will then detail the options.
 - (j) There will then be a private session for Members to take legal advice and consider the application.
 - (k) Once a decision has been reached, all parties will be invited to return. The Sub-Committee's decision and reasons will be announced by the Chair.
 - (I) The Sub-Committee's decision will be confirmed in writing to the applicant and those parties who made representations.
 - NB: 1) At any time in the Licensing Process Members of the Committee may request legal advice from the Solicitor to the Committee. This advice may be given in open session or in private.
 - 2) The Committee Hearing will be held in public unless and in accordance with the Regulations the Committee determine that the public should be excluded.

There is no right of appeal against the Council's decision to refuse to grant or revoke a Street Trading Consent.
