#### ADVICE TO MEMBERS ON DECLARING INTERESTS AT MEETINGS

The existing Standards regime will be abolished from 1<sup>st</sup> July, 2012 by the Localism Act 2011. From this date, the way that your interests need to be registered and declared will change. Prejudicial and personal interests will no longer exist and they have been replaced by Disclosable Pecuniary Interests (DPIs).

The Act also requires that provision is made for interests which are not Disclosable Pecuniary Interests and requires the Council to introduce a new local Code of Conduct for Members. It is intended that provision will be made in the new Code for dealing with "personal" interests.

The Regulations in relation to Disclosable Pecuniary Interests have only recently been published by the Government and guidance is being developed for circulation to you prior to 1<sup>st</sup> July.

If at all possible, you should try to identify any potential interest you may have before the meeting so that you and the person you ask for advice can fully consider all the circumstances before reaching a conclusion on what action you should take.



#### 1.0 PURPOSE OF REPORT

1.1 To consider an Application to Vary a Premises Licence made under the Licensing Act 2003.

#### 2.0 THE APPLICATION

- 2.1 The applicant is Forum Cafe Bars.
- 2.2 The application, which was received on 13 June 2012 is attached to this report labelled Appendix 'A'.

#### 4.0 FINANCIAL IMPLICATIONS

4.1 There are no specific financial implications arising from this application. However, additional costs may be incurred should the matter go to appeal. In such an eventuality it may not be possible to recover all these costs. The impact of these additional costs (if any) will be kept under review and may be subject of a further report during the year.

#### 5.0 THE LEGAL POSITION

- 5.1 The Licensing Act 2003 at section 4 (1) requires the Licensing Authority to carry out its functions with a view to promoting the Licensing Objectives which section 4(2) sets out as:
  - a) the prevention of crime and disorder,
  - b) public safety,
  - c) the prevention of public nuisance,
  - d) the protection of children from harm.
- 5.2 Section 4(3) of the Licensing Act also requires the Licensing Authority to have regard to the published statement of Licensing Policy and any guidance issued by the Secretary of State under section 182.

#### 6.0 HEARINGS REGULATIONS

- 6.1 Regulations governing hearings under the Licensing Act 2003 have been made by the Secretary of State.
- 6.2 The Licensing Authority has provided all parties with the information required in the Regulations to the 2003 Act as set out at Appendix 'F'.
- 6.3 Attached at Appendix 'F' is the following:
  - a) a copy of the Notice of Hearing;
  - b) the rights of a party provided in Regulations 15 and 16;
  - c) the consequences if a party does not attend or is not represented at the hearing
  - d) the procedure to be followed at the hearing.

#### 7.0 APPEALS

7.1 The Licensing Act 2003 section 181 and Schedule 5 makes provision for appeals to be made by the applicant and those making representations against decisions of the Licensing Authority, to the Magistrates' Court.

#### 8.0 **RECOMMENDATIONS**

8.1 That members carefully consider the representations made and take such steps, as the Committee consider necessary for the promotion of the Licensing Objectives.

#### 9.0 OPTIONS OPEN TO THE COMMITTEE

- 9.1 To vary the premises licence in the terms requested.
- 9.2 To vary the premises licence with modified conditions.
- 9.3 To reject the whole or part of the application.

#### <u>Annex 1A – Mandatory Conditions</u>

Mandatory Condition 1 (Section 19 ss 2)

Where a licence authorises the sale of alcohol then no supply of alcohol may be made under the premises licence –

- (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
- (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

Mandatory Condition 2 (Section 19 ss 3)

Where a licence authorises the sale of alcohol then every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

Mandatory Condition 3 (Section 20)

- 1. Where a premises licence authorises the exhibition of films, the licence includes the following conditions relating to the admission of children to the exhibition:
  - (a) The admission of children (under 18) to the exhibition of any film must be restricted in accordance with the classification set by the film classification body (currently the BBFC).

  - (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises in a manner which carries a significant risk of leading or contributing to crime and disorder, prejudice to public safety, public nuisance, or harm to children-

(a) games or other activities which require or encourage, or are designed to require or encourage, individuals to-

(i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply

alcohol), or

(ii) drink as much alcohol as possible (whether within a time limit or otherwise);

(b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic (other than any promotion or discount available to an individual in respect of alcohol for consumption at a table meal, as defined in section 159 of the Act);

(c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less;

(d) provision of free or discounted alcohol in relation to the viewing on the premises of a sporting event, where that provision is dependent on-

(i) the outcome of a race, competition or other event or process, or (ii)the likelihood of anything occurring or not occurring;

(e) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.

- 2. The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
- 3. The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.

#### Annex 1C - Mandatory Conditions effective from 1st October 2010:

These mandatory conditions apply were the licence authorises the supply of alcohol. The condition 5 does not apply where the licence authorises the sale by retail or supply of alcohol only for consumption off the premises.

4. (1) The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.

(2) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.

- 5. The responsible person shall ensure that-
  - (a) Where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures-
    - (i) beer or cider: 1/2 pint;
    - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
    - (iii) still wine in a glass: 125 ml; and
  - (b) Customers are made aware of the availability of these measures.

## Annex 2 – Conditions consistent with the operating schedule

- 1. There shall be no adult entertainment or services, activities, other entertainment or matters ancillary to the use of the premises that may give rise to concern in respect of children.
- 2. CCTV will be used throughout the premises.

3. Customers will not be allowed to leave the premises with open bottles or vessels.

- 4. A personal licence holder will be on site at all times.
- 5. Control sources of noise.
- 6. Ensure customers leave quietly to minimise disruption.
- 7. All amplified music will be played through an in house limiter.
- 8. No deliveries, waste sorting or waste removal will be made at times that would cause a disturbance to residents.
- 9. Challenge 21 scheme will be in operation.
- 10. Staff training to ensure no alcohol purchased or supplied to anybody under 18 years of age.
- 11. Any person under the age of 18 years are not allowed on the premises unaccompanied.
- 12. First aid equipment and trained staff will be provided.
- 13. The premises will have adequate and appropriate lighting.
- 14. Full risk assessments will be made for the premises.
- 15. Occupancy limits will be maintained.

16. Regular electrical and gas safety checks will be carried out.

17. No licensable activities will take place under the authority of this licence until the Authority has been notified that the premises are suitable. Any reasonable requirements of the public safety authority will be complied with in order to ensure that the premises are suitable for their intended use. The licensee will give the responsible authorities a minimum of 14 days notice of the intended opening date of the premises.

18. A Building Regulation Completion Certificate shall be submitted to the authority responsible for public safety.

19. Persons under the age of 18 must be off the premises by 21:30 hours unless dining or attending a private, prebooked function.



Dear all,

I wish to object to the application for an extension of hours for the York public house on Fulwood Road in Broomhill. The application seems to have disappeared off the list of licensing applications. I understand the closing date is 11th July 2012.

My main objections are that this is a family area and an extension of hours would severely affect the quality of the suburb, e.g. noise late at night because of taxis and late night drinking. The South Seas pub is experiencing problems with anti social behaviour, loud music and alleged drug taking. The police are well aware of this. Another bar opening late on a regular basis could attract similar problems. Broomhill is a suburb and not an extension of the city centre. The York is placed in a mainly residential area, not a student part of Broomhill. Also there are resident flats above the pub itself and opposite. This culture is not welcome in Broomhill by the residents or the fellow shop owners. The York pub will most likely have known the character of the area when it opened and it seems unfair for it to wish to change it now.

In light of these concerns I would say these are not in line with at least 3 of the objectives of the Licensing Act 2003:

- The prevention of crime and disorder: Taking the South Seas' problems into account I would regard this application as an unnecessary risk. Also it would most likely lead to an increase in police in Broomhill which I regard as an unnecessary drain on police resources. Other types of crime would most likely increase, such as littering, noise and alcohol induced vandalism.
- Public safety: Manchester Road and Fulwood Road are very busy roads and an increase late at night on these roads which are also very residential could increase accidents and injuries. Encouraging late night drinking in a residential area where many children live could potentially increase alcohol induced crime and the type of crime allegedly related to the South Seas.
- 3. Prevention of public nuisance: Noise would increase and the culture of Broomhill could be changed to that of a late night drinking culture which would contradict the Broomhill Neighbour Action Plan and the desire to keep late night drinkers in the City Centre. The York is surrounded by residents, many with young children, and late night noise would be a nuisance to them.

I hope I have sent this email to the right place, if I have not then could you please advice me who to contact.

#### Application to vary a premises license, The York (Forum Café Bars)

I am writing on behalf of Broomhill Action Neighbourhood Group to comment on the above application. I understand that The York has recently been granted planning permission to extend its opening hours on a trial basis for one year and that this application, if agreed, will allow them to trade during that time.

We would like the Licensing Committee to know that The York has put significant effort into developing good community relations and we have met with the owners and managers on several occasions to discuss how their impacts in the neighbourhood can be responsibly managed.

However it is still the case that many residents in Broomhill are concerned that later opening of The York, which is a very popular venue, could potentially exacerbate the problems of late night noise in the Broomhill District Centre and disturb their sleep. The district centre is a residential area as the accommodation above shops, including the York itself, has for the most part been converted into flats in recent years.

In our discussions with The York we have raised a number of practical measures that we think could help to prevent or mitigate the potential nuisances that might arise from later opening. We would like to ask the Licensing Committee to consider these points in making your decision.

1. No late night cut-price drinks promotions

The York tell us that they do not wish to attract people seeking to pre-load on their way to nightclubs and their pricing policy deters this activity. If it were possible for a 'no late-night promotions' policy to be adopted as a license condition it would give local residents added assurance that the policy would remain in place even if the venue has a change of ownership.

2. A 'winding down' period before closing time;

Turning the music off half an hour before closing time would encourage customers to finish their evening quietly and leave the premises quietly. The fact that The York has no entertainment license is helpful, but what would help even more would be for the license to restrict the hours for playing recorded music, to end half an hour before the opening hours.

3. Last food orders well before closing time;

The York tell us that the purpose of extended opening is to allow customers who have spent the evening there, particularly those who have purchased meals, to have more time to finish in a relaxed atmosphere. For this reason we would also like the hours for late night refreshment to be restricted to end at least half an hour before the opening hours.



Finally we would like to say that The York is a valued business in our district centre and is well managed. We don't feel that there is a risk of increased litter, crime or disorder if it stays open half an hour longer. We also have confidence that if there are noise impacts, we have established a constructive dialogue with the owners and managers and there is a willingness to work together to resolve problems. But we are concerned that because the license is attached to the premises rather than the current owners, it could be passed on to less responsible owners should the business change hands. This is why we would appreciate your help (where legally possible) in reinforcing responsible management practices through appropriate license conditions.



but such a person may, before the end of the hearing, submit to the authority in writing any information which they would have been entitled to give orally had they not been required to leave.



#### Licensing Act 2003 - Hearing Procedure - Regulation 7 (1)

This procedure has been drawn up in accordance with the Licensing Act 2003 to assist those parties attending Licensing Committee hearings.

- 1. The hearing before the Council is Quasi Judicial.
- 2. The Chair of the Licensing Committee will introduce the Committee and ask officers to introduce themselves.
- 3. The Chair will ask the applicants to formally introduce themselves.
- 4. The Solicitor to the Committee will outline the procedure to be followed at the hearing.
- 5. Hearing Procedure:-
  - (a) The Licensing Officer will introduce the report.
  - (b) Questions concerning the report can be asked both by Members and the applicant.
  - (c) The Licensing Officer will introduce in turn representatives for the Responsible Authority and Interested Parties who will be asked to detail their relevant representations.
  - (d) Members may ask questions of those parties
  - (e) With the leave of the Chair the applicant or his representative may cross examine the representatives of the Responsible Authorities and Interested Parties.
  - (f) The applicant/licensee (or his/her nominated representative) will then be asked to:-
    - (i) detail the application;
    - (ii) provide clarification on the application and respond to the representations made.
  - (g) The applicant/licensee (or his/her nominated representative) may then be asked questions by members and with the leave of the Chair from the other parties present.
  - (h) The applicant will then be given the opportunity to sum up the application.
  - (i) The Licensing Officer will then detail the options.
  - (j) There will then be a private session for members to take legal advice and consider the application.
- 6. The decision of the Licensing Committee will be given in accordance with the requirements of the Licensing Act 2003 and regulations made there under.

 NB: 1) At any time in the Licensing Process Members of the Committee may request legal advice from the Solicitor to the Committee. This advice may be given in open session or in private.

 The Committee Hearing will be held in public unless and in accordance with the Regulations the Committee determine that the public should be excluded.

#### **Regulation 8**

- A party shall give to the authority within the period of time provided for in the following provisions of this regulation a notice stating –
  - (a) whether he intends to attend or be represented at the hearing;
  - (b) whether he considers a hearing to be unnecessary
- (2) In a case where a party wishes any other person (other than the person he intends to represent him at the hearing) to appear at the hearing, the notice referred to in paragraph (1) shall contain a request for permission for such other person to appear at the hearing accompanied by details of the name of that person and a brief description of the point or points on which that person may be able to assist the authority in relation to the application, representations or notice of the party making the request.
- (3) In the case of a hearing under -
  - (a) section 48(3)(a) (cancellation of interim authority notice following police objection), or
  - (b) section 105(2)(a) (counter notice following police objection to temporary event notice),

the party shall give the notice no later than one working day before the day or the first day on which the hearing is to be held.

- (4) In the case of a hearing under -
  - (a) section 167(5)(a) (review of premises licence following closure order),
  - (b) paragraph 4(3)(a) of Schedule 8 (determination of application for conversion of existing licence), paragraph 16(3)(a) of Schedule 8 (determination of application for conversion of existing club certificate)
  - (c) paragraph 26(3)(a) of Schedule 8 (determination of application by holder of justices' licence for grant of personal licence),

the party shall give the notice no later than two working days before the day or the first day on which the hearing is to be held.

(5) In any other case, the party shall give the notice no later than five working days before the day or the first day on which the hearing is to be held.
