ADVICE TO MEMBERS ON DECLARING INTERESTS AT MEETINGS

The existing Standards regime will be abolished from 1st July, 2012 by the Localism Act 2011. From this date, the way that your interests need to be registered and declared will change. Prejudicial and personal interests will no longer exist and they have been replaced by Disclosable Pecuniary Interests (DPIs).

The Act also requires that provision is made for interests which are not Disclosable Pecuniary Interests and requires the Council to introduce a new local Code of Conduct for Members. It is intended that provision will be made in the new Code for dealing with "personal" interests.

The Regulations in relation to Disclosable Pecuniary Interests have only recently been published by the Government and guidance is being developed for circulation to you prior to 1st July.

If at all possible, you should try to identify any potential interest you may have before the meeting so that you and the person you ask for advice can fully consider all the circumstances before reaching a conclusion on what action you should take.

Hearing to consider a notice of objection to a Temporary Event Notice.

Vessel 'LB Hardfeet', Arch 16 Victoria Quays, Wharf Street, S2 5SY

1.0 PURPOSE OF REPORT

1.1 To consider a notice of objection submitted by South Yorkshire Police relating to a temporary event notice for the premises known as Vessel 'LB Hardfeet, Arch 16 Victoria Quays, Wharf Street, S2 5SY.

2.0 THE TEMPORARY EVENT NOTICE

- 2.1 The proposed premises user is Miss Dorothy Kim Grange.
- 2.2 The temporary event notice, which was received on 17 July 2012, is attached to this report labelled Appendix 'A'.
- 2.3 The event is from 4 August 2012 until 5 August 2012 for the following times 10:00 hours to 22:30 hours.
- 2.4 The nature of the event is described in the notice.
- 2.5 The licensable activities intended to be carried on at the premises are:
 - The sale by retail of alcohol
 - The provision of regulated entertainment

3.0 REASONS FOR REFERRAL

- 3.1 A notice was submitted by South Yorkshire Police on 17th July 2012, objecting to the temporary event notice on the following grounds of public safety.
- 3.2 The notice of objection is attached at Appendix 'B'.
- 3.3 The applicant and the objecting officers from 3.1 have been invited to attend the hearing. Copies of the front page of the notices are attached to this report labelled Appendix 'C'.



4.0 FINANCIAL IMPLICATIONS

4.1 There are no specific financial implications arising from this application. However, additional costs may be incurred should the matter go to appeal. In such an eventuality it may not be possible to recover all these costs. The impact of these additional costs (if any) will be kept under review and may be subject of a further report during the year.

5.0 THE LEGAL POSITION

5.1 Section 104 (2) of the Licensing Act states:

"Where a relevant person who is given a temporary event notice is satisfied that allowing the premises to be used in accordance with the notice would undermine a licensing objective, the relevant person must give a notice stating the reasons for being so satisfied (an "objection notice") –

- (a) to the relevant licensing authority,
- (b) to the premises user, and
- (c) to every other relevant person.".

5.2 Section 105 (2) states:

"The relevant licensing authority must -

- (a) hold a hearing to consider the objection notice, unless the premises user, the relevant person who gave the objection notice and the authority agree that a hearing is unnecessary, and
- (b) having regard to the objection notice, give the premises user and each other relevant person a counter notice under this section if it considers it necessary for the promotion of a licensing objective to do so."

5.3 Section 106A (2) states:

"The relevant licensing authority may impose one or more conditions on the standard temporary event notice if —

- (a) the authority considers it appropriate for the promotion of the licensing objectives to do so,
- (b) the conditions are also imposed on a premises licence or club premises certificate that has effect in respect of the same premises, or any part of the same premises, as the temporary event notice, and
- (c) the conditions would not be inconsistent with the carrying out of the licensable activities under the temporary event notice.

6.0 HEARINGS REGULATIONS

- 6.1 Regulations governing hearings under the Licensing Act 2003 have been made by the Secretary of State.
- 6.2 The Licensing Authority has provided all parties with the information required in the Regulations to the 2003 Act as set out at Appendix 'D'.



- 6.3 Attached at Appendix 'D' is the following:
 - a) a copy of the Notice of Hearing;
 - b) the rights of a party provided in Regulations 15 and 16;
 - c) the consequences if a party does not attend or is not represented at the hearing
 - d) the procedure to be followed at the hearing.

7.0 APPEALS

7.1 The Licensing Act 2003 section 181 and Schedule 5 makes provision for appeals to be made by the premises user and every other relevant person against decisions of the Licensing Authority, to the Magistrates' Court.

8.0 RECOMMENDATIONS

8.1 That members carefully consider the representations made and take such steps, as the Committee consider necessary for the promotion of the licensing objectives.

9.0 OPTIONS OPEN TO THE COMMITTEE

- 9.1 To acknowledge the temporary event notice, allowing the event to go ahead on the proposed date in the terms requested.
- 9.2 To acknowledge the temporary event notice, allowing the event to go ahead on the proposed date in the terms requested with the addition of a statement of conditions.
- 9.3 To give the premises user a counter notice if it considers it necessary for the promotion of a licensing objective.

Hi Emma, Jane and Gary.

Thanks for your very prompt dealings of out tens notice submissions.

Sorry I have been out on boat trips this afternoon.

1. I can open the 2nd tens notice for the Bar The Quays 1819 so have saved it again with the correct date on



it's file name, it is correct on the document. Hopefully you can read it this time.

2. I understand that the police are going to object to the Hardfeet Tens notice. I quite understand and expected that they would, as we are a tiny part of a large event of Sheftival that is going on that weekend in the Don Valley Stadium area.

While the boat is moving we are not doing anything that needs an extra licence it is well within our normal operation.

We may be covered while we are moored at the Don Valley Moorings by the general events notice as I know they will be a number of drink venues there.

As the organisers have not got back to us to confirm, to cover ourselves I applied for a tens licence so that it was within the 10 working day period as I stated above I expected the Police to want good control in the event, as there are a lot of people expected to attend.

It is expected that people leaving the boat after their trip will want to take there drinks off the boat, (in plastic glasses), this will make turn round on the trips easier for both passengers and staff. It is also anticipated that people on the quayside may want a drink, ice cream etc at times that the boat is moored. The third reason for wanting on off sell tens, is in the case the boat has an engine problem and we need to remain stationary at Don Valley moorings. Hopefully that makes sense, I will contact the organisers of Sheftival in the morning and check out the conditions that have been put on the event as a whole.

Right of attendance, assistance and representation

15. Subject to regulations 14(2) and 25, a party may attend the hearing and may be assisted or represented by any person whether or not that person is legally qualified.

Representations and supporting information

16. At the hearing a party shall be entitled to -

- (a) in response to a point upon which the authority has given notice to a party that it will want clarification under regulation 7(1)(d), give further information in support of their application, representations or notice (as applicable),
- (b) if given permission by the authority, question any other party; and

(c) address the authority

Failure of parties to attend the hearing

20. – (1) If a party has informed the authority that he does not intend to attend or be represented at a hearing, the hearing may proceed in his absence.

 - (g) The applicant/licensee (or his/her nominated representative) may then be asked questions by members and with the leave of the Chair from the other parties present.
 - (h) The applicant will then be given the opportunity to sum up the application.
 - (i) The Licensing Officer will then detail the options.
 - (j) There will then be a private session for members to take legal advice and consider the application.
- 6. The decision of the Licensing Committee will be given in accordance with the requirements of the Licensing Act 2003 and regulations made there under.
- NB: 1) At any time in the Licensing Process Members of the Committee may request legal advice from the Solicitor to the Committee. This advice may be given in open session or in private.







Annex 1A - Mandatory Conditions

Mandatory Condition 1 (Section 19 ss 2)

 - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic (other than any promotion or discount available to an individual in respect of alcohol for consumption at a table meal, as defined in section 159 of the Act);
 - (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less;
 - (d) provision of free or discounted alcohol in relation to the viewing on the premises of a sporting event, where that provision is dependent on-
 - (i) the outcome of a race, competition or other event or process, or
 - (ii)the likelihood of anything occurring or not occurring;
- (e) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.
- 2. The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
- 3. The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.



Annex 1C - Mandatory Conditions effective from 1st October 2010:

These mandatory conditions apply were the licence authorises the supply of alcohol. The condition 5 does not apply where the licence authorises the sale by retail or supply of alcohol only for consumption off the premises.

- 4. (1) The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.
 - (2) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.
- 5. The responsible person shall ensure that-
 - (a) Where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—

(i) beer or cider: ½ pint;

(ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and

(iii) still wine in a glass: 125 ml; and

(b) Customers are made aware of the availability of these measures.

Annex 2 - Conditions consistent with the operating schedule

- 1. To provide Illumination to the exterior areas of the pub.
- 2. Burglar alarm system in place.
- 3. Member of the local Pub Watch scheme as long as it remains
- 4. Under 21 proof of age scheme in operation
- 5. Notices to be displayed for zero tolerance on drugs.
- 6. Fire action notices to be posted, and emergency escape routes to be signposted and illuminated as appropriate.
- 7. All fire fighting equipment is to be serviced annually and there is a contract in place
- 8. All portable electrical appliances are to be tested annually.
- 9. To keep electrical and gas certificates current and in place.
- 10. Certificates relating to conditions 7, 8 or 9 must be kept on the premises and made available for inspection
- 11. To provide mechanical extraction in both bars.
- 12. First aid equipment and material is available on the premises.
- 13. The premises complies with the smoking charter.
- Downstairs windows are kept closed during opening hours.
- 15. No unaccompanied children are allowed. Accompanied children must be off the premises by 20:00 hours.
- A permanent residual current device (RCD) must protect electrical supply serving musical equipment.
- 17. No striptease, no nudity
- 18. Live music, amplified or acoustic, is limited to 2 performers.

This emailed representation is made in accordance with the agreement with the Licensing Authority on the 18th October 2006 to accept representations by email.

I wish to object to the above application on grounds of public nuisance. I am currently investigating allegations of statutory noise nuisance arising form this premises. The complaints concern both music breakout from the premises late at night and noise from patrons outside on the street smoking and waiting for taxis. I have visited the premises and spoken with the DPS and advised him of the complaints and the need for sound attenuation.

The premises require upgrading with respect to sound attenuation, there are gaps under the doors, no effective lobby and the windows are single glazed.

Prior to the current DPS there was no amplified music played at the premises, there was only acoustic music in the rear room at weekends. Complaints were received about noise in the street but not about music breakout.

A planning application was received for the conversion of 3 Bailey Street into residential accommodation several years ago. The noise survey revealed that should the residential development be granted without sound attenuation works to the pub and the proposed residential accommodation the future occupiers would suffer disamenity and possibly statutory noise nuisance. The residential development was granted consent with conditions requiring sound attenuation; however the consent was superseded by an application to convert the building into a laboratory. Should the applicant wish to amend the application or has further information which could assist me in assessing the application for preventing public nuisance, then of course I shall be happy to discuss the application further.

Objection to Licensing application by Dog & Partridge, 56 Trippet Lane, S1 4EL:

I am objecting to application on the grounds of the prevention of crime and disorder, the prevention of public nuisance and public safety.

The premises are directly opposite 28 apartments at the two joined West Point blocks at 33 & 35 Trippet Lane. Next door to the 33 block is Anglo Works, a student block with about 100 residents in about 13 apartments. Those apartments in Anglo Works surround "Maggie May's", a "50s to 80s" music bar which residents have had little disturbance from since it opened in the last year. Prior to that they suffered with the previous bar Alibi with some serious disturbance and incidents with planning conditions flouted.

Across the road 60–90 yards away is Cubana which also has a lot of recorded or live music but which slides open its big french windows on many days and evenings, especially in the summer, allowing noise breakout. This happens every Saturday from 12.30 to 5 pm when the french windows are all opened, the front door is propped open and people come and go through the french windows during the very popular dance classes. Residents hear the shouted instructors instructions and cheering of participants all afternoon. Unlike an increasing number of city centre bars and restaurants, Cubana also opens on Sundays so residents on Trippet Lane suffer noise during days and evenings throughout weekends.

To the other side, also about 60-90 yards away, are the Grapes pub and Dada bar which opens until 0030 at weekends. Residents have not mentioned issues with either of these to me.

For decades, the Dog & Partridge was an Irish pub with a reputation for acoustic sessions in the back room. That Irish pub format has now been moved about 80 yards away to The Grapes. The pub then had new managers for a few months before the current management team came in. The small number of plastic seats and tables outside have remained throughout, continuing a long standing tradition of outdoor pavement drinking from lunchtimes onwards. There is only a front entrance to the pub onto the pavement on Trippet Lane.

The target clientele has now changed with rock nights and karaoke advertised. For Tramlines 2012 they advertise a Rock DJ until 2.30 on Saturday and open mic night to 2pm on Sunday. This application seeks to remove condition 18 "live music, amplified or acoustic, is limited to 2 performers." The signs are that the managers want it to become a late night live or recorded music bar rather than a traditional pub with pub hours.

West Point apartments have good soundproofing provided their windows are closed. However, like everyone they have a need to open windows, especially in the summer. And it appears that noise from the Dog & Partridge is now at new leakout levels which is impacting residents.

I received this e-mail from a West Point resident on 29 June. The resident was unaware then that this application had been submitted. They also want to remain anonymous due to issues involving

previous managers of the Dog & Partridge when they raised issues with them. It has been brought to the attention of Licensing and the police are now following it up:

"I would be grateful if you could help with this. The Dog & Partridge is under new management and over the last few weeks there has been so much noise. There are drinkers outside the pub every night sometimes until the early hours and they make alot of noise. Also, I have clearly heard foul language on several occasions.

There is noise during the early hours, between 1am and 3am when customers and staff leave by taxi. We have to put up with taxis leaving their engines running, radios playing and customers making a lot of noise when they leave. I have not had a decent night's sleep for weeks.

Over the past few weeks they have had live music and DJs and karaoke singers using microphones and this can clearly be heard in my apartment. Fonight there is loud (live music) - far too loud.

There are restrictions in place at Maggie May's to restrict noise outbreak and customers drinking outside so why are there not similar restrictions in place for the Dog & Partridge? - after all they are directly opposite the West Point development and it is impossible to get away from the noise intrusion.

I had a conversation with Louise Thomas about 18 months ago when a previous licensee moved out of the D&P and asked if the new licensee could be told not to have drinkers outside. Can Louise please look into this?

Can someone please get this noise stopped? It is unreasonable of the licensee to expect residents at West Point to put up with it.

Grateful for anything you can do to help."

This e-mail sums up the issues that I ask Licensing to consider. A tradition of on street drinking that may be quiet and friendly at lunchtime but which brings an increasing risk of noise and antisocial behaviour if allowed to continue into the evening and beyond midnight. A live music and karaoke bar that lacks noise attenuation and which is not doing enough to keep noise within the bar. Or consider its neighbours.

The Dog & Partridge is attracting customers to noisy events suitable for a pub with pub hours where the noise all ends before midnight. I understand that Planning permissions do not apply as the pub pre dates their inception. If it has the powers to do so, Licensing need to look closely at the on street activity at these premises and measures to discourage it. And examine what noise attenuation is required and what must be done to stop noise breakout from the premises.

There are clear concerns about the operation of the pub in recent months. I believe it would totally inappropriate to extend hours at this time. I also believe that the current hours are as late as can be expected to be tolerated by West Point residents, even if the premises were well run in the future by managers who seek to be good neighbours. The managers have a number of issues on which they have to prove themselves and which the council and police need to be reassured on.

So I confirm my objection to this application on the grounds of the prevention of crime and disorder, the prevention of public nuisance and public safety. I also object to the removal of condition 18 – the premises are not currently suitable for live music bands.

We would like to object to the application to extend the hours of the Dog & Partridge pub at 56 Trippet Lane, S1 4EL.

We understand that Trippet Lane is a city centre street, and accept occasional noise from traffic and people walking by, but the recent noises throughout some nights coming from the Dog & Partridge pub goes beyond this and has been on the increase following its recent new management.

Due to the type of premises, it doesn't have a beer garden. This results in groups of customers smoking and drinking on the front pavement which is almost under our bedroom window. They can already become quite rowdy and loud, stopping us from opening our bedroom windows at night to prevent smoke and noise entering our room. This has all been on their current opening license. If they were to obtain extended hours it would lead to the clientèle becoming more inebriated which could lead to them becoming louder, more boisterous, and potentially bring more violence on our street.

We have already complained to Sheffield Environment Health through the 101 service regarding noise on Friday & Saturday nights from their music/DJ system going on until almost 1am. The noise consists of elevated bass settings, hearing DJ "MC'ing" and occasionally being able to hear a song clearly. We know that we are not the only residents on Trippet Lane to have complained about this, leading to the Environmental Health Service themselves to object to these plans.

Trippet Lane could almost be classed as a residential street, with 3 blocks of flats directly on Trippet Lane containing at least 12 apartments each, as well as flats further behind as part of the West Point complex. We understand that there have also been plans submitted for land at the end of Trippet Lane to be made into more flats. We have enjoyed living on Trippet Lane for over 2 years, but if these extended hours become a reality then it will result in a knock-on affect to residents health and stress levels and potentially lead to residents moving out, leaving empty flats in the middle of the city centre.

Right of attendance, assistance and representation

15. Subject to regulations 14(2) and 25, a party may attend the hearing and may be assisted or represented by any person whether or not that person is legally qualified.

Representations and supporting information

16. At the hearing a party shall be entitled to -

- (a) in response to a point upon which the authority has given notice to a party that it will want clarification under regulation 7(1)(d), give further information in support of their application, representations or notice (as applicable),
- (b) if given permission by the authority, question any other party; and

(c) address the authority

Failure of parties to attend the hearing

20. – (1) If a party has informed the authority that he does not intend to attend or be represented at a hearing, the hearing may proceed in his absence.

(2) If a party who has not so indicated fails to attend or be represented at a hearing the authority may:—

(a) where it considers it to be necessary in the public interest, adjourn the hearing to a specified date, or

(b) hold the hearing in the party's absence.

- (3) Where the authority holds the hearing in the absence of a party, the authority shall consider at the hearing the application, representations or notice made by that party.
- (4) Where the authority adjourns the hearing to a specified date it must forthwith notify the parties of the date, time and place to which the hearing has been adjourned.

Procedure at hearing

- 21. Subject to the provisions of the Regulations, the authority shall determine the procedure to be followed at the hearing.
- 22. At the beginning of the hearing, the authority shall explain to the parties the procedure which it proposes to follow at the hearing and shall consider any request made by a party under regulation 8(2) for permission for another person to appear at the hearing, such permission shall not be unreasonably withheld.
- 23. A hearing shall take the form of a discussion led by the authority and cross-examination shall not be permitted unless the authority considers that cross-examination is required for it to consider the representations, application or notice as the case may require.
- 24. The authority must allow the parties an equal maximum period of time in which to exercise their rights provided for at regulation 16.
- 25. The authority may require any person attending the hearing who in their opinion is behaving in a disruptive manner to leave the hearing and may –

(a) refuse to permit that person to return, or

(b) permit him to return only on such conditions as the authority may specify, but such a person may, before the end of the hearing, submit to the authority in writing any information which they would have been entitled to give orally had they not been required to leave.



<u>Licensing Act 2003 – Hearing Procedure – Regulation 7 (1)</u>

This procedure has been drawn up in accordance with the Licensing Act 2003 to assist those parties attending Licensing Committee hearings.

- 1. The hearing before the Council is Quasi Judicial.
- 2. The Chair of the Licensing Committee will introduce the Committee and ask officers to introduce themselves.
- 3. The Chair will ask the applicants to formally introduce themselves.
- 4. The Solicitor to the Committee will outline the procedure to be followed at the hearing.
- 5. Hearing Procedure:-
 - (a) The Licensing Officer will introduce the report.
 - (b) Questions concerning the report can be asked both by Members and the applicant.
 - (c) The Licensing Officer will introduce in turn representatives for the Responsible Authority and Interested Parties who will be asked to detail their relevant representations.
 - (d) Members may ask questions of those parties
 - (e) With the leave of the Chair the applicant or his representative may cross examine the representatives of the Responsible Authorities and Interested Parties.
 - (f) The applicant/licensee (or his/her nominated representative) will then be asked to:-
 - (i) detail the application;
 - (ii) provide clarification on the application and respond to the representations made.
 - (g) The applicant/licensee (or his/her nominated representative) may then be asked questions by members and with the leave of the Chair from the other parties present.
 - (h) The applicant will then be given the opportunity to sum up the application.
 - (i) The Licensing Officer will then detail the options.
 - (j) There will then be a private session for members to take legal advice and consider the application.
- 6. The decision of the Licensing Committee will be given in accordance with the requirements of the Licensing Act 2003 and regulations made there under.
- NB: 1) At any time in the Licensing Process Members of the Committee may request legal advice from the Solicitor to the Committee. This advice may be given in open session or in private.
 - 2) The Committee Hearing will be held in public unless and in accordance with the Regulations the Committee determine that the public should be excluded.

- (1) A party shall give to the authority within the period of time provided for in the following provisions of this regulation a notice stating

- (3) In the case of a hearing under -

 - (b) section 105(2)(a) (counter notice following police objection to temporary event notice),

the party shall give the notice no later than one working day before the day or the first day on which the hearing is to be held.

- (4) In the case of a hearing under -
