ADVICE TO MEMBERS ON DECLARING INTERESTS AT MEETINGS

New standards arrangements were introduced by the Localism Act 2011. The new regime made changes to the way that members' interests are registered and declared.

If you are present at a meeting of the Council, of its executive or any committee of the executive, or of any committee, sub-committee, joint committee, or joint sub-committee of the authority, and you have a **Disclosable Pecuniary Interest** (DPI) relating to any business that will be considered at the meeting, you must <u>not</u>:

- participate in any discussion of the business at the meeting, or if you become aware of your Disclosable Pecuniary Interest during the meeting, participate further in any discussion of the business, or
- participate in any vote or further vote taken on the matter at the meeting.

These prohibitions apply to any form of participation, including speaking as a member of the public.

You must:

- leave the room (in accordance with the Members' Code of Conduct)
- make a verbal declaration of the existence and nature of any DPI at any meeting at which you are present at which an item of business which affects or relates to the subject matter of that interest is under consideration, at or before the consideration of the item of business or as soon as the interest becomes apparent.
- declare it to the meeting and notify the Council's Monitoring Officer within 28 days, if the DPI is not already registered.

If you have any of the following pecuniary interests, they are your **disclosable pecuniary interests** under the new national rules. You have a pecuniary interest if you, or your spouse or civil partner, have a pecuniary interest.

- Any employment, office, trade, profession or vocation carried on for profit or gain, which you, or your spouse or civil partner, undertakes.
- Any payment or provision of any other financial benefit (other than from your council or authority) made or provided within the relevant period* in respect of any expenses incurred by you in carrying out duties as a member, or towards your election expenses. This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992.

Page 1

- *The relevant period is the 12 months ending on the day when you tell the Monitoring Officer about your disclosable pecuniary interests.
- Any contract which is made between you, or your spouse or your civil partner (or a body in which you, or your spouse or your civil partner, has a beneficial interest) and your council or authority -
 - under which goods or services are to be provided or works are to be executed; and
 - o which has not been fully discharged.
- Any beneficial interest in land which you, or your spouse or your civil partner, have and which is within the area of your council or authority.
- Any licence (alone or jointly with others) which you, or your spouse or your civil partner, holds to occupy land in the area of your council or authority for a month or longer.
- Any tenancy where (to your knowledge) -
 - the landlord is your council or authority; and
 - the tenant is a body in which you, or your spouse or your civil partner, has a beneficial interest.
- Any beneficial interest which you, or your spouse or your civil partner has in securities of a body where -
 - (a) that body (to your knowledge) has a place of business or land in the area of your council or authority; and
 - (b) either -

the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you, or your spouse or your civil partner, has a beneficial interest exceeds one hundredth of the total issued share capital of that class.

If you attend a meeting at which any item of business is to be considered and you are aware that you have a **personal interest** in the matter which does not amount to a DPI, you must make verbal declaration of the existence and nature of that interest at or before the consideration of the item of business or as soon as the interest becomes apparent. You should leave the room if your continued presence is incompatible with the 7 Principles of Public Life (selflessness; integrity; objectivity; accountability; openness; honesty; and leadership).

You have a personal interest where -

 a decision in relation to that business might reasonably be regarded as affecting the well-being or financial standing (including interests in land and easements over land) of you or a member of your family or a person or an organisation with whom you have a close association to a greater extent than it would affect the majority of the Council Tax payers, ratepayers or inhabitants of the ward or electoral area for which you have been elected or otherwise of the Authority's administrative area, or

• it relates to or is likely to affect any of the interests that are defined as DPIs but are in respect of a member of your family (other than a partner) or a person with whom you have a close association.

Guidance on declarations of interest, incorporating regulations published by the Government in relation to Disclosable Pecuniary Interests, has been circulated to you previously, and has been published on the Council's website as a downloadable document at -http://councillors.sheffield.gov.uk/councillors/register-of-councillors-interests

You should identify any potential interest you may have relating to business to be considered at the meeting. This will help you and anyone that you ask for advice to fully consider all the circumstances before deciding what action you should take.

In certain circumstances the Council may grant a **dispensation** to permit a Member to take part in the business of the Authority even if the member has a Disclosable Pecuniary Interest relating to that business.

To obtain a dispensation, you must write to the Monitoring Officer at least 48 hours before the meeting in question, explaining why a dispensation is sought and desirable, and specifying the period of time for which it is sought. The Monitoring Officer may consult with the Independent Person or the Council's Standards Committee in relation to a request for dispensation.

1. APOLOGIES FOR ABSENCE

1.1 Apologies for absence were received from Councillors Martin Lawton and Nikki Sharpe.

2. EXCLUSION OF PUBLIC AND PRESS

2.1 RESOLVED: That the public and press be excluded from the meeting before discussion takes place on item 6 on the grounds that, if the public and press were present during the transaction of such business, there would be a disclosure to them of exempt information described in paragraphs 1, 2 and 3 of Schedule 12A to the Local Government Act 1972, as amended.

3. DECLARATIONS OF INTEREST

3.1 The Chair (Councillor Chris Rosling-Josephs) declared an interest in Case No. UTC1 and did not take part in the consideration of this appeal.

4. MINUTES OF PREVIOUS MEETING

4.1 The minutes of the meeting of the Committee held on 20th November, 2013 were approved as a correct record.

Matters Arising

- 4.2 The Chair reported that he had met with John Bigley, Admissions Manager, Children, Young People and Families Service and had asked for clarity with regard to the policy surrounding home to school travel passes regarding the University Technical College (UTC). The Chair informed Members that the Policy states that any applications for UTC are treated as "parental choice" and that many pupils will not be within the catchment area. He added that parents are to be given a copy of the Policy when applying for a place at the College and that no free home to school passes will be granted. However, the College may provide a bursary. Members of the Committee requested that this information be loaded onto the Council's website.
- 4.3 With regard to Case No.MEAD1, which had been considered at previous meetings, the Chair informed the Committee that he had met with John Bigley, Admissions Manager, Children, Young People and Families Service and that Mr. Bigley had apologised that the decision to overturn the Committee's decision had been done without consultation with the Committee. Due to Members of the Committee expressing its displeasure regarding this matter, it has been decided

that any further reviews required to be undertaken of decisions of the Committee are brought back to Committee for its reconsideration.

- 4.4 RESOLVED: That (a) the information now reported be noted; and
 - (b) officers be requested to publish on the Council's website the policy regarding home to school travel passes relating to the University Technology College.

5. ACTION TAKEN UNDER DELEGATED POWERS

5.1 The Committee noted that, since its last meeting, no decisions had been made by the Executive Director, Children, Young People and Families, in consultation with the Chair of the Committee, under powers delegated to her with regard to home to school transport or school admissions.

6. HOME TO SCHOOL TRANSPORT APPEALS

- 6.1 The Executive Director, Children, Young People and Families, submitted reports and commented upon 25 cases where parents had appealed against the administrative decisions made by the Executive Director with regard to the refusal to grant home to school travel bus passes.
- The Committee gave consideration to all the supporting information and evidence provided by the pupils' parents including, in some cases, evidence and advice provided by voluntary or professional bodies and organisations and, arising therefrom, it was:-
- RESOLVED: That (a) 18 appeals be not upheld on the grounds that there are no exceptional circumstances demonstrated and, having regard to the Council's Home to School Transport Policy, (i) the school that eight of the pupils are requesting a pass for is not their catchment school/nearest suitable school (Case Nos. HUN1, HUN2, ALL1, ALL2, KIEC2, NOT1, UTC1 and DEFRIV1), (ii) the distance from the home address of seven of the pupils to the schools for which they are requesting a pass for is less than the distance in the criteria (Case Nos. PAR1, PAR2, KIED2, NEW1, NEW2, YEW1 and YEW2) and (iii) three of the pupils do not attend one of their three nearest qualifying schools (Case Nos. CIT1, KIEC1 and KIED1);
 - (b) one appeal be upheld on the grounds that there are exceptional medical and family circumstances in the case with a letter of support and medical evidence being received from the family's GP (Case No. LGO-ALLS2);
 - (c) five appeals be upheld on a termly basis, on the grounds that there are either exceptional educational, financial, medical or family circumstances in the cases (Case Nos. WYB1, CIT2, HIND1, SPR1 and MBR1def); and
 - (d) a decision on the remaining appeal be deferred to enable the Executive Director, Children, Young People and Families to make further investigations into the case, along the lines now requested, and authority be given to the Executive Director, in consultation with the Chair of the Committee, to determine the appeal

(Case No. PARK1).

(NOTE: (i) In accordance with Council Procedure Rule 26 of the Council's Constitution and the provisions of Section 100B(4)(b) of the Local Government (Access to Information) Act 1985, the Chair decided that one of the above appeals (Case No.MBR1def) be considered as a matter of urgency in order for the appeal to be considered at the earliest possible opportunity, although it had not been possible to give five clear days' notice that the appeal was to be considered; and (ii) during the consideration of Case No. UTC1, in which the Chair declared an interest, Councillor lan Saunders took the Chair).

7. DATE OF NEXT MEETING

7.1 It was noted that the next meeting of the Committee will be held on Wednesday, 15th January, 2014 at 1.00 p.m. at Howden House.
