### ADVICE TO MEMBERS ON DECLARING INTERESTS AT MEETINGS

If you are present at a meeting of the Council, of its executive or any committee of the executive, or of any committee, sub-committee, joint committee, or joint sub-committee of the authority, and you have a **Disclosable Pecuniary Interest** (DPI) relating to any business that will be considered at the meeting, you must not:

- participate in any discussion of the business at the meeting, or if you become aware of your Disclosable Pecuniary Interest during the meeting, participate further in any discussion of the business, or
- participate in any vote or further vote taken on the matter at the meeting.

These prohibitions apply to any form of participation, including speaking as a member of the public.

### You must:

- leave the room (in accordance with the Members' Code of Conduct)
- make a verbal declaration of the existence and nature of any DPI at any
  meeting at which you are present at which an item of business which affects or
  relates to the subject matter of that interest is under consideration, at or before
  the consideration of the item of business or as soon as the interest becomes
  apparent.
- declare it to the meeting and notify the Council's Monitoring Officer within 28 days, if the DPI is not already registered.

If you have any of the following pecuniary interests, they are your **disclosable pecuniary interests** under the new national rules. You have a pecuniary interest if you, or your spouse or civil partner, have a pecuniary interest.

- Any employment, office, trade, profession or vocation carried on for profit or gain, which you, or your spouse or civil partner undertakes.
- Any payment or provision of any other financial benefit (other than from your council or authority) made or provided within the relevant period\* in respect of any expenses incurred by you in carrying out duties as a member, or towards your election expenses. This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992.

\*The relevant period is the 12 months ending on the day when you tell the Monitoring Officer about your disclosable pecuniary interests.

- Any contract which is made between you, or your spouse or your civil partner (or a body in which you, or your spouse or your civil partner, has a beneficial interest) and your council or authority –
  - under which goods or services are to be provided or works are to be executed; and
  - which has not been fully discharged.

- Any beneficial interest in land which you, or your spouse or your civil partner, have and which is within the area of your council or authority.
- Any licence (alone or jointly with others) which you, or your spouse or your civil
  partner, holds to occupy land in the area of your council or authority for a month
  or longer.
- Any tenancy where (to your knowledge)
  - the landlord is your council or authority; and
  - the tenant is a body in which you, or your spouse or your civil partner, has a beneficial interest.
- Any beneficial interest which you, or your spouse or your civil partner has in securities of a body where -
  - (a) that body (to your knowledge) has a place of business or land in the area of your council or authority; and
  - (b) either -
    - the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or
    - if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you, or your spouse or your civil partner, has a beneficial interest exceeds one hundredth of the total issued share capital of that class.

If you attend a meeting at which any item of business is to be considered and you are aware that you have a **personal interest** in the matter which does not amount to a DPI, you must make verbal declaration of the existence and nature of that interest at or before the consideration of the item of business or as soon as the interest becomes apparent. You should leave the room if your continued presence is incompatible with the 7 Principles of Public Life (selflessness; integrity; objectivity; accountability; openness; honesty; and leadership).

You have a personal interest where -

- a decision in relation to that business might reasonably be regarded as affecting
  the well-being or financial standing (including interests in land and easements
  over land) of you or a member of your family or a person or an organisation with
  whom you have a close association to a greater extent than it would affect the
  majority of the Council Tax payers, ratepayers or inhabitants of the ward or
  electoral area for which you have been elected or otherwise of the Authority's
  administrative area, or
- it relates to or is likely to affect any of the interests that are defined as DPIs but are in respect of a member of your family (other than a partner) or a person with whom you have a close association.

Guidance on declarations of interest, incorporating regulations published by the Government in relation to Disclosable Pecuniary Interests, has been circulated to you previously.

You should identify any potential interest you may have relating to business to be considered at the meeting. This will help you and anyone that you ask for advice to fully consider all the circumstances before deciding what action you should take.

In certain circumstances the Council may grant a **dispensation** to permit a Member to take part in the business of the Authority even if the member has a Disclosable Pecuniary Interest relating to that business.

To obtain a dispensation, you must write to the Monitoring Officer at least 48 hours before the meeting in question, explaining why a dispensation is sought and desirable, and specifying the period of time for which it is sought. The Monitoring Officer may consult with the Independent Person or the Council's Standards Committee in relation to a request for dispensation.

# REPORT OF THE CHIEF LICENSING OFFICER, HEAD OF LICENSING, TO THE LICESNING SUB COMMITTEE.

### **LICENSING ACT 2003 – 88/15**

### Summary Review of Premises Licence: Serious Crime and Disorder

### Viper Lounge/Viper Rooms, 35&35a Carver Street, Sheffield, S1 4FS.

### 1.0 PURPOSE OF REPORT

- 1.1 To consider an application for the summary review of a premises licence made under Section 53A of the Licensing Act 2003 in relation to the premises known as Viper Lounge/Viper Rooms, 35&35a Carver Street, Sheffield, S1 4FS.
- 1.2 A copy of the current premises licence is attached at Appendix 'A'.
- 1.3 A meeting was held on 29<sup>th</sup> October 2015 to give consideration as to whether it was necessary to take interim steps following the application for Summary Review of the premises licence received on 28<sup>th</sup> October 2015. A copy of an email sent to the premises licence holders solicitors on 29<sup>th</sup> October 2015 detailing the interim steps taken is attached at Appendix 'B'.
- 1.4 The Premises Licence holder made representation against the decision of the Licensing Sub Committee at the meeting held on the 29<sup>th</sup> October 2015 and therefore a further meeting was held on 2<sup>nd</sup> November 2015 to consider the representations. Prior to the meeting, the premises licence holder presented a document entitled "Viper rooms management action plan", which was circulated to the parties to the hearing. A copy of the aforementioned plan is attached at Appendix 'C'. Attached at Appendix 'D' to the report is a copy of the decision of the Licensing Sub Committee of the Council at the hearing on 2<sup>nd</sup> November 2015.

### 2.0 THE APPLICATION

- 2.1 The applicant is South Yorkshire Police.
- 2.2 The application and certificate, which were received on 28<sup>th</sup> October 2015, are attached to this report labelled Appendix 'E'.
- 2.3 The grounds for the review are that in the opinion of a senior police officer, the premises are associated with serious crime or disorder or both.
- 2.4 The application form details further the grounds for review.

### 3.0 REASONS FOR REFERRAL

3.1 The Licensing Authority must under the Act refer any application for review made under section 53A to the Licensing Board.

- 3.2 The Licensing Authority has, during the representation period received representations from the following:
  - a) South Yorkshire Police Appendix 'F'
- 3.3 The chief officer of police who made the application, the Premises Licence Holder and any other person that has made representations have been invited to attend the hearing.

### 4.0 FINANCIAL IMPLICATIONS

4.1 There are no specific financial implications arising from this application. However additional costs may be incurred should the matter go to appeal. In such an eventuality it may not be possible to recover all these costs. The impact of these additional costs (if any) will be kept under review and may be subject of a further report during the year.

### 5.0 THE LEGAL POSITION

- 5.1 Section 53A of the 2003 Act as amended by the Violent Crime Reduction Act 2006 and The Licensing Act 2003 (Summary Review of Premises Licences) Regulations 2007 came into force on 1 October 2007
- 5.2 The new procedures allow a quick process for attaching interim conditions to a licence and a fast track licence review when the police consider that the premises concerned is associated with serious crime or serious disorder (or both).
- 5.3 The Licensing Act 2003 at section 53A requires that the Licensing Authority must-
  - (a) hold a hearing to consider the application for the review and any relevant representations;
  - (b) take such steps mentioned in subsection (3) (if any) as it considers necessary for the promotion of the licensing objectives; and
  - (c) secure that, from the coming into effect of the decision made on the determination of the review, any interim steps having effect pending that determination cease to have effect (except so far as they are comprised in steps taken in accordance with paragraph (b)).
- 5.4 Section 53C(3) states:

"The steps are -

- a) The modification of the conditions of the premises licence:
- b) The exclusion of a licensable activity from the scope of the licence;
- c) The removal of the designated premises supervisor from the licence;
- d) The suspension of the licence for a period not exceeding three months; or
- e) The revocation of the licence.
- (4) For the purpose of subsection (3)(a) the conditions of a premises licence are modified if any of them is altered or omitted or any new condition added."
- 5.5 If members decide to take the steps referred to in (a) or (b) above, it may provide that the modification or exclusion is to have effect only for a specified period (not exceeding three months).

- 5.6 The Licensing At 2003 at section 53C(11) states that:
  - "A decision under this section does not have effect until -
  - a) the end of the period given for appealing against the decision, or
  - b) if the decision is appealed against, the time the appeal is disposed of."
- 5.7 The Licensing Act 2003 at section 4(1) requires the Licensing Authority to carry out its functions with a view to promoting the Licensing Objectives which section 4(2) sets out as:
  - a) the prevention of crime and disorder,
  - b) public safety,
  - c) the prevention of public nuisance,
  - d) the protection of children from harm.
- 5.8 Section 4(3) of the Licensing Act also requires the Licensing Authority to have regard to the published statement of the Licensing Policy and any guidance issued by the Secretary of State under Section 182.

### 6.0 HEARINGS REGULATIONS

- 6.1 Regulations governing hearings under the Licensing Act 2003 have been made by the Secretary of State.
- The Licensing Authority has provided all parties with the information required in the Regulations to the 2003 Act as set out at Appendix 'G'.
- 6.3 Attached at Appendix 'G' is the following:
  - a) a copy of the Notice of Hearing;
  - b) the rights of a party provided in Regulations 15 and 16;
  - c) the consequences if a party does not attend or is not represented at the hearing
  - d) the procedure to be followed at the hearing.

### 7.0 APPEALS

7.1 The Licensing Act 2003 section 181 and Schedule 5 makes provision for appeals to be made by the applicant; the holder of the premises licence and those making representations against decisions of the Licensing Authority to the Magistrates Court.

### 8.0 RECOMMENDATIONS

8.1 That members carefully consider the application for review along with any other representations made and take such steps as detailed in paragraph 5.4 above that the Board consider necessary for the promotion of the Licensing Objectives.

### 9.0 OPTIONS OPEN TO THE BOARD

- 9.1 To authorise the Chief Executive of Legal and Governance to:
  - a) modify the conditions of the licence;
  - b) exclude a licensable activity from the scope of the licence;
  - c) remove the designated premises supervisor for the licence;
  - d) suspend the licence for a period not exceeding three months; or
  - e) revoke the licence.

### **Annex 1A - Mandatory Conditions**

### Mandatory Condition 1 (Section 19 ss 2)

Where a licence authorises the sale of alcohol then no supply of alcohol may be made under the premises licence –

- (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
- (a) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

### Mandatory Condition 2 (Section 19 ss 3)

Where a licence authorises the sale of alcohol then every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

### Mandatory Condition 3 (Section 20)

- 1. Where a premises licence authorises the exhibition of films, the licence includes the following conditions relating to the admission of children to the exhibition:
  - (a) The admission of children (under 18) to the exhibition of any film must be restricted in accordance with the classification set by the film classification body (currently the BBFC).
  - (a) In a case where there is no classification given by the classification body (the BBFC) the admission of children to the exhibition of any film must be restricted in accordance with any recommendation given by the Licensing Authority.
- 2. In this section -
  - "children" means persons aged under 18; and
  - "film classification body" means the person or persons designated as the authority under section 4 of the Video Recordings Act 1984 (c.39) (authority to determine suitability of video works for classification).

#### Mandatory Condition 4 (Section 21)

Where a premises licence includes a condition that at specified times one or more individuals must be at the premises to carry out a security activity each such individual must be licensed by the Security Industry Authority.

### Annex 1B - Mandatory Conditions effective from 6th April 2010:

These mandatory conditions apply where the licence authorises the supply of alcohol. The conditions in paragraph 1 to 3 do not apply where the licence authorises the sale by retail or supply of alcohol only for consumption off the premises.

- 1. (1) The responsible person shall take all reasonable steps to ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
  - (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises in a manner which carries a significant risk of leading or contributing to crime and disorder, prejudice to public safety, public nuisance, or harm to children—
    - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to—

- (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
- (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic (other than any promotion or discount available to an individual in respect of alcohol for consumption at a table meal, as defined in section 159 of the Act);
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less:
- (d) provision of free or discounted alcohol in relation to the viewing on the premises of a sporting event, where that provision is dependent on—
  - (i) the outcome of a race, competition or other event or process, or
  - (ii) the likelihood of anything occurring or not occurring;
- (e) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.
- 2. The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
- 3. The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.

### Annex 1C - Mandatory Conditions effective from 1st October 2010:

These mandatory conditions apply were the licence authorises the supply of alcohol. The condition 5 does not apply where the licence authorises the sale by retail or supply of alcohol only for consumption off the premises.

- 4. (1) The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.
  - (2) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.
- 5. The responsible person shall ensure that-
  - (a) Where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—
    - (i) beer or cider: ½ pint;
    - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
    - (iii) still wine in a glass: 125 ml; and
  - (b) Customers are made aware of the availability of these measures.



### Annex 2 - Conditions consistent with the operating schedule

- 1. The fire exit doors on to Carver Lane shall only be used as disabled access or as an emergency exit and shall not at any other time be propped open.

- (d) provision of free or discounted alcohol in relation to the viewing on the premises of a sporting event, where that provision is dependent on-

# APPENDIX C

## **Viper Rooms Management Action Plan**

The following actions were agreed following a meeting of Paul Kinsey and Dave Burgess with the police on Wednesday October 14<sup>th</sup>

- 1. Tuesday Risqué session to close immediately
- 2. New session to be launched on Tuesday 28thOctober
- 3. 1 in 15 customers will be searched with emphasis on males
- 4. Records of searches to be kept
- 5. Only NUS will be admitted to the session and promoter staff and networkers
- 6. Music policy to be house music led

### Additional actions implemented on 29th October

The only incident on the Tuesday 27<sup>th</sup> October was involving 2 female students. There were a significant number of refusals to entry at the front door.

The change in drinks sales mix clearly showed a different profile of audience to the Risqué sessions, although further steps are required to eliminate NUS card holders who may pose a risk.

The only glasses served that were not polycarbonate were champagne glasses.

Following a meeting with the police PK has proposed that the following further actions are taken

#### Admission policy

- 1. The front door admission policy will be reviewed to modify the NUS only policy to increase strictness on broader criteria, as both girls on Tuesday were students.
- 2. 1:15 search policy to be maintained and voluntary licence condition has been submitted

#### Internal supervision

- 1. An internal head door person position will be created who will take responsibility for the door-staff inside the venue which will further increase supervision levels
- 2. Doorstaff/customer ratio will be held at a new ratio of 1:70
- 3. All support management will be placed on an SIA training course within 6 weeks.
- 4. For the first weeks post re opening Paul Kinsey will attend the session along with another qualified DPS from the company to review the detail of the operation in terms of:
  - Audience quality
  - Music policy
  - Internal door supervision
  - Quality of support management supervision skills

#### General housekeeping

Following this process of weekly review the management action plan will be updated weekly to highlight and eradicate any residual risk issues

- 5. Music policy will be further adapted to maintain a light hearted feel to the room
- 6. Only poly carbonate glass will be used on the Tuesday session.
- 7. Only PET bottle beers will be served on a Tuesday night.
- 8. There has never been a bottle related incident on any night so it is proposed to serve champagne and bottles of spirit in the VIP area only which is supervised by 4 waitresses and a specific door supervisor. All glassware in VIP will be PET. This will ensure that the 'top end' of the market is not alienated.

#### Dispersal

- Doorstaff will ensure that customers that are exiting the building are encouraged actively to move away from the building and not congregate outside the gates. Also they will be encouraged actively to behave in a respectful and considerate manner
- 2. Internal dispersal will be supervised by the internal head door person and one of the senior venue management
- 3. Dispersal will be deliberately staggered over the 30 minutes post closure to allow orderly dispersal and minimize congregation outside.

# Decision of Licensing Sub-Committee 2nd November 2015 – Viper Rooms/Viper Lounge

Licensing Sub-Committee considered an application made by South Yorkshire Police for review of the premises licence issued to Viper rooms/ Viper Lounge, 35 & 35a Carver Street, Sheffield, S1 4FS. The review application was made under section 53A of the Licensing 2003, the ground being that, in the view of the South Yorkshire Police, the premises are associated with serious crime and disorder or both.

At the Interim Steps hearing on 28<sup>th</sup> October 2015 interim steps were imposed. Those steps were:

- 1. Licensable activities to be suspended on Tuesday
- 2. Risque or Luau night not to take place on another night of the week

South Yorkshire Police attended and submitted that Tuesday nights at the Viper Rooms were the problem. The issues have developed and the people attending have become less desirable. The Police stated that the Premises have fully cooperated and have attended meetings with the Police in an effort to resolve the problems. The premises volunteered to close and rebrand the night. The voluntary closure was for one night and it reopened on the 28<sup>th</sup> October as a NUS only night. At the end of the night a female was glassed and the Police officers attending reported a very hostile environment. They also reported lots of glass on the floor, more than a few champagne glasses worth.

In the opinion of South Yorkshire Police the premises needs to have a break on a Tuesday to lose the aggressive group who have started attending, partly from out of town, however submitted that it would be helpful for the premises to open before the review hearing so that the new management plans can be operated successfully.

The premises addressed the committee and detailed their operation with the experienced team employed. They asked that the current interim steps be lifted as it doesn't allow the premises to deal with the problems.

The premises took full responsibility for the issues but submitted that the stabbings were a one-off incident. There were then no issues until a high profile DJ was booked and it attracted an undesirable crowd from out of town. On the 28<sup>th</sup> October a female was glassed by another female. This incident was reported to the Police by the premises.

The premises submitted that a NUS policy was 'a blunt instrument' as some people who hold a NUS card shouldn't be able to access the venue whereas there were 'nice' people without them. The doorstaff and DPS need to make a judgment on who can get in. This will be supervised until the venue owner is satisfied that they are making the right call.

The premises submitted that some areas of the premises needed to be improved but this wasn't going to be able to happen if they are closed. The concern with closure wasn't commercial but that the management plan will be a work in progress and it would be beneficial to have weeks of trading prior to the review hearing.

In relation to the glass at the premises all drinks, including champagne, are served in plastic glasses.

Members considered all of the evidence and submissions before them and determined to modify the steps taken.

The two steps imposed on 28th October be withdrawn and replaced with:

- 1. Viper Rooms/ Viper Lounge be closed on 3<sup>rd</sup> November 2015
- 2. The new Viper Rooms management Action Plan be adhered to when the premises reopens on Tuesday 10<sup>th</sup> November

The reason for this decision was that members accepted both sides of the argument but felt that the premises did need a break to stop the behaviour becoming 'normalised' and 'embedded' as submitted by the Police however also accepted that it is beneficial to evidence the operation of the premises with the new Management plan.

# WITNESS STATEMENT OF

# Police Inspector Neil MUTCH

1. I am a Police Inspector in the South Yorkshire Police currently stationed at Snig Hill police station within Sheffield City Centre. I have been involved in policing the City Centre for around 20 years at different levels. In 2006 I became the City Centre Inspector responsible for the Safer Neighbourhood Team. From 2010 to 2011 I took over responsibility of the Police Licensing Team until I moved to the Events and Planning Department which involved the safety of the public and the policing of large events across the City. In 2014 I returned as Inspector to the City Centre and remain in this post today. As part of my role I am responsible for the police public order patrols and policing of licensed premises within Sheffield City Centre.

- 2. The premise known as Viper Rooms & Viper Lounge located at 35 & 35a Carver Street is within in the heart of the City Centre. The premises have separate premise licences within the same building and access can be gained through the same entry point. Once inside customers are generally able to walk between the two bars, one located upstairs, the other downstairs.
- 3. Serious incidents had been taking place at the premise previously and intervention work had taken place between the police and the management. Following a further serious incident on the 28<sup>th</sup> of October 2015 it was deemed necessary to apply for an Expedited/Summary review of the premises licence.
- 4. I can say from records in my possession that the following incidents have taken place at the premise over the past few months which have caused the police concerns. Some of the incidents are of a minor nature but there have been incidents of a far more serious nature described as follows:
- 5. At 03.08hrs on Wednesday 9th September 2015 police officers requested further police presence at the Viper Rooms due to lots of people in Carver Street. These people seemed to have spilled out of the premise. There had been an issue with door staff and a group of males. Further officers attended and this resulted in two people being detained for being drunk and disorderly.

 At 2.08hrs on Wednesday 30<sup>th</sup> September 2015 CCTV control room requested police attendance due to a male having been detained by door staff at Viper Rooms after a female had been stabbed.

At 02.16hrs the same date it was reported that the female had already been conveyed to the hospital and that the severity of her injuries at that time was unknown.

At 02.19hrs police officer reports that the female had been transported to the Northern General Hospital by a member of staff at the Viper Rooms. Also a report that there was a further victim, a male, also reported to have been stabbed at that location and was being tended to by a medic.

A third person, a male, was also reporting that he had been stabbed in the hip area and was bleeding heavily.

All three stabbings appeared to have taken place in the upstairs area of the premise.

A male had been detained by members of the door staff at the venue and was subsequently arrested for the offences described.

This defendant is due to stand trial at Sheffield Crown Court in March 2016.

7. At 00.47hrs on Wednesday 14<sup>th</sup> October 2015 report of a female having been assaulted outside the toilet area within the premise by another female. This group of females had been lawfully ejected from the club by door staff and caller stating that the offender was still in the premise. The injured female reported a bruise to her arm, lump on the head, her eyes were sore as drink had been thrown in them.

Door staff were spoken to and stated that a group of females inside had had a disagreement, one was lawfully ejected, once informed the police were attending all parties had left. The investigation is still ongoing.

8. At 02.19hrs on Wednesday 14<sup>th</sup> October 2015 ambulance control reported a 20 year old female had been glassed and had a head injury, she was described as being conscious but not alert.

Officers attended and PC 2012 Rimmer spoke briefly to the injured female prior to her being transported to the NGH by ambulance.

A copy of PC Rimmer's statement is within the review papers.

The investigation is still ongoing and remains undetected at this time.

9. At approximately 01.45hrs on Wednesday 14<sup>th</sup> October 2015 a female reported that she had been outside Viper Rooms with her friend in the smoking area provided when a male known to her has become agitated and pushed the females friend to the floor. The female has tried to assist her friend and the male has punched her in the face knocking her to the floor causing bruising to the left side of her chin, a bruise to her right arm and left shoulder.

Her friend also reports being assaulted by the same male at the same location stating that this male had 'kicked off', grabbed her by the hair and thrown her to the floor before leaving the area.

10. At approximately 03.00hrs on Wednesday 14<sup>th</sup> October 2015 a call is received from the Designated Premises Supervisor (DPS) at Viper Rooms reporting that the premise was due to close and that he had been approached by another customer stating that someone had a knife. This

had not been seen by the DPS but he was concerned due to the premise closing and customers leaving the venue into the street.

Officers attended the scene and spoke with a male and whilst dealing with this male a large crowd has followed. This male was subsequently detained.

PC 134 Thompson has now provided a statement in relation to this incident which is within the review papers.

During this incident a female member of staff reported that she had been assaulted by a male inside the premise. The complainant is a member of staff and stated that throughout the evening a male had been paying her unwanted attention. She had complained to the door staff numerous times about this male's behaviour. Around 03.00hrs, she was stood near him and this male has backhanded her across the face causing pain. He has then left the club and stood at the entrance door. The complainant has pointed the male out to both door staff and the police officers in attendance. He was subsequently arrested and charged with common assault.

11. At approximately 03.45hrs on Wednesday 14th October 2015, officers were already present on Carver Street following disorder there when they witnessed a fight breaking out of Viper Rooms into the street. Officers saw a male swinging punches towards another member of the public and acting aggressively.

The male was detained and due to his demeanour, it was deemed necessary for officers to use PAVA spray to gain compliance with the male.

- 12. At 03.32hrs on Friday 16th October 2015 caller reported that she had been ejected from Viper Rooms and complained that she wanted her money refunding as she had not been inside long. She then alleges that a member of door staff has pushed her and she has fallen over.

  She reports that she has not received any injuries but wanted to report the incident to the police. The incident has been crime recorded as a common assault and as yet there is not update from the officer in the case.
- 13. At 03.10hrs on Wednesday 28th October 2015 via CCTV, staff at the premise were requesting assistance with regards to a female that had been 'glassed' and that the offender may still be inside.

An ambulance had also been requested to attend. Officers attended and an 18-year-old female was seen with an injury to the top of her head stating that someone had thrown a bottle at her.

The complainant described that during the night she had come across the suspect who had been asking for cocaine from customers. Towards the end of the evening, the complainant came out of the toilets where she saw the suspect talking to another person. A minor argument ensued at which point a drink was thrown over the complainant who then threw one back at the suspect before attempting to leave the premise. As she walked out she was struck by a glass round the right side of her forehead causing two minor superficial cuts.

She was treated for her injuries initially by members of staff at the premise.

A female suspect was arrested, handcuffed and placed in the rear of a police vehicle. The arresting officer was concerned for the safety of his colleague so he returned to the premise to assist. Upon his return to the police vehicle the suspect was found to have escaped from the police vehicle.

This investigation is still ongoing and I am unable to fully expand on the circumstances around this matter at this time.

Officers describe attendance at the scene and a statement from PC 2142 Lannie and PC 1238 Uccellini expanding on this can be found within the review papers.

14. Following the interim steps hearing I held a meeting at Snig Hill police station with the management of Viper Rooms, Mr Paul Kinsey and the DPS, Mr David Burgess. Mr Kinsey proposed actions to be taken at the premise on a Tuesday night to ensure the safety of customers. The Licensing Sub-Committee have had sight of these actions at the last hearing on the 2<sup>nd</sup> of November.

I believe that the contents of this statement are true and I understand it may be placed before the court.

I also understand that the contents of this statement may be shared with agencies working in partnership with the South Yorkshire Police.

I turned to my mate and told him I had been stabbed. Grabbing my friend we went to find the doorstaff. I found a doorman straightaway, explained what had happened and he was joined by two colleagues and quickly moving through the club we located the male that had stabbed me.

Blood was pouring down my leg now and upon seeing the male I shouted "What gives you the right to stab me you bastard" by now the doorstaff had grabbed the male and were moving through the club with him. I did not see the male again after that point and I was then taken onto a stairwell out of the way. I had been feeling funny and managed to sit down on a step, eventually I was taken outside the club and as soon as I sat on a wall I passed out and when I eventually came around I was sat by the manager of the Viper Rooms. I must have passed out for around 2 minutes.

From first seeing the male I describe to the point he moved through the club when he had stabbed me must have been around one minute to a minute and half. The distance varied from touching when he stabbed me to about arms length at the furthest point when I first saw him. As I was stood near to the entrance to the club when I first saw the male visibility was good due to the bright lighting in that area. Apart from a female between us there had been a clear unobstructed view of the male. I do not know this male nor have I seen him before.

My group was around a vertical support beam, nearly in the middle of the club and slightly towards the VIP area. I needed the toilet, so I made my way to the toilets to the left of the main entrance door. There were quite a few people in the club, so I made my way past them, but couldn't help bumping into a male on the way. This happened as I started to turn right to the toilets having reached the end of the bar. My right shoulder bumped into his right shoulder. No words passed between us. I stood back a little, and motioned for him to pass me, as we were heading in opposite directions. As I stood back, we were chest to chest, less than a hand's length between us.

I noticed that he had both of his hands down out of sight, and instead of moving past me, he just stared straight at me, his eyes really wide. He stared at me like that for a few seconds. I then tried to move away, and as I did so, I saw his right arm move. It was a slight sideways move, and my first thought was that he was pushing me away. However I could feel pain in my groin area and I initially put my hand onto the right side of my groin, and found that my trousers had a rip on them. I then felt down my right groin area, and I could feel that it was wet, and that I was bleeding. The male who had been less than a foot from me, standing face to face, left immediately, and carried on towards the smoking area. There was no way that anyone, other than that man in front of me, could have done this.

Initially, I didn't know what to do. I turned and walked back towards the way I had come, and sat on a ledge below the VIP area, with the VIP booth slightly to my right. I sat there inbetween 2

people who I don't know and told them that I had just been stabbed. There was a bouncer on the steps on the corner of the raised VIP area and I tapped him on the shoulder and told him that someone had stabbed me. He took me outside the front of the club, where one of my friends happened to be. I gave details of what had happened. I could see into the smoking area, and I believe that I saw the man who stabbed me hug another male. A lady then came and took me downstairs, where she gave me first aid, and bandaged my leg.

Whilst I was outside, and before I was bandaged up, a different bouncer came up to me, and asked me to look at a couple of men to see if I could recognise the man who had stabbed me.

One man came outside, then another - it was neither of them. After I was bandaged up, I came back outside and stood with my friend, who was still there. I had my back to the railings that divide Carver Street from Viper Rooms. The third man that came out I recognised immediately. I said to the bounces "Thats him" as I could clearly see that was the man who had been standing in front of me, and had stabbed me.

Almost as soon as the words left my mouth, this male who I had identified began to start running out of the club towards the street. He was already outside, but ran straight into some bouncers near the street. They took hold of him, and took him down onto the ground as he was struggling to get away. The last I saw was when he was on the ground. I got into a taxi, and left to go to the Northern General Hospital.

Once at the hospital, my wound was cleaned with saline. I was then given a local anaesthetic, and had 6 stitches to close the wound that is about 2 - 2 1/2 inches long. Clearly no-one has any right

to do this to me.

The male who stabbed me is a complete stranger to me. I had never seen him before I bumped into him at the club. As we stood face to face, he was less than a foot away from me for a couple of seconds before his arm moved, and I was stabbed. When I saw him hug a male in the smoking area, I was about 20 metres from him. In the club, it was dark, but with plenty of lights around for me to see his face. Outside, it was lighter looking over into the smoking area. When I saw him, and identified him outside, he was about 4-5 metres away, the lights are quite bright meaning the area is well-lit. There is no doubt in my mind that the person I identified, and saw detained, is the same person who stabbed me.

I can describe him as short - about 5' 7", fat, short beard, Asian man, early 20s. He was wearing a long sleeved 'polo' I think, with buttons down the front to chest area in a dark colour. I can't recall his lower half.

My injury today is quite sore. A couple of the stitches have come out, which is making it even more sore. The wound is to the inside of the upper left leg.

At 03:00 hours Wednesday 14th October 2015 I was on mobile duty, in full uniform and in company with PS 163 BROWN. At that time we were patrolling Sheffield City Centre in support of the local district officers as it seemed particularly busy with night-time economy customers when I received a message from the control room regarding an incident occurring at the Viper Rooms nightclub on Carver Street. It was reported that a male had been seen inside the club in possession of a knife. At that moment, PS BROWN and I were already on foot on Carver Street dealing with an unrelated incident. As a result of the information passed, I walked up to the main entrance of the Viper Rooms and spoke with a member of door-staff who initially stated that he was not aware of any incident that required police attendance. At that time, it seemed like the club was closing because hundreds of people were walking out of the main door past me and out on to the street. It was extremely noisy and I would describe the situation as chaotic. I was then approached by a male who identified himself as the manager of Viper Rooms. He stated that he had contacted police and pointed me towards a young male who had allegedly witnessed someone in the club with a knife. I attempted to speak with the male but he was extremely drunk and quite

uncooperative. He made little sense and seemed annoyed at my presence. It was impossible to take any coherent account from the male so I took the decision to advise him regarding his behaviour and told him to leave the area.

Whilst trying to deal with that incident I was then approached by a male who I recognised from previous incidents as the head doorman of Viper Rooms. He explained to me that a member of staff had been assaulted inside the club and requested that I speak to her. As a result of speaking with the staff member I arrested a male stood on Carver Street on suspicion of assault.

I escorted the male to a nearby police vehicle where PC's 3853 ROBINSON and 917 CROSSLAND were stood. I was then approached by the head doorman again. He stated that he knew where the male was who had been in possession of the knife and explained he was stood on Carver Street just up from the entrance to Viper Rooms. PC CROSSLAND and I walked up Carver Street and approached a male who had been pointed out to us. At that time, there were hundreds of people out on the street blocking the road and making access on Carver Street very difficult. I approached the identified male from his right side and took hold of his right arm. I explained who I was and that I intended to search him due to my suspicion that he may be in possession of a knife. Almost immediately, we were surrounded by other people who all wanted to get involved. I was being shouted at, jostled and had people grabbing my body armour in an effort to pull me away from the male. At the same time, the male put his left hand in his pocket and dropped something on the floor. I heard the sound of metal hitting the floor and looked down to see a boxcutter style knife immediately at my feet. I stood on the knife to prevent anyone else from picking it up. PC CROSSLAND, who had been stood on my right shoulder, immediately took hold of the male's left arm and I quickly picked up the knife. The mood of the crowd then deteriorated further. I would estimate that about thirty people had surrounded us. They were all aggressively shouting and swearing whilst grabbing us and the detained male in an effort to prevent us from making an arrest.

I knew that we had to get away from the entrance to Viper Rooms as that is where the largest concentration of people were stood. I used bodily pressure to push through the crowd whilst still holding on to the detained male's right arm. PC CROSSLAND and I walked down Carver Street and over the junction with Division Street where our vehicles were located. I was aware that we were being followed by the agitated and hostile crowd.

As we reached the point where our vehicles were parked we seemed to get cut off by the group. I was aware that PC CROSSLAND had requested assistance from other officers by using his personal radio. I was shouting at people to get back and trying to free my right hand in an effort to allow me to push people away but it felt like I was penned in against the side of the vehicle. I could feel different impacts on the back of my body armour and knew I was being assaulted although I did not feel any pain. Every time I turned my back to deal with a different threat I also knew I was being spat on because I could feel it on the back of my head. I then saw a hand reach across from over my shoulder and grab PC CROSSLAND'S radio before it was ripped from his body armour attachment. The radio was quickly returned by a member of door staff from Viper Rooms before a number of them helped to push the crowd back.

A short time later, other officers arrived on the scene and order was restored although the hostile crowd remained on Carver Street and I was aware that sporadic instances of fighting were occurring around me. Another violent male was arrested by other officers on the opposite side of the road before the detained male we had with us was arrested by PC CROSSLAND. We then managed to place both prisoners into the rear of police vehicles before attending custody.

I have been a police officer for nine years, six years of which was spent as a police support unit constable trained to deal with large-scale public order. I have policed dozens of football matches, protest marches and provided support to the Metropolitan Police during the riots of 2011 but I have never been surrounded

## WITNESS STATEMENT OF Andrea Marsden

- 1. I am employed by South Yorkshire Police as a civilian Licensing Enforcement Officer based in Sheffield. I have been in my current role for approximately 5 years and predominantly work alongside the licensed premises within Sheffield City Centre. As part of my role, I monitor incidents at licensed premises and carry out intervention work with the management to ensure that they are working towards the licensing objectives.
- 2. Following a serious incident at the Viper Rooms/Viper Lounge, Carver Street on the 30<sup>th</sup> of September 2015 whereby three customers had allegedly been stabbed within the premise an urgent meeting was arranged with the Designated Premise Supervisor, Mr David Burgess. The meeting was held at the premise together with Police Sergeant Burdett.
- Mr Burgess informed us that he had been working at the premise when the incidents occurred. We discussed the delay in contacting the police either by CCRAC radio or the 999 system.

Mr Burgess stated that the female victim presented to the staff first and said that she had been stabbed in the leg. At that time she appeared to be coherent

and was with friends and using her mobile phone. The injury was looked at by a first aider and he made the decision that she was 'walking wounded' but in hindsight he should have contacted the police at that point.

A member of staff transported the female victim to the hospital.

Whilst this matter was still ongoing another injured person, a male presented to staff stating he had also been injured. At that time Mr Burgess stated that he was not aware that this injury was similar to the first victims and again first aid was administered by staff. During that period door staff had detained a male fitting the description but found no trace of any weapon and it later transpired this male was not connected.

Again whilst this was ongoing another injured person presented to staff, the police were called and door staff had detained another male fitting the description who had a flick knife secreted under his trouser belt.

Mr Burgess stated that all this incident happened within a 15 minute period and he stated that it was only then that he had made the connection between all three injured parties, again with hindsight he agreed that he should have contacted the police immediately.

We advised Mr Burgess that any further incidents should immediately be called into the police and reported particularly if a victim is stating that they have been stabbed.

He also informed us that he would be revisiting the search policy and was advised to have at least a one in ten search of customers entering the premise. A full incident report relating to the three injured parties would be logged by Mr Burgess.

He was also advised that the police licensing team would be monitoring any further incidents at the premise.

4. Following an application for an Expedited Review of the premise licence on the 28<sup>th</sup> October 2015 and after interim steps had been applied by the Licensing Sub Committee I attended a pre-arranged meeting with Police Inspector Mutch at Snig Hill police station. This was at the request of the Viper Rooms management, Mr Paul Kinsey. Also present was the DPS, Mr David Burgess and police licensing officer Cheryl Topham.

Mr Kinsey informed us that the last incident on the 28th of October, whereby a female was injured by a champagne glass the Tuesday night event had been changed from 'Risque'. The night of the last incident (28th) had been a student night and advertised as NUS access only ahead of the re-opening on that date and a new music policy had been fetched in to alter the mood of the crowd within the premise.

He also stated that there had been door staff close to the incident prior to it happening and that it appeared to have occurred as the club was emptying. This has resulted in a member of door staff being removed from working at the premise as Mr Kinsey believed that staff should have intervened at the earliest opportunity to avoid this type of incident.

Mr Kinsey made proposals of actions that would be implemented at the premise on a Tuesday night if they are able to re-open following a further hearing before the licensing board on Monday 2<sup>nd</sup> November.

(A copy of the actions proposed are within the review papers).

Inspector Mutch informed Mr Kinsey that officers attending the incidents had described large amounts of glass on the floor within the venue. He stated that this could be down to bad housekeeping on the venues behalf and agreed that on Tuesday nights polycarbonate glasses would be used although he was keen to continue to use champagne bottles in the VIP area.

I believe that the contents of this statement are true and I understand it may be placed before the court.

I also understand that the contents of this statement may be shared win agencies working in partnership with the South Yorkshire Police.	th

# WITNESS STATEMENT OF Police Sergeant 1988 Matthew BURDETT

- I am a Police Sergeant in the South Yorkshire Police based at Snig Hill police station within the City centre of Sheffield. Over the last 8 years, I have worked within Sheffield city centre Safer Neighbourhood Team and my responsibilities during that time have included licensing and crime and disorder in the night time economy.
- 2. Following a serious incident at the Viper Rooms/Viper Lounge, Carver Street on the 30<sup>th</sup> of September 2015 whereby three customers had allegedly been stabbed within the premise. An urgent meeting was arranged with the Designated Premise Supervisor, Mr David Burgess. The meeting was held at the premise together with Andrea Marsden, a police licensing enforcement officer.
- Mr Burgess informed us that he had been working at the premise when the incidents occurred. We discussed the delay in contacting the police either by CCRAC radio or the 999 system.
- Mr Burgess stated that the female victim presented herself to staff and informed them that she had been stabbed in the leg. At that time she appeared

to be coherent and was with friends and using her mobile phone. The injury was looked at by a first aider and he made the decision that she was 'walking wounded' but in hindsight he should have contacted the police at that point. A member of staff transported the female victim to the hospital.

- 5. Whilst this matter was still ongoing another injured person, a male presented to staff stating he had also been injured. At that time Mr Burgess stated that he was not aware that this injury was similar to the first victims and again first aid was administered by staff. During that period door staff had detained a male fitting the description but found no trace of any weapon and it later transpired this male was not connected.
- Again whilst this was ongoing another injured person presented to staff, the police were called and door staff had detained another male fitting the description who had a flick knife secreted under his trouser belt.
- 7. Mr Burgess stated that all this incident happened within a 15 minute period and he stated that it was only then that he had made the connection between all three injured parties, again with hindsight he agreed that he should have contacted the police immediately.
- We advised Mr Burgess that any further incidents should immediately be called into the police and reported particularly if a victim is stating that they have been stabbed.
- 9. He also informed us that he would be revisiting the search policy and was advised to have at least a one in ten search of customers entering the premise. A full incident report relating to the three injured parties would be logged by Mr Burgess.
- 10. He was also advised that the police licensing team would be monitoring any further incidents at the premise.
- 11.At 0800hrs on Wednesday 14th October 2015. I was made aware of the following incidents;

At 00.47hrs on Wednesday 14th October 2015 report of a female having been assaulted outside the toilet area within the premise by another female. This group of females had been lawfully ejected from the club by door staff and caller stating that the offender was still in the premise. The injured female reported a bruise to her arm, lump on the head; her eyes were sore, as drink had been thrown in them. Door staff were spoken to and stated that a group of females inside had had a disagreement, one was lawfully ejected, once informed the police were attending all parties had left. The investigation is still ongoing.

At 02.19hrs on Wednesday 14th October 2015 ambulance control reported a 20 year old female had been glassed and had a head injury, she was described as being conscious but not alert.

Officers attended and PC 2012 Rimmer spoke briefly to the injured female prior to her being transported to the NGH by ambulance. A copy of PC Rimmer's statement is within the review papers.

The investigation is still ongoing and remains undetected at this time.

At approximately 01.45hrs on Wednesday 14th October 2015 a female reported that she had been outside Viper Rooms with her friend in the smoking area provided when a male known to her has become agitated and pushed the females friend to the floor. The female has tried to assist her friend and the male has punched her in the face knocking her to the floor causing bruising to the left side of her chin, a bruise to her right arm and left shoulder.

Her friend also reports being assaulted by the same male at the same location stating that this male had 'kicked off', grabbed her by the hair and thrown her to the floor before leaving the area.

At approximately 03.00hrs on Wednesday 14th October 2015 a call is received from the Designated Premises Supervisor (DPS) at Viper Rooms reporting that the premise was due to close and that he had been approached by another customer stating that someone had a knife. This had not been seen by the DPS but he was concerned due to the premise closing and customers leaving the venue into the street.

Officers attended the scene and spoke with a male and whilst dealing with this male a large crowd has followed. This male was subsequently detained. PC 134 Thompson has now provided a statement in relation to this incident which is within the review papers.

During this incident a female member of staff reported that she had been assaulted by a male inside the premise. The complainant is a member of staff and stated that throughout the evening a male had been paying her unwanted attention. She had complained to the door staff numerous times about this male's behaviour. Around 03.00hrs, she was stood near him and this male has backhanded her across the face causing pain. He has then left the club and stood at the entrance door. The complainant has pointed the male out to both door staff and the police officers in attendance. He was subsequently arrested and charged with common assault.

At approximately 03.45hrs on Wednesday 14th October 2015, officers were already present on Carver Street following disorder there when they witnessed a fight breaking out of Viper Rooms into the street. Officers saw a male swinging punches towards another member of the public and acting aggressively.

The male was detained and due to his demeanour, it was deemed necessary for officers to use PAVA spray to gain compliance with the male.

Upon receiving this information, I immediately contacted Mr Dave Burgess and requested that he attend Snig Hill police station in order to discuss the reports of disorder outlined above.

- 13. At approx 1100hrs on Wednesday 14th October, Mr Dave Burgess and the owner of Viper Rooms Mr Paul Kinsey attended Snig Hill police station. A meeting then took place with them and PC1976 Tom Phelan and I. All the incidents that had taken place at the venue over the previous few months, outlined in the review papers, were discussed and concerns were raised due to the previous interventions implemented by the venue after the meeting on the 30th September 2015 clearly had been ineffective.
- 14. Mr Paul Kinsey stated that he has unaware of some of the incidents raised and that clearly there were some housekeeping issues that needed addressing. He asked if he could be allowed sometime to discuss a management plan with Mr Dave Burgess and his security team with a view to submitting to us that day.

15. At 1511hrs. I received an email from Paul;

"As discussed I am keen to resolve the matter without the need for a formal license review and to demonstrate sufficient change to the policy and procedures to give the police confidence that the session will be genuinely re positioned forthwith.

I would propose the following actions to achieve the objective and would appreciate your comment and agreement to the action plan as being sufficient"

- The Tuesday Risqué session will cease with immediate effect.
- The venue will remain closed next Tuesday night (October 20<sup>th</sup>)
- A new House music led session will be launched the Tuesday following (October 27th) with a girl friendly and student only admission policy
- The admission policy will be NUS only.
- A search policy of 1 in 10 customers will be introduced on all trading nights and I will submit a minor licence variation for your agreement. We will keep records of search numbers each
- All door staff will be the subject of re training to ensure that the level of vigilance and awareness is 'sharpened up' for all sessions.
- The guest DJ last night Russki will not be used again in the city in any of my venues. He has as I said appeared a number of times before without any issues but the scale of his profile and fanbase now is not appropriate for us to host.
- 16. These proposals were presented to Superintendent Shaun Morley. He agreed that they were proportionate to the circumstances and promoted the licensing objectives. Mr Paul Kinsey was informed of this approval and was informed that the licensing team would be monitoring the venue for any further incidents and action may be taken against the venue if there were any further occurrences.

I believe that the contents of this statement are true and I understand it may be placed before the court.

I also understand that the contents of this statement may be shared with agencies working in partnership with the South Yorkshire Police.

# **Viper Rooms Management Action Plan**

The following actions were agreed following a meeting of Paul Kinsey and Dave Burgess with the police on Wednesday October 14<sup>th</sup>

- 1. Tuesday Risqué session to close immediately
- 2. New session to be launched on Tuesday 28thOctober
- 3. 1 in 15 customers will be searched with emphasis on males
- 4. Records of searches to be kept
- 5. Only NUS will be admitted to the session and promoter staff and networkers
- 6. Music policy to be house music led

# Additional actions implemented on 29th October

The only incident on the Tuesday 27<sup>th</sup> October was involving 2 female students. There were a significant number of refusals to entry at the front door.

The change in drinks sales mix clearly showed a different profile of audience to the Risqué sessions, although further steps are required to eliminate NUS card holders who may pose a risk.

The only glasses served that were not polycarbonate were champagne glasses.

Following a meeting with the police PK has proposed that the following further actions are taken

## Admission policy

- 1. The front door admission policy will be reviewed to modify the NUS only policy to increase strictness on broader criteria, as both girls on Tuesday were students.
- 2. 1:15 search policy to be maintained and voluntary licence condition has been submitted

#### **Internal supervision**

- 1. An internal head door person position will be created who will take responsibility for the door-staff inside the venue which will further increase supervision levels
- 2. Doorstaff/customer ratio will be held at a new ratio of 1:70
- 3. All support management will be placed on an SIA training course within 6 weeks.
- 4. For the first weeks post re opening Paul Kinsey will attend the session along with another qualified DPS from the company to review the detail of the operation in terms of:
  - Audience quality
  - Music policy
  - Internal door supervision
  - Quality of support management supervision skills

# · General housekeeping

Following this process of weekly review the management action plan will be updated weekly to highlight and eradicate any residual risk issues

- 5. Music policy will be further adapted to maintain a light hearted feel to the room
- 6. Only poly carbonate glass will be used on the Tuesday session.
- 7. Only PET bottle beers will be served on a Tuesday night.
- 8. There has never been a bottle related incident on any night so it is proposed to serve champagne and bottles of spirit in the **VIP area only** which is supervised by 4 waitresses and a specific door supervisor. All glassware in VIP will be PET. This will ensure that the 'top end' of the market is not alienated.

## Dispersal

- Doorstaff will ensure that customers that are exiting the building are encouraged actively to move away from the building and not congregate outside the gates.
   Also they will be encouraged actively to behave in a respectful and considerate manner
- 2. Internal dispersal will be supervised by the internal head door person and one of the senior venue management
- 3. Dispersal will be deliberately staggered over the 30 minutes post closure to allow orderly dispersal and minimize congregation outside.

#### NOTES

# Right of attendance, assistance and representation

15. Subject to regulations 14(2) and 25, a party may attend the hearing and may be assisted or represented by any person whether or not that person is legally qualified.

# Representations and supporting information

- At the hearing a party shall be entitled to
  - (a) in response to a point upon which the authority has given notice to a party that it will want clarification under regulation 7(1)(d), give further information in support of their application, representations or notice (as applicable),
  - (b) if given permission by the authority, question any other party; and
  - (c) address the authority

## Failure of parties to attend the hearing

- 20. (1) If a party has informed the authority that he does not intend to attend or be represented at a hearing, the hearing may proceed in his absence.
  - (2) If a party who has not so indicated fails to attend or be represented at a hearing the authority may:—
    - (a) where it considers it to be necessary in the public interest, adjourn the hearing to a specified date, or
    - (b) hold the hearing in the party's absence.
  - (3) Where the authority holds the hearing in the absence of a party, the authority shall consider at the hearing the application, representations or notice made by that party.
  - (4) Where the authority adjourns the hearing to a specified date it must forthwith notify the parties of the date, time and place to which the hearing has been adjourned.

#### Procedure at hearing

- 21. Subject to the provisions of the Regulations, the authority shall determine the procedure to be followed at the hearing.
- 22. At the beginning of the hearing, the authority shall explain to the parties the procedure which it proposes to follow at the hearing and shall consider any request made by a party under regulation 8(2) for permission for another person to appear at the hearing, such permission shall not be unreasonably withheld.
- 23. A hearing shall take the form of a discussion led by the authority and cross-examination shall not be permitted unless the authority considers that cross-examination is required for it to consider the representations, application or notice as the case may require.
  - 24. The authority must allow the parties an equal maximum period of time in which to exercise their rights provided for at regulation 16.
  - 25. The authority may require any person attending the hearing who in their opinion is behaving in a disruptive manner to leave the hearing and may —
  - (a) refuse to permit that person to return, or
  - (b) permit him to return only on such conditions as the authority may specify, but such a person may, before the end of the hearing, submit to the authority in writing any information which they would have been entitled to give orally had they not been required to leave.

#### STREET TRADING CONSENT APPLICATION

#### SUB-COMMITTEE HEARING PROCEDURE

This procedure has been drawn up to assist those parties attending Street Trading Consent Committee hearings.

- 1. The Chair of the Licensing Committee will introduce the Committee and ask officers to introduce themselves.
- 2. The Chair will ask the applicants and interested parties to formally introduce themselves.
- 3. The Solicitor to the Committee will outline the procedure to be followed at the hearing.
- 4. Hearing Procedure:-
  - (a) The Licensing Officer will introduce the report.
  - (b) Questions concerning the report can be asked both by Members and the applicant.
  - (c) The applicant/consent holder (or his/her nominated representative) will then be asked to:-
    - (i) detail the application;
    - (ii) provide clarification on the application and respond to the representations made.
  - (d) The Chair of the Licensing Committee will invite Members of the Sub-Committee and all other parties present to put any relevant questions to the applicant and/or his/her representative.
  - (e) Consultees / interested parties will be invited to present their representations or elect a spokesperson (which may be a Councillor) to speak on their behalf. New representations must not be raised.
  - (f) The Chair of the Licensing Committee will invite Members of the Sub-Committee and all other parties present to put any relevant questions to the consultees / interested parties.
  - (g) The consultees / interested parties will be invited to sum up. A maximum of 5 minutes will be allowed.
  - (h) The applicant will be invited to sum up. A maximum of 5 minutes will be allowed.
  - (i) The Licensing Officer will then detail the options.
  - (j) There will then be a private session for Members to take legal advice and consider the application.
  - (k) Once a decision has been reached, all parties will be invited to return. The Sub-Committee's decision and reasons will be announced by the Chair.
  - (I) The Sub-Committee's decision will be confirmed in writing to the applicant and those parties who made representations.
- NB: 1) At any time in the Licensing Process Members of the Committee may request legal advice from the Solicitor to the Committee. This advice may be given in open session or in private.
  - The Committee Hearing will be held in public unless and in accordance with the Regulations the Committee determine that the public should be excluded.

There is no right of appeal against the Council's decision to refuse to grant or revoke a Street Trading Consent.
