#### ADVICE TO MEMBERS ON DECLARING INTERESTS AT MEETINGS

If you are present at a meeting of the Council, of its Policy Committees, or of any committee, sub-committee, joint committee, or joint sub-committee of the authority, and you have a **Disclosable Pecuniary Interest** (DPI) relating to any business that will be considered at the meeting, you must <u>not</u>:

- participate in any discussion of the business at the meeting, or if you become aware of your Disclosable Pecuniary Interest during the meeting, participate further in any discussion of the business, or
- participate in any vote or further vote taken on the matter at the meeting.

These prohibitions apply to any form of participation, including speaking as a member of the public.

#### You must:

- leave the room (in accordance with the Members' Code of Conduct)
- make a verbal declaration of the existence and nature of any DPI at any meeting at which you are present at which an item of business which affects or relates to the subject matter of that interest is under consideration, at or before the consideration of the item of business or as soon as the interest becomes apparent.
- declare it to the meeting and notify the Council's Monitoring Officer within 28 days, if the DPI is not already registered.

If you have any of the following pecuniary interests, they are your **disclosable pecuniary interests** under the new national rules. You have a pecuniary interest if you, or your spouse or civil partner, have a pecuniary interest.

- Any employment, office, trade, profession or vocation carried on for profit or gain, which you, or your spouse or civil partner undertakes.
- Any payment or provision of any other financial benefit (other than from your council or authority) made or provided within the relevant period\* in respect of any expenses incurred by you in carrying out duties as a member, or towards your election expenses. This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992.

\*The relevant period is the 12 months ending on the day when you tell the Monitoring Officer about your disclosable pecuniary interests.

- Any contract which is made between you, or your spouse or your civil partner (or a body in which you, or your spouse or your civil partner, has a beneficial interest) and your council or authority –
  - under which goods or services are to be provided or works are to be executed; and
  - which has not been fully discharged.

- Any beneficial interest in land which you, or your spouse or your civil partner, have and which is within the area of your council or authority.
- Any licence (alone or jointly with others) which you, or your spouse or your civil partner, holds to occupy land in the area of your council or authority for a month or longer.
- Any tenancy where (to your knowledge)
  - the landlord is your council or authority; and
  - the tenant is a body in which you, or your spouse or your civil partner, has a beneficial interest.
- Any beneficial interest which you, or your spouse or your civil partner has in securities of a body where -
  - (a) that body (to your knowledge) has a place of business or land in the area of your council or authority; and
  - (b) either -
    - the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or
    - if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you, or your spouse or your civil partner, has a beneficial interest exceeds one hundredth of the total issued share capital of that class.

If you attend a meeting at which any item of business is to be considered and you are aware that you have a **personal interest** in the matter which does not amount to a DPI, you must make verbal declaration of the existence and nature of that interest at or before the consideration of the item of business or as soon as the interest becomes apparent. You should leave the room if your continued presence is incompatible with the 7 Principles of Public Life (selflessness; integrity; objectivity; accountability; openness; honesty; and leadership).

You have a personal interest where -

- a decision in relation to that business might reasonably be regarded as affecting the well-being or financial standing (including interests in land and easements over land) of you or a member of your family or a person or an organisation with whom you have a close association to a greater extent than it would affect the majority of the Council Tax payers, ratepayers or inhabitants of the ward or electoral area for which you have been elected or otherwise of the Authority's administrative area, or
- it relates to or is likely to affect any of the interests that are defined as DPIs but are in respect of a member of your family (other than a partner) or a person with whom you have a close association.

Guidance on declarations of interest, incorporating regulations published by the Government in relation to Disclosable Pecuniary Interests, has been circulated to you previously.

You should identify any potential interest you may have relating to business to be considered at the meeting. This will help you and anyone that you ask for advice to fully consider all the circumstances before deciding what action you should take.

In certain circumstances the Council may grant a **dispensation** to permit a Member to take part in the business of the Authority even if the member has a Disclosable Pecuniary Interest relating to that business.

To obtain a dispensation, you must write to the Monitoring Officer at least 48 hours before the meeting in question, explaining why a dispensation is sought and desirable, and specifying the period of time for which it is sought. The Monitoring Officer may consult with the Independent Person or the Council's Standards Committee in relation to a request for dispensation.

# REPORT OF THE CHIEF LICENSING OFFICERRef No 125/23(HEAD OF LICENSING) TO THE LICENSING SUB COMMITTEEGAMBLING ACT 2005

#### Royal Amusements, 9 Fargate, Sheffield, S1 2HD

#### 1.0 PURPOSE OF REPORT

1.1 To consider an application for the grant of a premises licence for an 'Adult Gaming Centre' made under section 159 of the Gambling Act 2005.

#### 2.0 BACKGROUND – THE GAMBLING REGULATORY FRAMEWORK

- 2.1 The Gambling Commission is responsible for regulating gambling in accordance with the Act, and for issuing '<u>operating licences'</u> to gambling businesses and '<u>personal licences'</u> to individuals. To help fulfil its role, the Commission attach <u>licence conditions and issue codes</u> <u>of practice</u> relating to how gambling facilities should be provided, and <u>guidance</u> to Licensing Authorities on how to implement their responsibilities under the Act. Operators must have or be in the process of applying for an 'operating licence' before they apply for a 'premises licence' in Local Authority areas.
- 2.2 Licensing Authorities are a key partner in gambling regulation, with a responsibility for overseeing 'non-remote' gambling in their local areas. This involves:
  - setting the local framework for gambling through their statement of principles
  - considering applications and issuing licences for premises where gambling takes place, with conditions where appropriate
  - reviewing or revoking premises licences
  - issuing permits for some forms of gambling
  - undertaking inspection and enforcement activities, including tackling illegal gambling.
- 2.3 Like the Gambling Commission, Licensing Authorities are bound by a statutory 'aim to permit' and must grant premises licences so long as applications are:
  - in accordance with the Gambling Commission's <u>codes of practice</u>
  - in accordance with the guidance to local authorities
  - in accordance with the licensing authority's own statement of principles
  - reasonably consistent with the three licensing objectives.

#### ADULT GAMING CENTRES (AGCs)

2.4 An adult gaming centre premises licence entitles the holder to make gaming machines available for use within an adult gaming centre. The Act permits the following on AGCs:

#### 1. Category B machines

(The Category B machines are limited to B3 and B4 and the number of category B machines must not exceed 20% of the total number of gaming machines which are

available for use on the premises)

#### 2. Unlimited category C and D machines

- 2.5 Details of the machine categories can be found on the following link: <u>The Categories of</u> <u>Gaming Machines Regulations 2007</u>
- 2.6 The following details the access permitted to an AGC:
  - No one under the age of 18 is permitted to enter an Adult Gaming Centre.
  - No customer must be able to access the premises directly from any other licensed gambling premises.
- 2.7 Details of our local policy on Adult Gaming Centres can be found at <u>part 7.8 of SCC's</u> <u>Statement of Principles (Gambling Policy)</u>, a section of which is detailed below for ease:

#### 7.8.1 Policy - AGC

Factors for consideration by the Licensing Authority when determining the application for an Adult Gaming Centre will include the applicants demonstrating:

- Promotion of the licensing objectives in Part 4 of this policy and the Authority's considerations under this part
- Local area profiling through risk assessments and in particular the location (see location policy at Part 5); and
- · Applicants measures and procedures to minimise illegal access to the premises by under 18's

The Authority will have specific regard to the need to protect children and vulnerable persons from harm or being exploited by gambling and will expect the applicant for an Adult Gaming Centre to satisfy to the Licensing Authority that there will be sufficient measures to control access to and participation in gambling by such persons.

The Authority will also expect applicants to offer their own measures to meet the licensing objectives; however appropriate measures / licence conditions imposed by the Authority may cover issues such as:

- proof of age schemes
- CCTV
- supervision of entrances / machine areas
- physical separation of areas
- location of entry
- notices / signage
- specific opening hours
- change machines
- self-barring schemes
- provision of information leaflets/helpline numbers for organisations such as GamCare
- staff training including age verification and safeguarding awareness training
- record keeping
- signage
- publicity or advertising.

This is not an exhaustive list and each application will be judged on its merits. Any effective measures to support the licensing objectives will be taken into account.

In addition to the mandatory conditions attached by regulations issued by the Secretary of State, conditions may be applied by the Authority in support of the licensing objectives if it is felt necessary (see section 10.4 on conditions).

- 2.8 Further information on AGCs can be found in the:
  - Gambling Commissions guidance to Local Authorities.
  - Licence Conditions and Codes of Practice (gamblingcommission.gov.uk)

#### Mandatory and default conditions of ACGs

2.9 The majority of premises licences under the Gambling Act 2005 will have mandatory and/or default conditions attached to the licence under <u>The Gambling Act 2005 (Mandatory and Default Conditions) (England and Wales) Regulations 2007</u>. Default conditions are prescribed in regulations and will be attached to all classes of premises licence, unless excluded by the licensing authority. Mandatory conditions are automatically attached to a specific type of premises licence; the licensing authority has no discretion to alter or remove these conditions. These are detailed below:

#### Mandatory conditions attached to all premises licences.

- 1) The conditions specified in paragraphs (2), (3) and (4) shall be attached to every premises licence.
- 2) The summary of the terms and conditions of the premises licence issued under section 164(1)(c) of the 2005 Act shall be displayed in a prominent place within the premises.
- 3) The layout of the premises shall be maintained in accordance with the plan.
- 4) The premises shall not be used for -
  - (a) the sale of tickets in a private lottery or customer lottery, or
  - (b) the sale of tickets in any other lottery in respect of which the sale of tickets on the premises is otherwise prohibited.

#### Mandatory conditions attached to Adult Gaming Centre premises licences

- 1. A notice stating that no person under the age of 18 years is permitted to enter the premises shall be displayed in a prominent place at every entrance to the premises.
- 2. No customer shall be able to access the premises directly from any other premises in respect of which a licence issued under Part 8 of the Act, or a permit issued under Schedule 10, 12 or 13 to the Act, has effect.
- 3. Any ATM made available for use on the premises shall be located in a place that requires any customer who wishes to use it to cease gambling at any gaming machine in order to do so.
- 4. (1) No alcohol shall be permitted to be consumed on the premises at any time during which facilities for gambling are being provided on the premises.
  - (2) A notice stating the condition in sub-paragraph (1) shall be displayed in a prominent place at every entrance to the premises.

2.10 There are no Default Conditions on an Adult Gaming Centre licence.

#### LOCAL AREA RISK ASSESSMENTS

- 2.11 The Licensing Authority needs to be satisfied that there is sufficient evidence that the particular location of the premises would not undermine the licensing objectives.
- 2.12 The Gambling Commission's <u>Licence Conditions and Codes of Practice (LCCP)</u>, sets out requirements for licensees to assess local risks posed by the provision of gambling facilities at their premises and to have policies, procedures and control measures in place to mitigate those risks. The codes of practice require licensees to share their risk assessment with Licensing Authorities.
- 2.13 Sheffield City Council's policy on applicant's local risk assessments is detailed in <u>Part 5 of</u> <u>the Gambling Policy Statement of Principles</u>, this details what the Authority expects applicants to consider and detail in their risk assessments.

#### 3.0 THE APPLICATION

- 3.1 The applicant is Mr Mohammed Yousaf.
- 3.2 The application was received by the Licensing Authority on the 16<sup>th</sup> of August 2023. A full copy of the following application documents is attached at Appendix 'A' of this report:
  - Premises licence application
  - Plan of the premises
  - Local Area Risk Assessment
- 3.3 The Gambling Act 2005 and associated regulations, does not restrict the times that AGCs can operate. Therefore, AGCs may be open 24 hours, with the exception outlined in Section 183 of the Gambling Act 2005 which applies a condition on all premises licences that facilities for gambling must not be provided on Christmas Day. This application does not seek to restrict operating hours outside of this 24-hour entitlement.

#### 4.0 REASONS FOR REFERRAL

- 4.1 The application has been referred to the Licensing Sub-Committee due to unresolved representations from the following which are attached at Appendix B:
  - Sheffield's Office of Public Health
  - South Yorkshire Police (Responsible Authority)
  - Green Party City Ward Councillors Cllr Ruth Mersereau and Cllr Martin Phills
  - ChangingSheff 'The residents' association for 27,000 people living within a radius of 750 metres of City Hall'
  - Victoria Hall Methodist Church
  - The Foundry Victoria Hall
  - The Cathedral Church of St Peter & St Paul
  - 1 x resident objection

- 4.2 Sheffield's Planning Department (a Responsible Authority under the Gambling Act 2005), have also made comments in relation to the application which is attached at Appendix 'C' with a copy of the applicant's response.
- 4.3 The objections referred to in 4.1 above detail concerns in relation to the following licensing objectives:
  - preventing gambling from being a source of crime or disorder, being associated with crime or disorder or being used to support crime
  - protecting children and other vulnerable persons from being harmed or exploited by gambling.

In particular, the following factors:

- Area is a hotspot for violence and antisocial behaviour
- Area is part of a violent crime initiative
- Lack of resources to deal with current issues in the area
- Likely increased gambling activity with a high risk of harm to people who live, work, study and socialise in this mixed-use area
- Increased exposure to gambling related harm issues and vulnerable people in the area
- Content around city centre regeneration and plans
- Risks around the location of the gambling premises in particular to:
  - Demographics of local area and close to areas of high deprivation
  - Close proximity to sensitive buildings and sensitive locations (examples given)
  - Density of gambling premises in area and vulnerable people
  - Risk of problem gamblers typically male and in younger age groups student population and nearby universities
  - Exposure and negative affect to children/young adults and vulnerable persons
  - Exposure to vulnerable persons proximity of the congregation points for people suffering from mental health issues and drug and alcohol addiction – <u>Archer Project</u> / McDonalds and the Cathedral grounds
  - The Foundry (close to proposed gambling premises) is a community hub for a number of support services including addiction support groups (sensitive building)
- 4.4. The representations detail the proposed gambling premises are located near to sensitive buildings and locations. A list and plans have been mapped out for Members to view premises that may fall within those listed in Part 5 of the Gambling Statement of Principles (policy) along with information relating to the area as described under the same part of the policy. This is attached at Appendix 'D' of this report.
- 4.5 The applicant and the objectors have been invited to attend the hearing. Copies of the front page of the notices are attached to this report labelled Appendix 'E'.

#### 6.0 FINANCIAL IMPLICATIONS

6.1 There are no specific financial implications arising from this application. However, additional costs may be incurred should the matter go to appeal. In such an eventuality it may not be possible to recover all these costs. The impact of these additional costs (if any) will be kept under review and may be subject of a further report during the year.

#### 7.0 THE LEGAL POSITION

- 7.1 The Section 153 of the Gambling Act 2005, provides that in determining applications the licensing authority shall aim to permit the use of the premises for gambling in so far as it thinks it is
  - a) in accordance with any relevant (Gambling Commissions) <u>code of practice</u> under section 24,
  - b) in accordance with any relevant guidance issued by the Commission under section 25,
  - c) reasonably consistent with the <u>licensing objectives</u> (subject to paragraphs (a) and (b)), and
  - d) in accordance with the <u>statement published by the authority</u> under section 349 (subject to paragraphs (a) to (c)).
- 7.2 In determining whether to grant a premises licence a licensing authority may not have regard to the expected demand for the facilities which it is proposed to provide.
- 7.3 If the licensing authority issues an adult gaming centre premises licence, this will be subject to the mandatory conditions applicable to such premises licences, as prescribed under

section 167 of the Act. The mandatory conditions are details in paragraph 2.9 above.

- 7.4 Further to the mandatory conditions, where a licensing authority issue a premises licence they may
  - (a) attach a condition to the licence
  - (b) exclude a condition that would otherwise be attached to the licence by virtue of section 168 of the Act (default conditions) There are however no default conditions prescribed under section 168 of the Act in relation to adult gaming centre premises licences.

#### 8.0 HEARINGS REGULATIONS

- 8.1 <u>Regulations</u> governing hearings under the Gambling Act 2005 have been made by the Secretary of State.
- 8.2 The Licensing Authority has provided all parties with the information required in the Regulations to the 2005 Act as set out at Appendix 'E'.
- 8.3 Attached at Appendix 'E" is the following:
  - a) a copy of the Notice of Hearing;
  - b) the rights of a party provided in Regulations;
  - c) the consequences if a party does not attend or is not represented at the hearing
  - d) the procedure to be followed at the hearing.

#### 9.0 APPEALS

9.1 The Gambling Act 2005 section 206 makes provision for appeals to be made by the applicant and those making representations against decisions of the Licensing Authority to the Magistrates' Court.

#### **10.0 RECOMMENDATIONS**

9.1 That members carefully consider the representations made in accordance with the legislation, codes of practice, guidance to local authorities and the Licensing Authority's Statement of Principles (policy).

#### 11.0 OPTIONS OPEN TO THE COMMITTEE

- 11.1 To grant the premises licence in the terms requested.
- 11.2 To grant the premises licence with conditions.
- 11.3 To reject the application.



Dear Licensing Authority

Thank you for the opportunity to comment on this grant application. On behalf of Sheffield City Council Public Health Team, we have reviewed this application to grant a licence for an Adult Gaming Centre and need to raise some fundamental concerns about the proposal.

Public Health's overarching aim is to work to protect and improve the public's health and reduce health inequalities.

The grounds for this objection are outlined below and based around the premise of the gambling objective 'protecting children and other vulnerable persons from being harmed or exploited by gambling'.

#### In summary, our main objections are:

**1.** People likely to be the most negatively affected by this potential premises include children, young adults and vulnerable people; people in treatment for gambling related harms; people in treatment for alcohol addiction; people living in areas of high deprivation; people from ethnic minority groups; and people living with financial hardship.

**2.** If granted a license, this premises would lead to likely increased gambling activity with a high risk of harm to people who live, work, study and socialise in this mixed-use area. This area has a rough sleeper and street begging population and numerous hostels and day centres in the vicinity, and is very close to a university centre. The city centre due to its offer also attracts young adults who have increased freedoms with reduced support networks, and people seeking help from local services for debt, housing, and other financial problems. It is therefore likely to impact disproportionately on the health of those most at risk.

**3**. There is already a high concentration of similar premises in the immediate and wider vicinity. An Adult Gaming Centre is likely to have a net negative effect on the city centre and would not bring any benefit as there are already many opportunities in the area for people to gamble if they choose to do so, including an existing Adult Gaming Centre at 15 Haymarket which is 0.3km or a 4 minute walk away. The proposed application would create clustering of similar venues which is detrimental to the character, vitality and economic wellbeing of the city centre.

#### General Comments




Figure 1: Indices of Multiple Deprivation scores for City Ward and surrounding areas

The application is within the City Ward, an area of average deprivation (based on the Indices of Multiple Deprivation 2019) containing smaller areas of above average deprivation and fringed by areas of Sheffield with higher than average levels of deprivation where health outcomes along with levels of fuel poverty and income deprivation are worse than the England average (figure 1).<sup>1</sup>

In light of the levels of deprivation and associated poor health in and around City Ward we consider there is a clear local health and wellbeing need for measures that prevent already deprived areas from schemes and systems that reinforce disadvantage and negative impact on human health.

#### Gambling-related harms

There is evidence to show that gambling can be a significant cause of harm to human health and wellbeing.

A recent Public Health England evidence review of gambling-related harms found that people at risk of gambling harms are concentrated in areas of higher deprivation and may already be experiencing greater health inequalities.<sup>2</sup>

The review highlights the link between gambling and mental health issues, including the conclusion that people with gambling problems are at least twice as likely to die from suicide compared to the general population.

The Public Health England review also included the most comprehensive estimate of the economic burden of gambling on society to date by looking at the following categories of harms: financial; relationship disruption, conflict or breakdown; mental and physical health; cultural; employment and education; and criminal activity. The review found that harms associated with gambling cost at least £1.27 billion in 2019 to 2020 in England alone. This analysis includes the first estimate of the economic cost of suicide (£619.2 million) and provides an updated cost of homelessness associated with harmful gambling (£62.8 million).

# Sheffield accounts for approximately 1% of the population of England, and demographically reflects the English average. This means the societal harms associated with gambling in Sheffield are likely to be in the region of £12.7 million each year including £6.1m through suicide and £628k through homelessness.

Gambling harms are not equally distributed throughout society. People from more affluent and less vulnerable groups are more likely to gamble, yet those who are already vulnerable and at risk of poor health are more at risk of gambling-related harms, further exacerbating existing inequalities.

The groups for whom there is the strongest evidence for vulnerability to gambling harms include:

- Men
- Those aged 16-44 years old
- People living in an area of higher deprivation
- People drinking alcohol at higher risk levels
- Those participating in seven or more gambling activities

Further examples of identified vulnerable groups at risk from gambling related harm are identified in Sheffield's *Gambling Act, Statement of Principles 2022.*<sup>3</sup>

While 3.8% of people in the general population gamble at levels of elevated risk, this increases to 6.1% in those who are unemployed. Furthermore, 5.3% of people in the most deprived neighbourhoods are gambling at levels of elevated risk compared to 3.0% in the least deprived and rates of harmful gambling are over seven times higher in the most deprived neighbourhoods compared to the least deprived neighbourhoods.<sup>4</sup>

These disparities are particularly clear when looking at land-based gambling venues, with 21% of venues located in the most deprive decile compared to 2% in the least deprived decile.<sup>5</sup> A PHE evidence review in 2021 suggests that accessibility of gambling opportunities is associated with increased gambling and gambling-related harm.<sup>2</sup>

#### Density of city centre gambling locations and vulnerable people





Figure 2: Gambling locations within a 500m radius of 9 Fargate

Sheffield City Centre already has many gambling premises such as betting offices, amusement centres and bingo halls. Figure 2 shows that there are 11 physical locations to gamble within a 500m

walking distance (a 5 minute walk) of the proposed Adult Gaming Centre in Fargate and a total of 15 locations within 1km (a 12 minute walk). This includes an existing Adult Gaming Centre at 15 Haymarket which is 0.3km or a 4 minute walk away. This does not include additional gaming opportunities within the surrounding pubs, hotels, and social clubs and similar premises with a licence for a maximum of two gaming machines, as well as newsagent-type off licenses who retail opportunities to buy and gamble on lottery tickets and scratch-cards.

Figure 3 shows the density of betting and gambling premises by ward in Sheffield. City Ward has by far the highest density of premises of any ward, at 80 per 100,000 population. The second highest density – less than half of that in City Ward – is Darnall at 35 per 100,000 population. While it's not unexpected that City Ward has a higher density of premises given the city centre offer, it clearly shows the saturation of offer within an area that contains a population vulnerable to gambling harms.

The Archer Project, located at the Cathedral, provides a day centre for people that are homeless/rough sleeping so the footfall of vulnerable people is increased in the area. There is a known gambling issue with some people who are part of the street culture in the city centre, with staff from soup kitchens trying to access support from the gambling service from them. Children's services in Sheffield City Council have three 16 year olds placed in Supported Accommodation nearby. There are also nearby Salvation Army and Roundabout hostels, plus South Yorkshire Housing Association have social housing in the area.





In relation to these types of applications, planning and licensing authorities need to consider whether any special considerations need to be balanced against the use of the premises for gambling. This should include, for example, the spatial distribution of similar land uses in the local area and the impact on vulnerable people.<sup>6</sup> In this example, there is both a high intensity of gambling premises and high numbers of vulnerable people.

Gambling premises have a negative impact on the health of Sheffield's high streets. The Marmot Review: Ten Years On report identified a higher concentration of gambling premises on high streets as the sign of an "unhealthy high street", widening inequalities for the most vulnerable, and leading to poor mental and physical health.<sup>7</sup>

Evidence shows that increasing accessibility and availability of gambling increases the number of regular and problem gamblers in an area.<sup>8</sup>

#### Impact on children and young people

While the gambling industry and its regulations take suitable measures to prevent children and young people from accessing licensed premises, there is likely to still be an impact on young people, not just those under the age of 18. This proposal is within walking distance of Sheffield Hallam University and, as a city centre shopping location, is well frequented by children and young people.

#### Gambling advertising and visibility

Although children are not legally permitted to gamble, advertising and visibility of gambling companies and products in places where children and young people are present can normalise gambling and make it appear appealing. A recent study conducted on behalf of GambleAware looked

into the exposure to and impact of advertising of gambling products on children and young people.<sup>9</sup> The study found that, despite regulations prohibiting targeting of gambling advertising to under 18s:

"Participants reported what they perceived to be high levels of exposure to gambling advertising and marketing and spoke of the ubiquitous nature of gambling advertising across multiple formats. The most common channels of exposure were identified as TV, social media and the high street – including inside and outside shops, billboards and presence of gambling venues...Seeing betting shops or casino arcades was spontaneously mentioned across the research, with participants arguing that they were more prevalent in less affluent areas. The presence of the shop brand and logo was seen to build brand recognition, and participants noted the window advertising used to prominently display promotions and odds of upcoming events."

The reviewers found that "exposure to the sheer volume of gambling advertising and marketing led to some normalisation of gambling and, on occasion, legitimisation among participants."

#### Public view

Evidence from Bristol University showed that nearly three-quarters of consumers say that they would not want gambling premises on their 'ideal' high street, and there are concerns from those with lived experience of gambling harms that such venues "prey on those that can't afford it and have taken over streets in rundown areas and towns".<sup>10</sup>

#### Conclusion

If a premises licence was granted, this betting shop would lead to likely increased gambling activity with a high risk of harm to vulnerable people who live, work, study and socialise in this mixed-use area. Therefore, we recommend that the application is refused based on the following grounds:

- 1. High numbers of vulnerable people and students in the area and the likely negative health impact on residents and visitors within Sheffield City ward and surrounding wards
- 2. There is already a high concentration of similar premises in the immediate and wider vicinity. The proposed application would create clustering of similar venues which is detrimental to the character, vitality and economic wellbeing of the city centre. There is an existing Adult Gaming Centre at 15 Haymarket which is 0.3km or a 4 minute walk away.
- 3. The likely negative health impact on children and young people, vulnerable people and the cumulative impact when co-located in a high-risk environment.

I am a Police Office in South Yorkshire Police currently seconded to the Home Office as part of Operation GRIP. This is a violent crime initiative looking at where we can reduce violent crime, across South Yorkshire. The majority of what we do is "hot spot policing" This is an evidence based policing model and involves targeted activity where violent crime is most concentrated. It works by defining the hot spot area to understand the problems, second part is to look at the data that is held within the force and then analyse that data to create a full picture of what is happening, in order to plan a response.
We currently have 24 hotspot areas with South Yorkshire across Sheffield, Rotherham, Doncaster and Barnsley.

One of our main hot spot areas in Sheffield city centre is High Street and Fargate with key times where violence is occurring between 1600-2300 daily but spikes during the weekend. We have had 137 recorded violent offences in this area, in a 12 month period, this does not include individual premises that themselves become hot spots in their own right.
I am aware of an application that has been submitted for an adult gaming centre at 9 Fargate Sheffield S1 2HD and would like to raise the following concerns and to object to the application.

The location of the premises is within our main hotspot area for violence and although we cannot attribute violence to a premises not yet open these types of premises often bring about issues of crime and anti-social behaviour due to the clientele they attract.

There are three of these types of premises on Haymarket under ½ mile away and also four bookmakers, in the same location. These venues have caused many issues over the years from violence, criminal damage, ASB, drug dealing and CSE.

I have worked in Sheffield city centre for over 20 years and I have first-hand experience of how these types of premises cause issues outlined above as well as health implications of those that become addicted to gambling.

Due to the issues that were being caused in these premises we launched Bet Watch to try and deter crime and disorder. Although this was positive, once the new gambling legislation around fixed price betting terminals came into force, some bookmakers closed, and the concentration of these venues lessoned in the area. However, some issues have remained and they take a significant amount of resources to elevate the problems caused.

Fargate has been in a state of decline for a number of years and is currently undergoing a transformation using a European grant fund and once completed should bring it back to how it used to be with a concentration of cafes and restaurants and city centre living.

It would be my worry that by allowing this premises to be granted a license that the same problems we experience in the same and similar premises in the city centre will just occur here to, and there is no evidence to suggest that it won't.

City ward councillors would like to strongly object to the application for a gambling establishment at Royal Amusements, 9 Fargate (page 12).

As has been noted in a previous objection by public health to a nearby proposal for a gambling shop in Haymarket, there are a number of land-based gambling premises already existing in the area.

Gambling shops in the city centre have attracted anti-social behaviour which has deteriorated the area, and taken significant resource to address. Introducing a gambling centre to Fargate will risk introducing more antisocial behaviour to Fargate and deteriorating the area, in direct conflict with the council's aims to regenerate Fargate through the Future High Street Scheme.

It also will likely disturb residents living on Fargate, and runs counter to the council's aim to introduce more housing into the city centre and Fargate, by potentially attracting anti social behaviour to the area which would make it a worse place to live as well as visit, as well as incurring additional costs and resource to address.

Officers noted about nearby Fitzalan Square: 'Fitzalan square has had significant reinvestment to improve amenities and the former Post Office is a Sheffield Hallam University site. However, despite some reductions in gambling establishments since the redevelopment it remains an area which has proliferation of gambling and high cost credit in close proximity to sensitive receptors and sensitive locations.'

As noted in government publication: (<u>https://www.gov.uk/government/publications/gambling-related-harms-evidence-review</u>)

'This suggests harmful gambling is related to health inequalities....The most socio-economically deprived and disadvantaged groups in England have the lowest gambling participation rates, but the highest levels of harmful gambling and they are also the most susceptible to harm'

The proposed Fargate location is close to areas of high deprivation, as noted in the public health objection to the nearby Haymarket gambling shop application.

In addition public health officers identified 4 sensitive receptors and locations near the Haymarket location, which applies also to this Fargate application:

'The site visit identified types of sensitive locations in close proximity to the proposed site:

- South Yorkshire Police Snig Hill
- Sheffield Magistrates Court
- Sheffield Hallam University
- Pawnbrokers and cheque cashing/cash converter premises

The sensitive receptors at this site who are potentially more vulnerable to exposure to gambling premises and products are offenders (perhaps 13% prevalence of problem gambling) and young people.

Sheffield Street Outreach Network Meeting (05/10/22) noted concerns around the tendency for street

communities to gravitate towards (nearby Castlegate, Dixon Lane and Exchange Street) as a meeting point (therefore being vulnerable to criminal behaviour in the area such as drug dealing). Many people involved in the street community have substance misuse and other mental health difficulties.'

Many universities students live nearby the proposed Fargate location, as well as nearby Sheffield Hallam University facilities, such as on Fitzalan Square. From the same government gambling publication:

'The highest rates of gambling participation are among people who have higher academic qualifications, people who are employed, and among relatively less deprived groups. People who are classified as at-risk and problem gamblers are more typically male and in younger age groups.'

As well as detriment to the area through attracting anti-social behaviour, we believe a gambling shop in this location would also pose a material risk to the health and wellbeing of vulnerable people, from students to people who may suffer from drug addiction, be rough sleeping and/or homeless, who may use the service.

On the basis that this will be a negative addition to Fargate, which is being regenerated, both for people visiting and living in the area, and would have a material impact to health and wellbeing of young and vulnerable people, we believe this application should be rejected."

Please note that in addition the Cathedral area is also a known area of anti-social behaviour that the council and police are aware of and go to some effort to attempt to address, with the police developing Problem Oriented Plans (POP plans) for this. McDonalds and outside Boots can also be an area of anti-social behaviour.

Adding a gambling shop to this location, an area of known anti-social behaviour, will likely make this worse, as we have seen in Haymarket and Fitzalan Square previously, and also currently in High Street and Cathedral area.

We're also concerned that it would expose vulnerable people to gambling debt, such as students and people who may be suffering from drug addiction, rough sleeping and/or homelessness.

# From ChangingSheff, the residents' association for 27,000 people living in Sheffield City Centre:

This objection is against the Royal Amusements application for an AGC licence at 9 Fargate - next to Café Nero - for a gaming shop with slot machines and jackpot prizes up to £500

- 1. The areas outside the Cathedral, McDonalds and Boots are known for anti-social behaviour which the council and police go to some effort to attempt to address. A gambling shop in this location will likely make this worse, as has been seen in Haymarket and Fitzalan Square. (a comment from Local Councillors)
- 2. Fargate was already a crime 'hotspot' and gambling centres elsewhere in Sheffield such as Fitzalan Square have led to a rise in incidents. (a comment by S.Y. Police)
- 3. The mental health risks associated with harmful gambling raise concerns the proposal could attract vulnerable people. (a comment by the Director of Public Health)
- 4. With the regeneration of Fargate underway at a projected cost of £18million and the goal to turn it into a high-quality events and cultural space, this seems to fly smack in the face of that goal. We don't need Fargate becoming an extension of Haymarket. (a comment by a local resident)
- 5. The proximity of the congregating points for people suffering from mental health issues and drug and alcohol addiction - being the Archer Project, McDonalds and the Cathedral grounds – means that the nearby addition of a facility offering gambling would be like giving a bucket of petrol to a pyromaniac. It would be madness and inevitably make the currently unacceptable situation worse.
- 6. Four recent independent expressions of concern from members of the public to ChangingSheff over the fears being generated in an area of around 100 metres radius around Sheffield Cathedral include:
  - a. "A friend of the wife of one of our committee members was walking up East Parade at the side of the Cathedral one recent lunchtime when she was approached by one of the 'street' community who started demanding money and behaving extremely aggressively and being intimidating right in her face. She ran away and he started to chase after her so she went into the reception of a solicitors. The receptionist asked if she could help and when she told her she said "Oh yes it's a massive problem, it happens all the time. We are always having to get the police out." This was at lunchtime - in the middle of the day in broad daylight.

- b. "Apparently George Street (by the Curzon) is a favourite sleeping place for Street dwellers and some need stepping over to get by. I've also had a report of hordes of teenagers by McDonald's.
- c. "I'm getting more people with mental health issues at the Cathedral, sometimes tipping over to aggression, often with significant personal hygiene issues.
- d. "We've all seen an escalation of ASB recently it might be worth asking if SCC, police and Help Us Help partners are aware of this and can they act?
- 7. Adding a facility that adds gambling in this location is completely unacceptable, as the agencies charged with policing, controlling and supporting the area are having to devote excessive resources to cope with the current situation, so this is going to make their attempts to control the problems even more challenging.
- 8. At the time when Fargate is having an £18millin remodelling exercise, it would be outrageous to add to the situation by accepting a gambling den.
- 9. The three key licensing objectives which guide the way that the Commission and licensing authorities perform their functions and the way that gambling businesses carry on their activities, are:

preventing gambling from being a source of crime or disorder, being associated with crime or disorder, or being used to support crime

ensuring that gambling is conducted in a fair and open way

protecting children and other vulnerable persons from being harmed or exploited by gambling

### The third objective is destined to fail

10 It would be unconscionable for an AGC licence to be granted at 9 Fargate to support a gambling facility. The Licensing Committee is asked to take an authoritative view of its responsibilities and refuse the application.

I oppose this application for a number of reasons.

1. It is only a few feet away from Victoria Hall where we support many people who are addicts. One significant addiction is gambling and several of those who are supported by us are very upset that they will have to walk past this centre to get to our front door where they are offered support.

2. The City of Sanctuary is housed on Chapel Walk and there are many who will walk past this gambling centre who are on very low income and are being supported as they go through the process of being an assylum seeker and refugee. They may find it attractive to spend the little money they have on the illusive dream that they may win some significant money to live on. Others may consider it a place to take their mind off the stress and the loneliness.

3. I know that there is much work being done to re-develop Fargate and Chapel Walk as a destination for people with some retail, but also attractive places for people to meet to eat, drink and be entertained and to socialise. Is such a gambling shop in keeping with the exciting and weclomed blue print for this part of Sheffield? I would suggest that for those with families coming into the city it wouldnt. Neither would it be for teenagers who could be tempted to go into such places. It would certainly remain a temptation for those who have addiction issues with gambling.

I work alongside other organisations who are looking to support the vulnerable and those with addictions and I really do feel that this amusement shop would be in the wrong place and ask you to seriusly consider my oppoaition.

I am writing on behalf of The Foundry Sheffield who lease the Victoria Hall building on Chapel Walk, in regards to the application for a premises licence under the Gambling Act 2005 at 9 Fargate, Sheffield. S1 2HD which we strongly oppose.

The Foundry is a CIO which exists to help improve the lives of the inhabitants of the people of Sheffield and surrounding areas through providing spaces and facilities to charities and organisations at low cost rates. The building is a community hub of a variety of support services, including addiction support groups. The Victoria Hall building has a footfall of approximately 1500 individuals each week, accessing support services.

Opening a gambling premises at the end of the walk could be dire to so many individuals who access the support services at Victoria Hall. The services and facilities provided contribute to less anti social behaviour around the end of Fargate, and for many of these individuals, they are trying to remove themselves from old habits and ways. The introduction of a gambling shop could devastate the progress made or force them to not access the services that they so desperately need.

A reduction in individuals accessing the services will likely have a negative effect within the town centre as they will have nowhere else to go and there may then be an increase in antisocial behaviour.

The gambling shop will negatively affect our organisation and reduce the footfall down Chapel Walk, which is the opposite effect of what the council are trying to achieve currently.

Gambling shops increase anti social behaviour and we have staff members who lone work until midnight or later, increasing the risk of staff not getting home safely or feeling vulnerable when leaving work.

I have been passed your details as being the relevant person to raise objections against the Adult Gaming Licence being sought for 9 Fargate.

My understanding is that this needs to reference the undermining of one or more of the three licensing objectives and I believe that this is the case.

With respect to "preventing gambling from being a source of crime or disorder, being associated with crime or disorder, or being used to support crime" I am concerned that the location of such a premise so close to an area that is already subject to a high degree of anti-social behaviour and crime will only exacerbate an existing problem and at the very least make it more difficult to manage. We already work closely with the local NPT and the City Centre teams to encourage a presence around the Cathedral and Fargate and I am aware from our conversations how stretched their resources already are. The location of a gambling location would likely only add to the stressors and problems in an already under pressure area of the City.

With regards to "protecting children and other vulnerable persons from being harmed or exploited by gambling", I am very concerned that its location will increase chances of exploitation for various groups of vulnerable people who engage with the Cathedral. This includes vulnerable people accessing the space as a place of worship, for pastoral support and/or to engage in some of the activities that take place here. There is also a concern around the vulnerability of people who access peer support programmes in the building and those that are currently engaging with the Archer Project and are, by definition, some of the most vulnerable people in our City. It would seem entirely unhelpful to be placing an establishment such as is being proposed so close to a place where so many vulnerable people are regularly accessing support.

This area is already identified by the Police, Sheffield City Council and residents as a hotspot for anti social behaviour. A police operation is in progress to alleviate the situation. There is little evidence of change for the better since it is a difficult and complex process to change behaviours. The addition of a gambling venue will only make the problem worse as has been evidenced by the problems around a similar place in Haymarket and by research studies.

It is highly improbable that this venue could be run to avoid increasing crime and disorder.

In addition the people who spend time around the top of High Street and Fargate are vulnerable and prone to peer pressure to engage in gambling beyond their means.

Young people often gather in the immediate vicinity close to McDonalds and there is potential for them bring drawn into gambling by the proximity of this "amusement".

The renovation of Fargate and the development of new retail and leisure will inevitable bring more people into the area, which may be good trade for the gambling venue but be harmful to society in increasing harm through gambling and anti social behaviour.

I strongly object to this application on the basis of clear evidence that the presence of a gaming shop will increase crime and disorder and be draw the young and vulnerable into harmful gambling.

#### NOTES

#### Right of attendance, assistance and representation

A party may attend the hearing and may be assisted or represented by any person, whether or not that person is legally qualified.

The hearing will generally take place in public. However, the Sub-Committee may exclude the public from all or part of a hearing where it considers that the public interest in so doing outweighs the public interest in the hearing, or that part of the hearing, taking part in public. In such circumstances, a party and any person assisting or representing a party may be treated as a member of the public. The Sub-Committee will exclude the public (and the parties and their representatives) during the decision making process.

The Sub-Committee may require any person attending the hearing who in its opinion is behaving in a disruptive manner to leave the hearing, and may refuse to permit that person to return, or permit him to return only on such conditions as the Sub-Committee may specify. However, such a person may, before the end of the hearing, submit to the Sub-Committee in writing any information which he would have been entitled to give orally had he not been required to leave.

#### **Representations and supporting information**

At the hearing a party shall be entitled to:

(a) Give further information as applicable in response to a point upon which notice has been given to that party that clarification is required. (Note – if such clarification is required from a party this will have been indicated in the Notice of Hearing).

(b) Question any other party, but only if given permission by the Sub-Committee; and

(c) Address the Sub-Committee

#### Failure of parties to attend the hearing

If a party has given notice that he does not intend to attend or be represented at a hearing, the hearing may proceed in his absence.

If a party who has not so indicated fails to attend or be represented at a hearing, the Sub-Committee may, where it considers it to be necessary in the public interest, adjourn the hearing to a specified date, or hold the hearing in the party's absence. If the hearing proceeds in a party's absence, the Sub-Committee will consider and give appropriate weight to the application, representation or notice given by that party in their absence.

#### **Representations and Evidence**

A party who wishes to rely on information or documentary evidence that has not been submitted in advance of the issue of the Notice of Hearing should ensure that such information or evidence, together with sufficient copies for all the parties, is submitted to the Licensing Authority as soon as possible before the day of the hearing.

Parties are reminded that documentary or other information submitted on the day of the hearing may only be taken into account with the consent of all the other parties.

A party who wishes to produce audio/visual evidence should make such evidence available as soon as practical, and should give a minimum of two clear working days notice to the Licensing Authority to facilitate arrangements for the appropriate equipment to be available at the hearing.

#### **Procedure at hearing**

A summary of the procedure that will normally the followed at the hearing is enclosed.

It should be noted that this is a general procedure intended to cover matters that will normally be applicable at all hearings.

However, depending on the circumstances of each individual case, it is recognised that other issues may need to be considered as preliminary points at the hearing. These may include (but are not limited to):

- Whether to proceed in the absence of a party
- Whether to admit new documents/information submitted at the hearing
- Whether it is in the public interest to exclude members of the public from the hearing or any part of the hearing (other than the decision making process)
- Whether any party wished to withdraw representations previously submitted

#### **Special Needs**

Any person who intends to attend a hearing and who has special needs, for example in connection with access, language, hearing or vision, should inform the Licensing Authority as soon as practical prior to the day of the hearing, so that appropriate provision or arrangements may be made.

#### Regulations

#### Failure of parties to attend the hearing

- **10.** (1) A relevant committee may proceed with a hearing in the absence of a party or a party's representative if the party has—
  - (a) informed the committee that he does not intend to attend or be represented at the hearing (and has not subsequently advised the committee otherwise);
  - (b) failed to inform the committee whether he intends to attend or be represented at the hearing; or
  - (c) left the hearing in circumstances enabling the committee reasonably to conclude that he does not intend to participate further.
  - (2) If a party has indicated that he does intend to attend or be represented at the hearing, but fails to so attend or be so represented, the relevant committee may—
    - (a) adjourn the hearing to a specified date if it considers it to be in the public interest, or
    - (b) proceed with the hearing in the party's absence.
  - (3) Where the hearing proceeds in the absence of a party, the relevant committee must consider at the hearing the application or representations made by that party.
  - (4) Where, under this Regulation, the relevant committee adjourns the hearing to a specified date it must, as soon as reasonably practicable, notify the parties of the date, time and place to which the hearing has been adjourned.

#### Hearings to be public

- 8. (1) Subject to paragraph (2), the hearing must take place in public.
  - (2) A relevant committee may direct that all or part of a hearing must be in private if it is satisfied that it is necessary in all the circumstances of the case, having regard to—
    - (a) any unfairness to a party that is likely to result from a hearing in public; and
    - (b) the need to protect as far as possible, the commercial or other legitimate interests of a party.

#### Proceedings of a relevant committee in conducting a hearing

- **9.** (1) Subject to regulations 8 and 11, a relevant committee must permit a party to attend a hearing and be assisted or represented by any person whether or not that person is legally qualified.
  - (2) At the beginning of the hearing the relevant committee must explain the procedure that it proposes to follow in conducting the hearing.
  - (3) In conducting a hearing the relevant committee must ensure that each party is given the opportunity to—
    - (a) address the relevant committee on any matter that is relevant to the application or review, or any representations made on the application or review;
    - (b) call witnesses to give evidence on any matter that is relevant to the application or review, or any representations made on the application or review;
    - (c) provide further information on, or explanation of, any matter on which the relevant committee has indicated that it will want further clarification under regulation 6(1)(j).
  - (4) In conducting a hearing the relevant committee must also-
    - (a) permit any party to question any other party or person representing a party on any matter that is relevant to the application or review, or any representations made on the application or review, where the relevant committee considers that in all the circumstances it is appropriate to do so; and
    - (b) take into consideration documentary or other information in support of the application or representations produced by a party—
      - (i)before the hearing; or
      - (ii)at the hearing, with the consent of all the other parties attending the hearing.
  - (5) Without prejudice to paragraphs (3) and (4), a hearing must be conducted so that it takes the form of a discussion led by the relevant committee, and the committee must not permit any cross-examination unless it considers that cross-examination is required for it properly to consider the application or representations made by any party.

### Gambling Act 2005 – Hearing Procedure – Regulation 9

# This procedure has been drawn up in accordance with the Gambling Act 2005 to assist those parties attending Licensing Committee hearings.

- 1. The hearing before the Council is Quasi Judicial.
- 2. The Chair of the Licensing Committee will introduce the Committee and ask officers to introduce themselves.
- 3. The Chair will ask the applicants to formally introduce themselves.
- 4. The Solicitor to the Committee will outline the procedure to be followed at the hearing.
- 5. Hearing Procedure:-
  - (a) The Licensing Officer will introduce the report.
  - (b) Questions concerning the report can be asked both by Members and the applicant.
  - (c) The Licensing Officer will introduce in turn representatives for the Responsible Authority and Interested Parties who will be asked to detail their relevant representations.
  - (d) Members may ask questions of those parties
  - (e) With the leave of the Chair the applicant or his representative may cross examine the representatives of the Responsible Authorities and Interested Parties.
  - (f) The applicant/licensee (or his/her nominated representative) will then be asked to:-
    - (i) detail the application;
    - (ii) provide clarification on the application and respond to the representations made.
  - (g) The applicant/licensee (or his/her nominated representative) may then be asked questions by members and with the leave of the Chair from the other parties present.
  - (h) The applicant will then be given the opportunity to sum up the application.
  - (i) The Licensing Officer will then detail the options.
  - (j) There will then be a private session for members to take legal advice and consider the application.
- 6. The decision of the Licensing Committee will be given in accordance with the requirements of the Gambling Act 2005 and regulations made there under.
- NB: 1) At any time in the Licensing Process Members of the Committee may request legal advice from the Solicitor to the Committee. This advice may be given in open session or in private.
  - 2) The Committee Hearing will be held in public unless and in accordance with the Regulations the Committee determine that the public should be excluded.
