1. APOLOGIES FOR ABSENCE

- 1.1 Apologies for absence had been received from Dr David Black, Councillor Douglas Johnson, Paul Ferguson, Emma Latimer, Dr Zak McMurray, Judy Robinson, Dr Leigh Sorsbie, Rob Sykes, Meredith Teasdale, Alison Wells, Salma Yasmeen.
- 1.2 The Chair, Councillor Angela Argenzio thanked Dr David Black for his contribution to the Board as he was standing down and being replaced by Mark Tuckett.

2. DECLARATIONS OF INTEREST

2.1 There were no declarations of interest.

3. BETTER CARE FUND UPDATE

- 3.1 The report, which provided a Quarter 4 Better Care Fund update, and a Better Care Fund 2024/25 Refresh update, was presented by Martin Smith (Assistant Director of Transformation & Delivery NHS South Yorkshire ICB (Sheffield Place) / Sheffield City Council).
- 3.2 Board Members discussed whether the "Team Around the Person" target relating to not keeping patients in hospital for too long, had actually led to people being discharged home too soon, and were advised that in Sheffield there were a range of options for intermediate care, the ultimate aim of which was to help people to live independently. This had been a priority in patient feedback.
- 3.3 A request was made for the Better Care team to give greater thought to inequality

- and to consider whether more could be done in this respect via smarter use of resources. Martin Smith advised that this could be considered further and was already being looked at regarding Covid recovery.
- 3.4 Board Members requested clarification as to what they were being asked to do to promote the services available to unpaid carers. Martin Smith advised that an Unpaid Carers group had been established and that carer support was built into the ICB (Integrated Care Board) quality contract and was at the forefront of Better Care Fund priorities. Board Members doing what they could to share information on this would be helpful and Martin Smith agreed to share information with the Board to help with this. It was noted that a Health and Wellbeing Board discussion had recently been held on this topic and the Council had a multi-disciplinary Carers Delivery Plan in Place. A leaflet had been produced regarding how to support people leaving hospital and work was being done within the Council to understand the demographics of unpaid carers.
- 3.5 The Chair, Councillor Angela Argenzio, requested that data regarding the demographics of unpaid carers be included in a future Better Care Fund report.
- 3.6 **RESOLVED**: That the Sheffield Health and Wellbeing Board:
 - (a) Notes the 2023/24 Better Care Fund Q4 update.
 - (b) Notes the submission of the 2024/25 refresh planning template; and
 - (c) Delegates in year oversight to the Joint Strategic Executive Meeting and sign off of in year reporting to the Board Co-Chairs.

4. JOINT HEALTH AND WELLBEING STRATEGY

- 4.1 The report, which presented an update on the development of the Sheffield Joint Local Health and Wellbeing Strategy 2024-2034, was presented by Susan Hird (Assistant Director of Public Health, Sheffield City Council), and Helen Watson (Public Health Registrar, Sheffield City Council).
- 4.2 **RESOLVED**: That the Sheffield Health and Wellbeing Board:
 - (a) Notes the summary report of the outcomes of the strategy workshop on the 23rd May.
 - (b) Approves the wording of the four radical shifts and the Board's collective commitments found in Appendix 3 of the report.
 - (c) Will develop individual commitments to the radical shifts if they were unable to attend the workshop on 23rd May.
 - (d) Notes the current descriptions of the eight building blocks found in Appendix 4 of the report, and will make any relevant comments to support further development.
 - (e) Notes the design concept for the new Health and Wellbeing Board Microsite which will host the strategy.
 - (f) Supports using language everyone can understand in the microsite content.
 - (g) Agrees to participate in developing video content for the microsite and blogstyle content.
 - (h) Notes the timescales for finalising and publishing the new strategy. Will

participate in a further development workshop on 19th July 2024; and (i) Will provide any additional steer and guidance including the role of the public and partner organisations in development and endorsement of the Strategy.

5. GROWTH PLAN

- 5.1 The report, which gave an update on the Growth Plan, was presented by Diana Buckley (Director of Economy, Skills and Culture, Sheffield City Council). A presentation was delivered which was published on the Council's website.
- 5.2 The Board welcomed neighbourhoods being a key aspect of the plan and emphasised that good growth was growth which worked for neighbourhoods and communities. Board Members were reminded that in establishing this it was important to hear from people with disabilities. Members noted that foundational sectors, including health and social care, formed the majority of jobs in the city, and this led to an intersection with the work of the Board. Members discussed the opportunity for the city to be a centre for the development of national and international Health and Wellbeing, e.g. via universities and the teaching hospitals, and the importance of involving the Knowledge Sector, in order to attract more investment.
- 5.3 Members also emphasised the need to ensure local infrastructure such as housing, transport and GP practices kept up with growth, in order to avoid "stretch" and noted that this was embedded in the approach of the Growth Plan.
- 5.4 **RESOLVED**: That the Sheffield Health and Wellbeing Board notes the Growth Plan update.

6. CHANGING FUTURES

- The report which gave an update on Changing Futures, was presented by Sam Martin (Head of Commissioning, Sheffield City Council), Vic Stirling (Head of Service, South Yorkshire Housing Association), Jessie Adams (Changing Futures Programme Manager), and Lewis Goodyear (Programme Co-ordinator, Changing Futures).
- 6.2 Members thanked the Changing Futures team for what they considered to be an excellent piece of work that the city should be proud of. The importance of making the case for continued funding and staffing of this approach of direct engagement and positive support, was emphasised. The need to embody it across all Council services, was stressed, particularly when working with people with complex needs, in order to avoid them being "bounced around" different services. Members underlined that the approach would have a huge impact on the lives of children and young people. It was agreed that further thought needed to be given to what mechanisms were needed to embed learning from the project and that a future update on the work would be beneficial when appropriate.

- 6.3 Members commented on the success of the codesign and coproduction which had been an equal and meaningful partnership which should be continued.
- 6.4 **RESOLVED**: That the Sheffield Health and Wellbeing Board notes the Changing Futures update.

7. COUNCIL PLAN

- 7.1 The report which updated the Board on the Sheffield City Council Plan was presented by Kate Josephs (Chief Executive, Sheffield City Council).
- 7.2 **RESOLVED**: That the Sheffield Health and Wellbeing Board notes the content and framing of the Council Plan, and the strong cross reference of this with the City Goals and with the refreshed Joint Health and Wellbeing Strategy.

8. MINUTES OF THE PREVIOUS MEETING
