#### REPORT TO THE EXECUTIVE LEADER

#### **MONTH 11 2015/16 CAPITAL APPROVALS**

#### 1. SUMMARY

- 1.1 A number of schemes have been submitted for approval in line with the Council's capital approval process. In line with the financial reporting calendar, these schemes would normally go forward for approval at the Cabinet to be held in April. However, the April cabinet meeting has been cancelled and the next scheduled meeting is set for June 2016. In order to avoid unnecessary delay to the progress of these projects, approval is sought through a Leader's Executive Decision.
- 1.2 Below is a summary of the number and total value of schemes in each approval category:
  - 10 additions of specific projects to the capital programme with a value of £5.5m.
  - 8 variations to the capital programme creating a net decrease of £1.7m and
  - 3 requests for slippage amounting to £8.6m.

Three variations were undertaken under delegated approval powers.
