## What are the brief aims of the policy/project/decision?

Sheffield has a long history of management and delivery of refugee resettlement programmes. Since 2004 the Council has resettled over 1100 refugees via the Gateway Protection Programme, GPP, and by the end of April 2016 had resettled 48 refugees via the Syrian Vulnerable Persons Relocation Scheme, VPRS.

The Council has recently agreed to work in Partnership with Migration Yorkshire and all authorities in Y & H to resettle Syrian VPRS refugees between April 2016 and March 2019. The Council plans to resettle 225 Syrian refugees in this period.

The Council's current involvement in the Gateway protection programme is due to end in March 2017.

This EIA has been drafted to accompany the Cabinet report which is seeking approval for the Council to enter into delivery of the Gateway Protection Programme for a further 4 years resettling 495 refugees in Sheffield and Hull between April 2016 to March 2019.

Sheffield has led a successful partnership with Hull City Council and the British Refugee Council delivering resettlement to refugees under the Gateway Protection Programme since April 2011.

Within Sheffield, Housing Association and private rented accommodation will be used to house refugees and Home Office grant funding will fund a range of specified support measures and integration support to ensure the refugees are supported to successfully integrate.

If refugees do become victims of crime, ASB etc we will ensure that they receive appropriate support. Refugees receive a Home Office orientation into life in the UK. They are made aware of the UK law and its enforcement. Case workers work closely with refugees in the early months to ensure refugees are safe, limiting the possibility of them becoming victims of crime as well as ensuring the refugees understand the law within the UK and do not become involved in crime.
