Decision to be removed from Call-in process:-

- (a) The awarding bodies, the Ministry of Housing, Communities and Local Government and The National Lottery Community Fund, announced the funding award for Sheffield City Council on the 16th July 2021. This was following a four week delay in them making the announcement.
- (b) Sheffield City Council have been given a deadline of the 21st July 2021 to accept this funding in order that the first payment can be made quickly and the programme launched in line with our mobilisation schedule.
- (c) This funding is critical in supporting Sheffield City Council to fulfil its responsibility to vulnerable adults in the city and realise longer term system change ambitions around the support of this cohort. Failure to accept this funding within the designated time frame may lead to the funding offer being withdrawn.
- (d) Please note that the Changing Futures programme has been developed to facilitate further scrutiny and review influencing the delivery of the programme and that any decision to fast track this decision is linked entirely to the limited timeframe provided for accepting this funding.

Reasons for Urgency

To avoid the loss of this grant funding and the subsequent detrimental impact on the future provision of services in Sheffield.

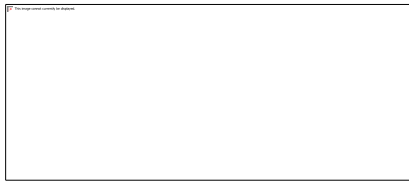
