- 4) Notes the implementation of the Omicron Hospitality and Leisure Grant scheme as required by Government

## **Reasons for Urgency**

- The grants are being made available to businesses that are suffering from a loss
  of trade and income as a result of the Omicron variant and restrictions. It is critical
  to ensure that financial support to businesses is provided as quickly as possible to
  assist their survival and encourage employee retention which in turn protects the
  wider Sheffield economy.
- 2) The ARG guidance requires all ARG funding to be defrayed by 31<sup>st</sup> March 2022. To meet this deadline all applications need to be submitted no later than the end of February 2022 in order to be verified and paid. In order to give businesses the maximum opportunity to access support it is critical to launch the scheme as soon as possible.
