Purpose of Report:

This report provides details of proposed changes to the existing Capital Programme relating to other committees, new additions in relation to Strategy & Resources Committee and one urgent new approval in relation to Education, Children & Families Committee as brought forward in Month 01 2020/21.

In addition it provides details of the changes to the capital programme required as part of the year end close down process requiring formal ratification

Recommendations:

- (ii) That the committee approve the budget adjustments required as part of the financial year end close down procedure as detailed in Appendix 2

- Accelerated expenditure of projects in delivery from 21/22 to 22/23 of £0.8m

- Overspends – net additions to the programme £3.1m

- Underspends - £6.6m

- Internal Adjustments (including reallocation of underspends) - $\pounds 2.9m$

1. PROPOSAL

1.1 The proposed changes to the Capital programme will improve the recreational leisure facilities, schools, roads and homes used by the people of Sheffield, and improve the infrastructure of the city council to deliver those services.

2. HOW DOES THIS DECISION CONTRIBUTE ?

2.1 By delivering these schemes the Council seeks to improve the quality of life for the people of Sheffield.

3. HAS THERE BEEN ANY CONSULTATION?

3.1 Any appropriate consultation was carried out at the original approval of the schemes included

4. RISK ANALYSIS AND IMPLICATIONS OF THE DECISION

- 4.1 <u>Equality Implications</u>
- 4.1.1 Any Equality implications are the responsibility of the service area under which the approval falls.

4.2 Financial and Commercial Implications

- 4.2.1 A number of schemes have been submitted for approval in line with the Council's capital approval process during the Month 12 reporting cycle. This report requests the relevant approvals and delegations to allow these schemes to progress.
- 4.2.2 Below is a summary of the number and total value of schemes in each approval category:
 - 2 additions of specific project to the capital programme creating a net increase of £84k
 - 5 variations to specific projects and allocations in the capital programme creating a net decrease of £6.567m
- 4.2.3 Further details of the schemes listed above can be found in Appendix 1.
- 4.2.4 In addition the budget adjustments required as part of the year end close down process are also presented for approval:
 - Slippage of expenditure of projects in delivery from 21/22 to

22/23 - £29.1m

- Re-profiling of schemes not in delivery from 21/22 to 22/23 – \pm 13.9m

- Accelerated expenditure of projects in delivery from 21/22 to 22/23 of $\pounds 0.8m$

- Overspends - net additions to the programme £3.1m

- Underspends - £6.6m

- Internal Adjustments (including reallocation of underspends) - £2.9m

- 4.2.5 It should be noted that these amounts represent know variations to existing projects and allocations. The approvals are required to reflect these in the capital budget as part of the year end close down process.
- 4.2.6 Also note 21/22 Outturn figures are presented by Corporate Ambition, while 22/23 approvals are presented by ne Policy Committee Area.
- 4.2.7 A summary of these adjustments by priority and full details on a scheme by scheme basis can be found at Appendix 2
- 4.2.8 Further analysis of this position will be provided in the Capital outturn report.
