REPORT OF THE CHIEF LICENSING OFFICER (HEAD OF LICENSING) TO THE LICENSING SUB COMMITTEE LICENSING ACT 2003

1.0 PURPOSE OF REPORT

1.1 To consider an application for the variation of a premises licence made under Section 34 of the Licensing Act 2003.

2.0 THE APPLICATION

- 2.1 The applicant is Mr Ata Azadi.
- 2.2 The application was received by the Licensing Service on the 9th June 2022, and is attached to Appendix 'A' of this report.
- 2.3 A copy of the current Premises Licence is attached at Appendix 'B'.
- 2.4 This case was originally listed to be heard on the 2nd August 2022, but due to representations from Health Protection and Environmental Protection Services both being in concern of the layout of the premises and extensive works proposed, it was agreed that a deferral would be granted to allow time for works to be completed and new plans to be agreed. Unfortunately, these works and subsequent plans have not been submitted in time, and the issues raised within the representations are still outstanding.

3.0 REASONS FOR REFERRAL

- 3.1 Outstanding representations concerning the application have been received from the following Responsible Authorities and is attached at Appendix 'C'.
 - 1 x Health Protection Service
 - 1 x Environmental Protection
- 3.2 The applicant and objectors who made written representations have been invited to attend the hearing. Copies of the front page of the notices are attached to this report labelled Appendix 'D'.

4.0 FINANCIAL IMPLICATIONS

4.1 There are no specific financial implications arising from this application. However, additional costs may be incurred should the matter go to appeal. In such an eventuality it may not be possible to recover all these costs. The impact of these additional costs (if any) will be kept under review and may be subject of a further report during the year.

5.0 THE LEGAL POSITION

- 5.1 The Licensing Act 2003 at section 4 (1) requires the Licensing Authority to carry out its functions with a view to promoting the Licensing Objectives which section 4(2) sets out as:
 - a) the prevention of crime and disorder;
 - b) public safety;
 - c) the prevention of public nuisance;
 - d) the protection of children from harm.
- 5.2 Section 4(3) of the Licensing Act also requires the Licensing Authority to have regard to the published statement of Licensing Policy and any guidance issued by the Secretary of State under section 182.

6.0 HEARING REGULATIONS

- 6.1 Regulations governing hearings under the Licensing Act 2003 have been made by the Secretary of State.
- 6.2 The Licensing Authority has provided all parties with the information required in the Regulations to the 2003 Act as set out at Appendix 'D'.
- 6.3 Attached at Appendix 'D' is the following:
 - a) a copy of the Notice of Hearing;
 - b) the rights of a party provided in Regulations 15 and 16;
 - the consequences if a party does not attend or is not represented at the hearing
 - d) the procedure to be followed at the hearing.

7.0 APPEALS

7.1 The Licensing Act 2003 section 181 and Schedule 5 makes provision for appeals to be made by the applicant and those making representations against decisions of the Licensing Authority to the Magistrates' Court.

8.0 RECOMMENDATIONS

8.1 That Members carefully consider the representations made and take such steps as the Sub-Committee consider appropriate for the promotion of the Licensing Objectives.

9.0 OPTIONS OPEN TO THE COMMITTEE

- 9.1 To vary the premises licence in the terms requested.
- 9.2 To vary the premises licence with conditions.
- 9.3 To reject the whole or part of the application.

Michelle,

I hope you are well. Thanks for the call back.

I have the following representation to make with regards to Public Nuisance for the application for a premises licence for the above premises.

The premises are located in close proximity to residential accommodation. I am therefore concerned that nearby residents could potentially be affected by excessive noise disturbance from the use of the premises for longer and/ or later hours on some days, noise breaking out of the premises and noise from people outside the venue in the later evening.

Unfortunately I have not been able to visit the premises to assess the buildings suitability for retaining sound, especially on the first floor which was not previously part of the licensed premises. I have therefore submitted this representation to raise my concerns as the closing date is today.

I'm hopeful that the refurbishment will include suitable glazing that will prevent excessive noise escaping from the premises, to help assist in Preventing Public Nuisance.

I look forward to our meeting tomorrow 8/7/22 @ 2pm to ensure that alterations to the fabric of the building have not compromised the premises ability to contain sound.

706929-30 Ottos, Sharrow Vale Road - Variation Application

I represent Sheffield City Council's Health and Safety Enforcement Team in the Health Protection Service as Responsible Authority for Public Safety for this application.

I note from the documents that major refurbishment is planned/taking place at the premises and would like to check with you if the premises was built before the year 2000. If this is the case can you please advise me if an asbestos renovation survey has been carried out as I will need to know this.

There are two types of asbestos survey:

- Asbestos Management Survey This type of survey is for managing asbestos in the premises where major change is not being carried out.
- A Refurbishment & Demolition Survey where full access, sampling and identification is required. This type of survey is normally recommended prior to demolition or major refurbishment work commencing in the survey area to identify all asbestos containing materials to be removed as far reasonably practicable before major refurbishment or final demolition.

I have gone through all to documents you have sent but unfortunately a number of issues remain unanswered. I understand Sean will discuss with you when you meet next week.

25/08/22 - Additional information and plans received from Michelle Hazelwood. Revised Plans – these are still unsatisfactory

It is noted that 'the drawings, plans, sketches etc. are provided to our clients based upon information provided by the client and drawn in accordance with common building practices and local codes. None of the employees are registered architects, engineers or land surveyors...'

1. The stepped entrance to the premises is not shown.

- 2. The drawings do not show the changes in level to the fire exit to Steel Road. The temporary ramp seen at time of visit did not comply with Part M of the building regulations, and a compliant ramp or steps will need to be shown.
- 3. There is no indication where the goods lift terminates in the kitchen as it is not marked on the ground floor plan.
- 4. The bar or bars are not shown.
- 5. The external terrace and other rooms are not adequately identified.
- 6. No information on internal stair dimensions or external stair from the terrace have been provided as requested.

I understand from the correspondence the number of internal covers is to be 60. An asbestos survey has been submitted following action taken by the Health and Safety Executive and found to be satisfactory.

Application

There is no mention of an additional outside first floor terrace on the licence application form and it is not identified in the original drawings or identified as such on the updated plan.

I propose these conditions for consideration.

- 1. A Building Regulation Completion Certificate shall be submitted to the responsible authority for public safety prior to opening for business.
- 2. A satisfactory Electrical Installation Certificate shall be submitted to the responsible authority for public safety prior to opening for business. (If an electrical condition report is provided it should cover 100% of the premises).
- 3. A permanent fixed residual current device (RCD) must protect the electrical power serving all amplified music equipment used for the purposes of live music or similar entertainment.
- 4. A structural engineers report shall be submitted confirming that the single-story roof is suitable to be used as a outdoor seating area or terrace for a dynamic load commensurate for the purpose and numbers of people using it.
- 5. There shall be no transportation of hot food and drinks using the public staircase between the ground floor and the first floor (whilst open to members of the public).

NOTES

Right of attendance, assistance and representation

15. Subject to regulations 14(2) and 25, a party may attend the hearing and may be assisted or represented by any person whether or not that person is legally qualified.

Representations and supporting information

- 16. At the hearing a party shall be entitled to
 - (a) in response to a point upon which the authority has given notice to a party that it will want clarification under regulation 7(1)(d), give further information in support of their application, representations or notice (as applicable),
 - (b) if given permission by the authority, question any other party; and
 - (c) address the authority

Failure of parties to attend the hearing

- 20. (1) If a party has informed the authority that he does not intend to attend or be represented at a hearing, the hearing may proceed in his absence.
 - (2) If a party who has not so indicated fails to attend or be represented at a hearing the authority may:—
 - (a) where it considers it to be necessary in the public interest, adjourn the hearing to a specified date, or
 - (b) hold the hearing in the party's absence.
 - (3) Where the authority holds the hearing in the absence of a party, the authority shall consider at the hearing the application, representations or notice made by that party.
 - (4) Where the authority adjourns the hearing to a specified date it must forthwith notify the parties of the date, time and place to which the hearing has been adjourned.

Procedure at hearing

- 21. Subject to the provisions of the Regulations, the authority shall determine the procedure to be followed at the hearing.
- 22. At the beginning of the hearing, the authority shall explain to the parties the procedure which it proposes to follow at the hearing and shall consider any request made by a party under regulation 8(2) for permission for another person to appear at the hearing, such permission shall not be unreasonably withheld.
- 23. A hearing shall take the form of a discussion led by the authority and cross-examination shall not be permitted unless the authority considers that cross-examination is required for it to consider the representations, application or notice as the case may require.
- 24. The authority must allow the parties an equal maximum period of time in which to exercise their rights provided for at regulation 16.
- 25. The authority may require any person attending the hearing who in their opinion is behaving in a disruptive manner to leave the hearing and may
 - (a) refuse to permit that person to return, or
 - (b) permit him to return only on such conditions as the authority may specify.
 - but such a person may, before the end of the hearing, submit to the authority in writing any information which they would have been entitled to give orally had they not been required to leave.

Regulation 8

- (1) A party shall give to the authority within the period of time provided for in the following provisions of this regulation a notice stating
 - (a) whether he intends to attend or be represented at the hearing;
 - (b) whether he considers a hearing to be unnecessary
- (2) In a case where a party wishes any other person (other than the person he intends to represent him at the hearing) to appear at the hearing, the notice referred to in paragraph (1) shall contain a request for permission for such other person to appear at the hearing accompanied by details of the name of that person and a brief description of the point or points on which that person may be able to assist the authority in relation to the application, representations or notice of the party making the request.
- (3) In the case of a hearing under
 - (a) section 48(3)(a) (cancellation of interim authority notice following police objection), or
 - (b) section 105(2)(a) (counter notice following police objection to temporary event notice),

the party shall give the notice no later than one working day before the day or the first day on which the hearing is to be held.

- (4) In the case of a hearing under
 - (a) section 167(5)(a) (review of premises licence following closure order),
 - (b) paragraph 4(3)(a) of Schedule 8 (determination of application for conversion of existing licence), paragraph 16(3)(a) of Schedule 8 (determination of application for conversion of existing club certificate)
 - (c) paragraph 26(3)(a) of Schedule 8 (determination of application by holder of justices' licence for grant of personal licence),

the party shall give the notice no later than two working days before the day or the first day on which the hearing is to be held.

(5) In any other case, the party shall give the notice no later than five working days before the day or the first day on which the hearing is to be held.

<u>Licensing Act 2003 – Hearing Procedure – Regulation 7 (1)</u>

This procedure has been drawn up in accordance with the Licensing Act 2003 to assist those parties attending Licensing Committee hearings.

- 1. The hearing before the Council is Quasi Judicial.
- 2. The Chair of the Licensing Committee will introduce the Committee and ask officers to introduce themselves.
- 3. The Chair will ask the applicants to formally introduce themselves.
- 4. The Solicitor to the Committee will outline the procedure to be followed at the hearing.
- 5. Hearing Procedure:-
 - (a) The Licensing Officer will introduce the report.
 - (b) Questions concerning the report can be asked both by Members and the applicant.
 - (c) The Licensing Officer will introduce in turn representatives for the Responsible Authority and Interested Parties who will be asked to detail their relevant representations.
 - (d) Members may ask questions of those parties
 - (e) With the leave of the Chair the applicant or his representative may cross examine the representatives of the Responsible Authorities and Interested Parties.
 - (f) The applicant/licensee (or his/her nominated representative) will then be asked to:-
 - (i) detail the application;
 - (ii) provide clarification on the application and respond to the representations made.
 - (g) The applicant/licensee (or his/her nominated representative) may then be asked questions by members and with the leave of the Chair from the other parties present.
 - (h) The applicant will then be given the opportunity to sum up the application.
 - (i) The Licensing Officer will then detail the options.
 - (j) There will then be a private session for members to take legal advice and consider the application.
- 6. The decision of the Licensing Committee will be given in accordance with the requirements of the Licensing Act 2003 and regulations made there under.
- NB: 1) At any time in the Licensing Process Members of the Committee may request legal advice from the Solicitor to the Committee. This advice may be given in open session or in private.
 - 2) The Committee Hearing will be held in public unless and in accordance with the Regulations the Committee determine that the public should be excluded.
