I live in Carter Knowle, and Archer Lane is the main point of access for our regular journeys to Nether Edge where I have a young child in nursery. There also seems to be completely inadequate consultation or notification of local residents - as I

understand it, this Active Neighbourhood is due to be implemented on 25 April, yet there has been no notification apart from a postcard on certain streets in a very small area. I only spotted the proposals belatedly on a local Facebook site; there will be many people who will be unaware.

As you will know, many people travel into Nether Edge from surrounding areas, for work, for leisure, for social activities, and there should have been more widespread consultation and notification, particularly for those residents who live adjacent to Archer Lane and use it as an essential route for regular journeys. As an example, my family use it for the nursery and school run every day (a round trip of 3 miles), for access to gym and local leisure, for playdates, and for other social activities. Cutting off Archer Lane will merely displace traffic onto the already extremely busy Abbeydale Road, and also cuts us off from Nether Edge which I have always viewed as our social hinterland here in Carter Knowle. I can understand and support some of the measures: making the roads down from Brincliffe Edge one-way makes sense, for example. Why not alternate one way traffic on Nether Edge Road, Oakhill, and Edgehill? This would alleviate traffic on these narrow streets and calm things considerably.

In particular, I strenuously object to the underlying logic of the proposals, which is to close traffic in a small number of selected (leafy) parts of Nether Edge, thus displacing huge amounts of traffic onto already cramped and less well-off streets: Glen Road, Sheldon Road, Machon Bank. All of the traffic which currently comes down NE Road and Union Road will be displaced onto these small roads, and it is clear to see that there will be seriously increased traffic problems particularly at rush hours there. What measures are being taken in anticipation of these problems? For example, are there going to be modifications to the traffic lights at Nether Edge crossroads, to allow filter lights for those turning right onto Moncrieffe Road from Sheldon Road? Otherwise traffic will be unable to flow smoothly. The residents of those streets will have to contend with a constant line of back-up traffic, idling engines and all the fumes arising. Similarly, at the end of Brincliffe Edge turning right onto Ecclesall Road, will there be filter lights installed there? There is very heavy traffic passing there most of the time, and it will be dangerous for cars to try to edge out without proper traffic calming measures. Without these easily foreseeable issues being addressed in advance of the implementation of the proposals, the scheme will not only fail but cause

				significant hardship and even danger to both drivers and residents. In sum, this is a half-baked set of proposals, which will have a significant detrimental and possibly dangerous effect on traffic in the area, clogging already busy streets, and making life even more difficult for residents particularly those with mobility issues. It is not accompanied, as far as I know, by the essential traffic flow modifications on the roads where you are proposing to displace large numbers of traffic. Lastly, there has not been sufficient consultation or notification of the wider community affected by these proposals. My heart sank when I saw the plans, and I am sure I am not the only one. I always read every missive from Sheffield City Council so it is not a case of me missing this. Neither do I accept that many others who are saying the same thing, is simply a coincidence. The councillor agreed that most people he had spoken to in the area had not received notification of the scheme, had not received consultation document last year and had not received a postcard through the door c 2 weeks ago to make people aware of the changes. Words fail me in describing the imbecility of the proposed scheme of road closure and redirection. I live on Nether Edge Road. With the scheme now to be introduced, I will have to access my home via Brincliffe Edge from Psalter Lane when returning from the city centre to enable me to go down a road I can until Monday 25/4/22 access easily from the crossroad at the bottom of the road. This will mean increased journey time, fuel use at a time of rising fuel prices, congestion on the roads which are remaining accessible and increased emissions at a time when we should be looking to achieve reduced emissions.

Unlike others, I do not have the luxury of being able to cycle to work due to a level of disability and it would be unsuitable in any event even if I could due to the nature of my work, my age, and what I am required to carry. Cycling is great if it is a suitable method of transport for the individual but for many people it is simply not an option.

If I now want to go to Sainsburys for instance on Archer Road, I have increased journey time and distance having the divert to Abbeydale Road which is already heavily congested with slow moving traffic (emissions and fuel usage again) in order to travel there due to the closure of Archer Lane. The traffic which used Union Road in the mornings will now divert to Nether Edge Road, increasing morning commuter traffic down Nether Edge Road and across Brincliffe Edge road overall which is already a narrow road and should not now become the main commuter route which it will do.

I could go on. I really fail to understand how these very obvious flaws have not been recognised by people who I assume are supposed to have some expertise in planning. Logistically the scheme is ridiculous. It might look fine on paper to people who do not actually use the roads or live in the area, but there is no account taken of the householders and business owners who do.

As much as it might be desirable, without a corresponding change in the public transport system and a whole lot of other measures, Sheffield and other cities will not achieve car free status and to force this scheme through in the hope that will be artificially achieved is nonsensical. You are not going to suddenly see people abandon their vehicles to get on a bike. All you are actually doing is introducing an unnecessary degree of inconvenience for reasons best known to those who dreamt up the scheme, expense by increased fuel use, and increased fuel emissions. An example of pipedream over reality, paper planning rather than planning for humans. I do hope that I am going to see a decrease in my Council Tax to reflect this.

The whole scheme is flawed and I want to be notified of all consultation processes going forwards so I can involve myself and I would also like an explanation about how the consultation scheme was operated given the councillor said that the people he had spoken to on this road were unaware of the process they had not received any information, which suggests it was flawed.

Yes 2 ventures is one small company that escorts with support vulnerable adults to their vital day services. This service also enables unemployed people back into employment.

The additional cost of fuel additional journey time and unhappy customers makes people consider if this is still a satisfying job.

The vulnerable adults with learning disabilities have to endure longer journeys on congested roads where traffic has been disbursed to. Leading to one gentleman being incontinent in the car on the extended journey.

Older adults wait hours for carer to arrive to help them with getting out of bed, they quite possibly have been in bed over 14 hours risking pressure sores and hospital admissions.

Again the customer is not happy and its the low paid care worker that takes the negative comments not the traffic planners.

Again care workers are leaving to work in better working conditions.

This is a serious matter that I believe is not being taken seriously.

To add another issue. I have walked along Archer lane at 9pm and felt vulnerable as it was dark, there was no traffic and there are woods at both sides, no houses.

I used to walk on the that road no problem but now I wont walk on there when it is dark as I fear being attacked and pulled into the woods, out of sight of anyone and out of ear shot.
